Each team shall designate a single person to serve as the team representative for disputed ruling(s)**:

- The designated person is the ONLY individual who may dispute an official's ruling.
- The designated team representative must check in with the meet referee prior to the start of the meet.
- Please note, a parent or guardian may not dispute a ruling of an official on behalf of their child. If the Team Representative's child is the subject of the contestation, the challenge shall be brought by a member of that teams Governing Board.
- The Meet Referee's decision is final.
- ***Disputes regarding the Meet Referee's children will be settled by committee in accordance with MVSL by-laws.

Team Entries are due electronically to ROST Meet Director by 8:00pm on Thursday, June 12, 2025. Submit entry files to jlebel1854@gmail.com.

- Seeded event files shall be transmitted on Friday, June 13, 2024.
- Any special needs or accommodation requests for athletes must accompany the entry file by the Thursday deadline.

Event Rules

Mid-Valley Swim League Bylaw rules shall apply.

- Eligible swimmers may elect up to three (3) individual events and two (2) relay events.
- In order to maximize lane usage, events may be combined. These events will be noted on the meet program or communicated prior to the start of event #1.
- Flyovers will be employed for all block-end start events (excluding Backstroke).

Scratches are due to the Meet Director by 7:45am; relay changes are due prior to Event #1. We know stuff happens, just please inform us to the best of your ability. A scratch/change form is attached for your use.

Job Volunteers

We are running 2 shifts only.

First Shift Jobs report at 7:50 to begin the 8:00 shift; TIMERS need to be in their seats at 7:45 to start the meet on-time.

Second Shift Jobs report at 10:55am to start the 11:00am/final shift

Starters and Stroke/Turn Judges need to be trained/qualified for the events chosen.

General Information

For team area and deck access, please refer to the following images. No BBQ's, RV's, fire pits, propane/gas, flame of any kind, pets, alcohol or tent stakes allowed.


Photography is strictly prohibited in the starting area. Photography should be taken from the bleachers or side pool observation areas only. Violators will be removed from the deck.

Deck access for parents and volunteers is through the 'tennis court' gate or the aquatics building, and not the gate on the baseball field side of the pool (swimmers/lifeguards/Board Staff only).

Only swimmers, coaches, job volunteers, and ROST board members are allowed in the operational areas marked in red on the deck site plan. If you require assistance or have issues at the meet, please contact Joe Le Bel, Meet Director, any ROST Board member, or a member of your team's Board.

There will be food vendors on-site that accept multiple forms of payment. There are also many food options available within a 5-minute walk from the pool on Oak Street towards downtown.

Reserved Parking for (2) visiting coaches' vehicles and lunch will be provided for (2) coaches of the visiting team.




