# Officer's report

#### A) <u>Secretary (Mike Burgenger)</u>:

- League Reps signed in for attendance. Determined we had a quorum for the May Meeting with 22 of 26 teams present.
- Moved to approve April 2016 League Meeting Minutes. Approved unanimously.
- Reminded League Reps and Computer Operators to send results/scores from dual conference meets to Mike at swimncsl@gmail.com or secretary@norcalswimleague.com.

#### B) President (Steffi Jones):

- Steffi Jones appointed to USA Swimming's Safe Sport Council. Attended the council's first conference call. This is a first year program. More information at <a href="http://www.usaswimming.org/">http://www.usaswimming.org/</a>
- Held Meet Official/Referee Training on 5/21/2016. Attended by only 4 teams-RW,
   EG, WSW, and WS. May plan a official/referee training for all teams next year.
- 2 teams (FOD and CB) with ineligible swimmers participating in meets over the first
  two weekends. This is a bylaw violation and a liability problem that must be fixed.
  The FOD violation involved swimmers registering within 24 hours of a meet after the
  eligibility rosters went out. The CB violation involved swimmers NOT registering with
  the league and participating in a meet with FTST.
- All teams paid their league dues for 2016.
- Several teams need to pick up ribbons ASAP.
- C) Vice President (Emily Phillips): No Report
- D) VP of Champs (Travis Bill):
  - Needs key volunteer contacts for Mother Lode and Eureka Conferences
- E) Treasurer (Jeff Grubbs): No Report
- F) Registrar (Monica Lopez)
  - Per NCSL Bylaws, league registration closes on June 15<sup>th</sup>, but ALL swimmers MUST register with the league before swimming in any meet between two or more NCSL teams. Registration must be complete at least 24 hours prior to the meet.

MAKE SURE swimmers in the meet are on the eligibility roster. Swimmers not registered with the league will be removed from all results in accordance with NCSL bylaws. Failure to adhere to registration requirements specified in NCSL bylaws may result in punitive action against the team.</li> <li>G) Commissioner of Records/computers (Teresa Folsom):         <ul> <li>5 Records broken in May (4 –Relays and 1-Individual)</li> <li>Proposed to amend bylaws with a paperless process for updating records. Existing process requires mailing records to the Commissioner of Records. BOARD VOTED UNANIMOUSLY to temporarily use the paperless process outlined in the bylaw amendment proposal included with the minutes. Official board vote to follow in June.</li> </ul> </li> </ul>
