Officer's report

A) <u>Secretary (Mike Burgenger)</u>:

- League Reps signed in for attendance. Determined we had a quorum for the June
 Meeting with 22 of 26 teams present.
- Moved to approve May 2016 League Meeting Minutes. Approved unanimously.
- Reminded League Reps and Computer Operators to send results/scores from dual conference meets to Mike at swimncsl@gmail.com.
- Will update bylaws for latest record update process change
- B) President (Steffi Jones):
 - 129 fewer swimmers than 2015
 - 2 parents requested late registration after 6/15/2016, which bylaws did not allow
 - 214 swimmers registered after 6/1/2016 with fairly even distribution across ages.
 - Will try to differentiate the "Sign In" versus "Register Here" errors with registration for the 2017 swim year.
- C) <u>Vice President (Emily Phillips):</u> No Report
- D) VP of Champs (Travis Bill):
 - Expressed concern about conferences being prepared to receive chairs, tables, security personnel instructions, and other deliverables the day before champs.
- E) <u>Treasurer (Jeff Grubbs):</u> Financials included with meeting packet. No payments for Champs yet.

- G) Commissoner of Records (Teresa Folsom: No Report

Old Championship Event Order Change Request: The Rocklin Wave proposed to move **Business** the medley relays to Sunday and freestyle relays to Saturday of Championships. BOARD VOTED AGAINST THE CHANGE. 6 Teams voted FOR the change while 16 voted AGAINST the change. RESULT: Freestyle Relay stays on Sunday and Medley Relay stays on Saturday. B) Unregistered Swimmer at Meets: Laguna Creek v. Fulton ElCamino: Both teams had unregistered swimmers participate. Board emphasized there is NO provision for "exhibition swimmers" at NCSL meets. If swimmers are not registered with NCSL, they DO NOT participate in meets between NCSL teams. Both teams acknowledged mistakes, corrected scores, and pledged to prevent the issue going forward. Issue Considered Resolved. Carmichael v. Folsom: Carmichael swam multiple unregistered swimmers at the meet that were not registered with the league AND/OR registered within 24 hours of the meet. Bylaws require registration a minimum of 24 hours prior to participating in a dual meet. Issue caused confusion for parents and a lengthy delay for the meet with Folsom. Carmichael team president did not exhibit any intention to resolve the unregistered swimmer situation and directed parents to the league for resolution. NCSL voted to establish a disciplinary committee to review Carmichael's standing with NCSL and possible sanctions under the league bylaws. **Disciplinary Board includes:** i.
