 - <u>Bylaw:</u> Exhibit B Northern California Swim League Championship Meet Rules, VII. Failure to Swim a Final Event After Qualifying: Any swimmer who qualifies for the Finals in an event and who fails to swim in the final event without the permission of the Meet Referee shall be barred from competing in any other events during the championship meet, and the next qualified swimmer will take the barred swimmer's place.
 - Proposed Change: this rule should have an exception in that if a swimmer misses an individual Finals race, that swimmer should still be allowed to swim in a relay during that same Finals session. They will continue to be barred from all other subsequent individual events and relays in the following session

• The meeting was called to order by Jennifer Isaacs Breaux at 6:35pm. Annie Fischer made a motion to approve the minutes as presented. Michael Wright seconded the motion. There was no discussion. The motion passed.

Treasurer's Report (Annie Fischer) • Checking Balance- \$ 35090.50

- Savings Balance- \$ 25503.64

- "Try It" Clinic is on 4/22/23
 - This is canceled as only 1 child signed up and she ended up joining the team anyway
- Practice starts 4/24/23
- Nicole spoke with Emma (synchro coach) about the underwater speaker and it is ok it just needs new fuses which can be purchased on Amazon for \$5 (for a 1000 pack). Nicole will order the fuses.

Combined Swim/Synchro

- Overall website and registrar update
 - o 170 swimmers have turned in their paperwork and 183 have signed up. Kristin estimates about 10 more swimmers need to turn in paperwork. Families can turn in paperwork to Kristin at Cottage Pool or the District Office which is open M-F 10am-4pm. Kristin is letting families know when she is available at the pool.
 - Sarah has been making frequent Social Media posts emphasizing swim families to check their emails for instructions and upcoming dates that have been sent out.

District Report (Ryan Harder)

- Last Tuesday, 04/11/2023, the pool was down to about ¼ full. It was discovered that a back flow valve didn't get closed all the way and the water went into the drain. The maintenance staff at the Cottage Pool location has been changed and no further issues are expected.
 - The heater and chlorinator kept up and seem to be operating fine.
- The bathrooms both need to be painted so the Boosters suggested this task be added volunteer hours. We will host a "Team Workday" and send it out once Ryan checks the dates and lets us know when no one will be at the pool and no bathroom access is needed.

Swim Team

- Personalized caps are in and will be distributed closer to time trials
- Suits are currently in production 27 female suits and 32 male suits were ordered
- For next year, boosters need to choose a new 2 year suit should we go personalized or off-the-shelf? Solid navy with an embroidered logo?
 - o Tavia likes the personalized (custom) suits most boosters agreed. But the production time is ~8 weeks which makes it difficult to receive the suits in time.
 - o Solid navy suits with embroidery was also discussed which some Boosters did like
 - o Boosters to maybe do an end-of-season poll/survey for the swimmers/parents
 - o Jason will also need to give his opinion so it can be considered before a decision is made
 - o Will table this topic for next meeting
- New Supplies for Team Parents
 - o New supplies are needed for all of the team parent baskets/supplies
 - o Janeen and Kimberly will draft a list of needed supplies and poll returning team parents from last year to see what they recommend for the supplies.
 - o Fanny packs were favored over half aprons so they will ask everyone's preference too. Gail has a vendor for embroidery for the fanny packs or aprons whatever is decided.

Verizon WiFi Cube

o Michael suggested we purchase a WiFi cube that we can pre-load with data needed for snack bar and meet computer internet needs. Jon's setup for the meet computers does not work with a wifi cube since he connects from a phone -> a router -> computer ethernet ports, So Michael will purchase and use for snack bar. Price depends on how much data we need but should range from \$100-200.

- Jon mentioned 2 computers are getting old and both have dead batteries so it was decided to purchase 1 new computer and 1 new battery. The 2nd old computer will be replaced in the future.
- Mike van den Enden also brought up the bylaw changes that will be voted on at the NorCal meeting at the end of the month.
 - o #1 Bylaw Change requiring booster recommendation:
 - Exhibit A Northern California Swim League Dual Meet Rules
 - III. Entries
 - B. Except as otherwise provided in Section III.C. below, each Team may enter up to three official (scoring) entries per race in both individual and relay events.
 - C. Five-lane Pools:
 - 1. If a dual meet is held in a five-lane pool, there shall be a maximum of only two score entries per Team for each individual and relay event.
 - 2. In a five-lane pool, competing Teams may, by prior agreement, enter three entries on an alternating basis in each individual and relay event. The third entry shall compete on a non-scoring basis and shall compete in lane 1.
 - Recommended Change to Be Voted on By the League:
 - We recommend changing language in Exhibit A, III. Entries, B & C to be replaced with the below.
 - "B. Except as otherwise provided in Section III.C. below, each team may enter official (scoring) entries equal to half the number of competition lanes per race in both individual and relay events. These swimmers will be seeded in the first heat.
 - C. Five-lane Pools: If a dual meet is held in a five-lane pool, there shall be a maximum of 5 official (scoring) entries per team in both individual and relay events. These entries will be seeded in the first two heats."

Booster's recommended a "yes" vote

- o #2 Bylaw requiring booster recommendation:
 - o Discipline of Swimmers who miss a Finals race at Championships.
 - o The Current Bylaw:
 - Exhibit B Northern California Swim League Championship Meet Rules

 - Any swimmer who qualifies for the Finals in an event and who fails to swim in the final event without the permission of the Meet Referee shall be barred from competing in any other events during the championship meet, and the next qualified swimmer will take the barred swimmer's place.
 - Recommended Change to Be Voted on By the League:
 - We suggest the league strike this bylaw in its entirety.

District Report (Ryan Harder)

• The meeting was called to order by Kristin Isaacson at 06:32 pm. Jennifer Breaux made a motion to approve the minutes. Mike van den Enden seconded the motion. The motion passed.

Treasurer's Report (Annie Fischer)

- Checking Balance-\$42763.36 (\$109 coming out and Quick Quack check [2863.21] needs to be deposited)
- Savings Balance- \$25,519.68
- Due to the high balance we need to come up with ways to spend money. Suggestions for spending money:

- Raise deposit for volunteer shifts and/or number of volunteer shifts
 - The boosters are in favor of doing both. It was proposed to raise the deposit to \$350 and increase the number of shifts to 9 regular season shifts and keep it at 2 champs shifts.
 - We will discuss next meeting and take an official vote with the new members.

- Costumes for champs are old so synchro suggested replacing them. Synchro was reminded that they have \$300 budgeted for costumes every year. Erica will bring a list of exact needs for boosters to approve if it is over the allotted \$300.
- Underwater speaker is new(ish) so it does not need to be replaced. However, it may need to be sent back to the manufacturer if it is not working properly. Ryan says it is possible the wrong fuses are being used which would cause the fuse to blow frequently.
- Erica also brought up the issue of the synchro league champs setup. When FEC, or any small team, is competing against larger teams in champs it makes it difficult for novice levels to be promoted to the intermediate level since making it to finals is statistically more difficult for the smaller teams. So it makes it really hard for the smaller synchro teams to have any intermediate level swimmers. She was bringing this up so that it could be brought to the league to potentially think about how these rules can be updated, if at all.


