- Parking The process is stated and being taken care of.
- Slack Administration Jon will take off the obvious people. He will email Ryan if there are people in question.
- Equipment Purchases for 2019 There is money budgeted. We need to decide if we need everything that is being requested or if we want to pick and choose. We need to decide if we want to purchase these things as the other teams are not in our conference any more. When looking at the budget, there is \$1000 in operating expenses. Swim has a \$2000 equipment budget. If we are not buying ribbons this year, we can move the ribbon money and we will have enough money. Cory Stowell moves to move the \$800 from ribbons to equipment. Kristin Elser seconded the motion. There was no discussion. The motion passed.
