Annual Dues

The annual dues for the 2023 season will be **\$990** and must be paid by **Monday May 1, 2023**. This is slightly more than last year partially because the minimum wage has gone up but also because inflation has increased the cost of our supplies. More importantly, we are moving to a year-round operational model where all members can utilize the facility every month of the year, with no additional fee for winter lap swimming. More details will be provided at the AGM. The Annual Letter will contain detailed instructions of how to pay the annual dues via credit card on the FPCC website, which is preferred over cash or check.

Lifeguards and Swim Instructors are needed for the 2023 season. A qualified lifeguard must be at least 15 years old with current Red Cross Lifeguard, CPR and First Aid certifications. Swim Instructors must be at least 15 years old with current CPR and First Aid certifications. Training for swim instructors will be provided by FPCC. The board typically gives preference to qualified job applicants within the membership community. Job applications are currently being accepted for the 2023 season, apply by filling out the on-line application under the <u>Jobs</u> tab on the FPCC website. Interviews will begin in March.
