# Cross Plains Stingrays Swim Team - Discipline Code and Procedure

- First infraction -The swimmers parents will be notified with a written or verbal notice of the infraction. The swimmer
  will be removed from the pool, whether it is practice or a meet for the remainder of the day. If occurrence at a meet,
  swimmer will be scratched from all scheduled events after infraction.
- Second infraction The swimmers parents will be notified with a written or verbal notice of infraction. The swimmer
  will be suspended for one meet. (Note if the second misconduct occurs after the final dual meet and before the
  conference meet, the conference meet will be the meet that the swimmer will be suspended for.)
- Third infraction The swimmers parents will be notified with a written or verbal notice of infraction. The swimmer will be suspended for the balance of the season regardless of the date of the third infraction.

## NO REFUNDS WILL BE GIVEN TO FAMILIES WHOSE SWIMMER IS SUSPENDED.

The Cross Plains Stingrays Swim Team has adopted a code of conduct and discipline procedure to provide a fun and safe place for all swimmers, coaches, pool staff, and families.
