The government is requiring that all NPOs have audited financial statements.

The government assistance in the amount of KYD\$ 150,000 is greatly appreciated.

The expense increase is due to the financial year being a full year rather than the 9 month from when the year end was changed.

The meeting was asked to approve these financials as presented.

Aquatic Centre

Stephen Broadbelt updated the meeting on the status of the plans for the 50m Aquatic Centre and other CIASA updates with the following points to note.

- The 50m Aquatic Centre will be community orientated. (Pool, community wellness).
- The pool will be 3 m deep; 10 lanes, design is same 50m/25m. All four disciplines can be accommodated.
- The pool will have a ramp on 25m for easy access by wheelchair.
- The pool design will have Climate control.
- All equipment will be hurricane rated equipment.
- Cayman Sports Leisure Hotel will be made up of two levels multistorey parking and two floors accommodation. It is designed to hold 300 persons with 2 or 4 per room with bunks. The façade of the hotel will resemble the shape and look of wind, making it not only practical but attractive as well.
- The hotel will have a solar panel on the roof.
- Stephen informed the meeting that we have had one offer to fund the project through pension funds. The achievable goal of 56% occupancy of the hotel is what would be needed to make the funding a realistic option. This, we believe, is achievable. Government is guaranteeing the project as a bond.
- CIASA's vision is to give essential access to a life skill.

- Mr Broadbelt went through the CIASA Vision and Strategy. We were at 46% last year and this year we have improved to 56%.
- CIASA is no longer using the power points system. We are transitioning to the FINA points system.
- CIASA has applied to FINA and PanAm Aquatics to host an international Open Water event.
- CIASA is committed to developing the other sports: Artistic, Water Polo, Open Water. CIASA is also committed to developing the Learn to Swim program. Jacky the TD will be working with the SISC to host clinics and to do time trials. The pool at the Brac is up and running and we plan to host a swim meet there in the near future.
- We now two RTC committees; one RTC committee dedicated to Artistic and one RTC committee dedicated to Pool and OW. The Chairman of the RTC committee (Also a Board Director) will oversee both committees.
- TD Jacky will attend all CIASA sub committee and committee meetings.
- CIASA is working with SwimCloud platform, it is a website with statistics. Meet files will be uploaded to this SwimCloud platform.
- 10th Nationals and OW event championships: TD will keep the same format with the Super Finals. Livestreaming was available and it will be offered again.
- Chiller was installed at Lions Pool; not working as well as it could. Lions pool no longer has touchpads. It is using the Dolphin timing system. Clifton Hunter and Brac Pool are fully operational.
- CIASA will be hiring a Federation coordinator. We expect to have that position filled at the end of the year or first quarter of 2023. Currently Jacky, TD, is our only CIASA employee and we need a Federation coordinator to assist with some of the administrative tasks.
- Insurance: Liability insurance stays the same. The policy does not cover us in the USA. Covers the clubs, sea swims, and domestic. If your athlete is competing or training in the USA, each family will have to arrange insurance and sign up with USA swimming.

Adrian Neblett, representing the Lions club of Grand Cayman, thanked Stephen for the presentation and in addition thanked everyone who have been a part of the work behind the

Aquatic Centre. Mr Neblett reassured the meeting that the Lions Club are in support of this project.
