

Rose Bowl Aquatics Center - Swim Team
2023-2024 Fees and Payment Policies

As a member of the Rose Bowl Aquatics Swim Team, you agree to pay the following fees and charges associated with the program.

PAID TO RBAC FRONT DESK:

1. **Rose Bowl Aquatics Center Monthly Training Fee** – This fee varies according to the swimmer’s practice group (see Monthly Training Fee Schedule A below). As these fees must be paid directly to the Aquatic Center front desk by the 1st of each month, we encourage families to sign up for autopay to ensure a payment is not missed. Swimmers will not be allowed to swim at the Rose Bowl if these fees are not current.

*Partial need-based scholarships are available from RBAC (please go to the front desk for an application or email scholarships@rosebowlaquatics.org). To receive a need-based scholarship you must reapply each quarter. The application is due on the 15th of the month prior to the start of the quarter; it is due on September 15th, December 15th, March 15th and June 15th.

1. **Annual Swim Team Registration Fee - \$100.00.** This fee must be paid at the time of online team registration. Registration occurs once a swim-year on September 1st, or when you join the team.
2. **USA Swimming (USAS) Registration Fee** - This annual fee of **\$86.00** is determined by USAS and covers a January through December calendar year. For returning swimmers, the registration for the following year must be paid at the time of registration with the team in September. New swimmers must pay the fee when they register online, at the time they join the team. The payment

covers the period from the time of registration through December 2024. No swimmer may train at the Rose Bowl unless they are registered with USA Swimming.

3. **Rose Bowl Swim Team Annual Family Commitment Fee** – This fee is assessed by family and depends on the practice group of the most advanced swimmer in your family. Half the annual fee is invoiced on October 1st (short course season), the second half is invoiced on March 1st (long-course season). (see Schedule B: Annual Family Commitment Fees). For those that join the team after October 1st and/or March 1st, Family Commitment fees will be prorated and collected at the time of registration.

Swim Meet Entry Fees (paid through your Team Unify account) – The Head Coach determines all home and away swim meets in which the team participates. Swimmers sign up online to compete in meets, and entry fees are invoiced to your Booster Club (Team Unify) account. These fees vary and are based on the duration and level of the meet as well as the number of events entered to swim. If you sign up for a meet online and your plans change after the meet entry deadline, you will still be charged for the meet as the Booster Club pays in advance for the events you have signed up to swim. Changes before the Meet Entry deadline will be honored without charge.

4. **Team Support Hours Requirement**-- Please see the Booster Club's *Team Support Policies* for details.

Team Unify (Swim Team) Payments

1. Team Unify has been updated and autopay will be setup automatically during the registration process. If necessary, the card you entered during registration can be updated, deleted or changed at any time during the year. Payments will be run on the 1st of every month.
2. If for some reason the autopay transaction does not go through on the first of the month (expired card, insufficient funds, etc.) you will receive an email from the system letting you know. You are then responsible for logging onto Team Unify and making the payment manually. A late fee of

\$30 will be assessed to your booster account if you have an unpaid balance on the 20th of the month.

3. All Booster Club accounts must remain current. Swimmers will be suspended from practice and meet participation if their family's account is over thirty (30) days past due. If, on the 15th of any month, an account still reflects the previous month's unpaid balance in addition to the current month's new balance, the account will be put on suspension and the family's swimmers will not be allowed to participate in swim practices or meets until the account balance is made current. 4. Your Team Unify account will remain active until the end of the swim season, August 31, 2024. Only the swimmer will be deactivated on your Team Unify account if he/she leaves the swim team.
5. If you do not pay your Team Unify balance in full when the swimmer is deactivated, your account will continue to incur a late fee of \$30.00 each month it remains unpaid.
6. Each family will be responsible for completing their Team Support Hours, based on the swimmers' practice group. If families do not complete their support hours obligation, hours will be converted to a \$25.00 an hour unfulfilled team support fee to be billed on your August 1, 2024 Team Unify invoice.
