General Chair report

I am still looking forward for the Administrative Review Board. As explained in the November meeting, we have not had an Admin review board since last elected in 2020 (expired 2022). Obviously we have not had any issues that have needed to be addressed. And issues for this board are very rare. Basically the review board is there to address issues or grievances that someone within the LSC has that would go past a grievance with their team, does not rise to the level to have USA swimming deal with it, and is not quickly addressable by the board (or could involve the board). Since this is a 2 year election cycle I need to appoint people to be on this review board until the November 2026 election. The review board members cannot be on the current board of directors (but can be on committees). This board is to consist of 5 members of which must be at least 20% athletes. I had asked for interested parties last meeting, and do not yet have any names. Please speak up tonight if you're interested, or send me an e-mail.

Sectionals, moving forward will include 50's of stroke.

Is there interest in having meetings on a day other than Sunday's? After I was elected two years ago, we decided to continue with Sunday meetings, but I have been asked by a board member to revisit this. I will accept a motion for an alternative so we can open a discussion on the topic.

There have been people who have asked to consider financial compensation for officials (see old business), as well as possible reconsideration for amounts for zone coaches, as well as possible compensation for all-star meet coaches. I believe the best route is to refer this to the governance committee and have them report back with recommendations.

Other ideas/suggestions that have come across my plate since November:

For LSC hosted meets, task one team with managing hospitality. Give them a budget dependent on number of days and ask them to figure out hospitality (with guidelines / standards).

Rising star meets: Besides caps, come up with additional goodies or money to host for goodies to enhance them even more. AND have a 20-30 minute pre-meet education for newer parents - Similar to a program Mary had done in the past, or similar to the parent education that used to occur at the Don Watkins meet. (Perhaps this will aid in recruiting officials as well).

Finally, I received a concern regarding LSC hosted meets – voicing that according to our P&P, meet directors of meets larger than 500 athletes are not supposed to have additional jobs. We, as an LSC need to find positive ways to get people to step up and help, so admin and officials at LSC meets are not overwhelmed.
