

Facility:

The aquatics facility at the AAYMCA is an indoor climate controlled facility consisting of an eight (8) lane 25 yard competition pool and an adjacent therapy pool. The water depth of the competition course is nine (9) feet measured from one (1) meter to five (5) meters at the starting end of the course and four (4) feet measured from one (1) meter to five (5) meters at the turn end of the course.

The competition pool has bottom striping, wall targets, and competition starting blocks. The therapy pool is 15y long and will be available for warm-up and warm-down throughout the meet. The therapy pool depth is five feet. There is no diving allowed in the therapy pool. The facility has girls and boys locker rooms for all swimmers as well as separate locker rooms for adults. Additional restrooms are available for spectators outside the pool deck. Our facility is handicap accessible and has two special needs locker rooms.

The competition course has not been certified in accordance with 104.2.2C(4).

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Rules:	Meet to be conducted in accordance with the current USA Swimming, SC Swimming Rules and Regulations and information herein. This is a closed meet limited to any CYSL League Team. This meet will be conducted in accordance with CYSL By-Laws.		
	Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.		
	Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.		
	Deck changing is prohibited by USA Swimming and South Carolina Swimming. A first offense will result in the disqualification of the offending swimmer from the next scheduled event. The second offense for the same swimmer will result in the disqualification from the remainder of the meet.		
	SWIMWEAR: No Technical Suit may be worn by any 12 & under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet (USA Swimming Rule 102.81.1.F)		
	MAAPP 2.0: All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.		
Athlete Eligibility:	This competition is open to any YMCA swimmer. Swimmers age for the meet will be the age of the swimmer on May 10,2025. Any swimmer entered in the meet using the racing blocks must be proficient in performing a racing start dive or must start each race from the deck or within the water. It is the responsibility of the swimmer or swimmer's legal guardian to ensure compliance with this requirement. If a swimmer is unable to pull themselves out of the water, they must use the ladders located at lanes 1 or 8.		
Entry Fees:	Swimmers may swim four individual events and two relays. There will be no Time Trials offered at this meet.		
	The entry fee is \$15 per swimmer.		
	Clubs should submit a single check payable to the Anderson Area YMCA Swim Team for the full amount due. It is not necessary to mail entry fees; however, all fees must be paid prior to any swimmer from that team entering the pool.		
Meet Format:	All events will be contested as timed finals. - Meet management reserves the right to adjust numbers of heats, lanes, entry limits, and warm-up times based on the number of entries. We reserve the right to combine events to better control the flow of the meet. We will only swim the events listed in the meet information.		
	Age groups for the meet will be 6 & Under, 7-8, 9-10, 11-12, 13-14, 15-18, 19-21. Clerk of course will not line up athletes.		
	 If a swimmer misses their assigned heat, every effort will be made to get the swimmer into an open lane in a subsequent heat. No new heats will be created to accommodate these athletes. 		
	 No refunds will be given The 500 Free and 400IM will be positive check-in events. All other events will be pre-seeded. Positive check-in will close 30 minutes prior to the start of the session.

	Teams are responsible for the delivery of entries on time. Meet Director is NOT RESPONSIBLE for chasing down entries.		
	Late entries and deck entries will be accepted at the discretion of the meet director and at an additional fee of \$1.00/event in addition to the \$15.00/swimmer fee.		
Awards:	Ribbons will be awarded for the 1 st through 8 th places in individual events and relays.		
Scoring:	The meet will be scored overall as follows: Individual: 9-7-6-5-4-3-2-1 Relay: 18-14-12-10-8-6-4-2 *6 & unders are NOT eligible to swim any Open Event		
Timing:	Colorado Timing System and data processing will be used. We have an 8 Lane LED Scoreboard displaying swimmers times to the 1/100 th of a second. Event and Heat will be on display throughout the meet.		
Coaches Eligibility:	All coaches must be a current coach member in good standing with the YMCA of the USA. Coaches must present their credentials to receive their coaching packet and must have their credentials visible at all times. There will be a coaches meeting 15 minutes prior to the start of the sessions. Each team should have at least one representative coach present.		

Other Information:

- SPECIAL INSTRUCTIONS:
- Age as of May 10, 2025 will be used as the competition age per CYSL Swimming Rules.
- 12 & under Relays will be swum in the Afternoon Session only
- Due to deck capacity limitations, there will be no spectator seating in the facility. Spectators are encouraged to tailgate or camp in the Parking Lot or grassy area behind the building. There will be a very limited, standing room only spectator viewing area behind the blocks. Spectators may enter one door from the Water Works area to view a race but must exit another door immediately following the heat. Parents may stand outside in the Water Works area but must wear a mask while inside the gates. No camping or seating will be allowed inside the gates. We ask that spectators be respectful of all who want to view their athletes competing. Children must be supervised at all times. Horseplay will not be tolerated.
- No photography of any kind is allowed behind the blocks. This will be strictly enforced.
- 500 Free and 400IM will be positive check-in events. Positive check-in closes 30 minutes prior to the start of the session.
- Any swimmer participating in the 500 Free or the 400 IM must provide their own timer and counter.
- All Afternoon Relays are Mixed Relays and will be odd numbered events
- Mixed Relays All mixed relays must consist of 2 male and 2 female athletes.
- Athletes will have designated team areas in the bleachers on deck. We ask that no chairs be brought onto the deck.
- Athlete only locker rooms will be clearly marked with access to the hallway and the pool deck. These locker rooms are for 17 and under athletes only. Athletes who are 18 or older should use the adult locker rooms. Locker rooms should only be used for athlete restrooms and not for changing. There are restrooms located in the hallway next to Back Door entrance for Spectators. Two special needs restrooms are designated for Coach/Official and Volunteer use only.
- <u>Electronic Heat Sheets</u> will be made available for parents ahead of the meet and are also available on Meet Mobile. Heat sheets will not be printed at the meet. All meet files can be found on our website.
- Results will be posted on the wall outside in Water Works patio area and made available on Meet Mobile. Results on Meet Mobile are unofficial.
- <u>Concessions</u> will be made available outside in the Water Works area.
- Hard copies of the heat sheet will be provided to coaches at the meet.
- We ask that teams be mindful of their team areas on the pool deck and help to police these areas for trash and mess. Vandalism of any kind will be cause for immediate ejection from the facility and cost of repairs to be charged to the visiting team.
- We welcome certified officials willing to work (please report to hospitality room at the start of warm-ups for each session)
- Warm-up procedures: All coaches should be familiar with the warmup procedures
 explained on the warmup assignment page on CYSL website. Team lane assignments will
 be sent out with any updated information prior to start of the meet. All CYSL safety
 swimming guidelines will be enforced.
