2021-2022 Registration Information

Welcome to the *Clemson Aquatic Team (CAT)* electronic registration for the 2021-2022 swim season! Founded in 1978, **CAT** is a year-round, parent owned swim team. There are training groups for novice competitive swimmers, groups for swimmers with varying degrees of competitive swimming experience, and a US Masters Swimming training group for adults (fitness, triathletes, or competitive adult swimmers). The team currently practices from September - July at Central Clemson Recreation Center (CCRC).

Both returning swimmers and new swimmers must register through the online registration portal. Please follow the instructions to register for the swim season.

Minimum Swimming Requirements: Your athlete must be able to swim at least 50 yards freestyle, 25 yards of one other stroke, and be comfortable in the water. If your child was a member of CAT last year, there is no need for a swimmer evaluation. Before the first practice, all new swimmers must provide a birth certificate (email to cat@clemsonaquaticteam.org).

New Swimmer Evaluation: We will hold evaluations on Aug 31, 2021 and Sept 2, 2021 between 5 pm and 7 pm (potential members must be evaluated at only one day) at the Central Clemson Recreation Center Pool. It is drop-in and the evaluations are first-come first serve, and take about 15 minutes in the water. Please have the child in a swim suit, with googles if you have them, and a towel.

After Sept 2, 2021, please contact Head Coach Jon Mengering at cat@clemsonaquaticteam.org to schedule new swimmer evaluation.

NEW SWIMMERS: DO NOT REGISTER UNTIL YOUR CHILD HAS BEEN EVALUATED.

New Swimmer Two Week Trial: If you or your child are wondering if swimming is for you and your family, we offer a 2-week trial with registration. You must complete the entire registration process. <u>Choose to pay with a check and bring the check to the pool</u>. We will hold the check until you make your decision. If you decide not to continue after 2 weeks, your check will be destroyed or returned without being deposited. Note: This does not mean your swim fees are prorated for the two weeks if you join.

We look forward to having you join the *Clemson Aquatic Team* and are excited for a great swim season!

Note: USA-S or USMS registered athletes from other teams who wish to train with CAT while in the Clemson area temporarily, may train a maximum of 15 days/year without joining CAT and paying swim fees. Visiting or Temporary Swimmers not registered with either USA-S or USMS must provide proof of registration with either organization prior to swimming with CAT.

If your swimmer has not yet been evaluated, please do not continue the registration process!

AGMT 1: Liability & Medical Release Waiver

FOR USA-S SWIMMERS UNDER 18

I certify that I am the parent or legal guardian for the child(ren) being registered by this process.

I hereby give approval for his/her/their participation in all of the Clemson Aquatic Team's (CAT) activities.

I hereby give my permission for any supervisor, coach or other team administrator associated with CAT, to seek and give appropriate medical attention for our child(ren) in the event of accident, injury, illness. I will be responsible for any and all costs associated with any necessary medical attention and/or treatment.

I hereby waive, release and forever discharge CAT, the CAT Board of Directors, Central-Clemson Recreation Center, the employees or program volunteers from all rights and claims for damages, injury, loss to person or property which may be sustained or occur during participation in CAT activities, whether or not damages or loss is due to negligence. I hereby acknowledge that my child (children) is (are) physically fit and capable of participation in all (CAT) activities.

FOR USA-S SWIMMERS 18 & OVER AND MASTERS SWIMMERS

I hereby give approval for my participation in all of the Clemson Aquatic Team's (CAT) activities. I shall hold blameless the CAT Board of Directors, Central-Clemson Recreation Center, the employees or program volunteers liable for same. I grant permission to managing personnel, emergency medical personnel, physician, hospital, or medical clinic to give lifesaving medical aid should I become ill or injured during CAT activities.

COVID RELATED WAIVER FOR ALL SWIMMERS (during the current pandemic)

I certify that I and as the parent or legal guardian, my child or children, to the best of my knowledge, have not been exposed to a person(s) confirmed to be infected with COVID-19 virus or exhibiting symptoms of infection. If I have been exposed or have traveled outside of South Carolina, I have been symptom free for at least 14 days.

Additionally, I acknowledge that if I become ill or learn of any potential exposure, I shall cease all participation in all programming of **CAT** and inform the staff immediately so they may take steps to mitigate community spread and inform those possibly exposed.

AGMT 2: Tuition & Fee Schedule

2021-2022 CAT MEMBERSHIP AND TUITION FEES

MEMBERSHIP FEE: \$200 (\$77 for Masters). This fee is collected upon registering for the team. The Membership Fee includes required membership in USA Swimming (Masters Swimmers **must** register at their own expense with <u>USMS online</u>), a team t-shirt, latex cap, and a one-year subscription to SPLASH magazine (only USA-S Members receive magazine). Silicone caps are available for purchase. Membership fee is non-refundable after the two-week trial.

The membership fee may be paid by credit card (\$0.30 plus 3% fee) or check (no fee, bring check to first practice).

CAT is pleased to offer two membership models for 2021-2022: *Semester* (paid in two installments – in the first month and by February 1) and *Monthly* (paid each month). With notification by January 1, 2022, a swimmer can move between these models.

SEMESTER MODEL: TUITION FEE: This fee is collected on the 1st day of the month following registration and February 1. Swim fees are non-refundable.

IMPORTANT: Adv Juniors, Senior and Master's Biannual (Semester) Rates include a discount compared to paying monthly. The Hydrotigers and Juniors rates for monthly and Biannual are the same if 11 months are swum. If your swimmer is not committed to 11 months of swimming, we recommend the monthly rate!

There are no refunds for the Biannual (Semester) Membership model once paid.

MONTHLY MODEL: TUITION FEE: This fee is collected on the 1st day of each month. Swim fees are non-refundable.

General Payment Policies

CAT does not accept checks for any expenses other than annual membership, volunteer buy-out or fundraising obligations. Fees associated with monthly tuition and swim meets must be paid by credit card or electronic check. On-demand payments (one-time payments) are assessed a fee of \$0.30 per transaction and 3%.

A \$25 late fee will be assessed on all accounts with an outstanding balance on the 15th of each month.

Swimmers may be eligible for some fee reduction using guidelines for the Outreach Program from the South Carolina Local Swim Committee. Please contact the CAT Treasurer at treasurer@clemsonaquaticteam.org for information.

<u>Multi-Swimmer Family Discounts (only applicable to Hydrotigers, Juniors, Advanced Juniors, Seniors; Outreach families not eligible)</u>

Families with two or more swimmers receive discounted dues

1st swimmer pays full dues (applied to highest fee payer)

2nd swimmer receives a 5% discount (applied to second highest fee payer)

3rd swimmer receives a 10% discount (applied to third highest fee payer)

4th swimmer and subsequent swimmers are free, in addition to the discounts for the second and third swimmer (applied to 4th and later highest fee payer)

These discounts apply to biannual (semester) and monthly membership models, as long as all swimmers in a family are in the same membership model

Team competition suits and caps, practice equipment, meet entry fees, travel fees, and any swimmer/parent travel cost associated with attending meets is the sole responsibility of the swimmer and their family.

AGMT 3: Member Family Volunteer and Fundraising Commitment

CAT is run by a volunteer parent board and a paid coaching staff. However, these 10-13 people cannot run the entire team by themselves. As CAT is a parent-owned team, we spread the work to run the team over the team families as a volunteer obligation. If the family volunteer hours are not included, CAT would have to pay for people to perform these tasks, which will raise monthly fees.

Volunteer Obligation

Applies to Hydrotigers, Juniors, Advanced Juniors, Seniors 50 hours per *family*. 2 options:

- 1. Pay \$500 at registration
- 2. Volunteer at meets, social events, or in other roles.

Obligation is pro-rated based on membership length if joining later or leaving the team. Contact the Chair for details.

Shortages will be charged \$20/hour on Aug 1, 2022.

BEST SOURCE OF VOLUNTEER HOURS: WORK AT CAT HOSTED SWIM MEETS: Hosting swim meets is CAT's main activity during the year. Please see the CAT Volunteer Handbook https://www.teamunify.com/team/sccat/page/team-info/volunteer-handbook for roles at meets.

Other service opportunities are available in addition to CAT hosted meets. For example, time spent as an official or timer at non-CAT meets are appreciated by other teams, and CAT wants to encourage your service in those roles. Please contact the CAT Board Chair for more information.

CAT's Budget Model

CAT's budget model is based on monthly fees recovering the costs for practice coaching and practice space (pool time). Unfortunately, the monthly rates do not cover our anticipated costs, so the CAT Board has elected to use a family Fundraising Obligation to partially meet the difference in the budget. In this way, costs that could be imposed on families can be met in other ways – for example, by the family making a tax-deductible donation, securing a donation from a local merchant, or receiving a grant from a foundation. This is similar to "fair share" programs in some school activities.

All non-athlete members (coaches, officials, board members, safety marshals, etc.) are subject to a criminal background check and a pre-employment screening, as well as complete USA Swimming's Athlete Protection Training.

All USA Swimming athlete members 18 or older must complete Athlete Protection Training (http://www.usaswimming.org/apt) annually before participating in any USA Swimming meets. The policy is available at https://bit.ly/2H9Ah4I.

All member clubs are required to have athlete protection policies in place with regard to travel, electronic communication, and anti-bullying.
