Greenville County Aquatic Complex is a semi-open-air facility with twenty (20) 25 yard lanes and adjacent five (5) lane warm-up/warm-down pool. Both pools are bottom striped, wall targeted and equipped with non-turbulent lane lines. Bleacher seating is available for up to 850 spectators along with ample deck space and bleacher seating for swimmers. The water depth of the competition pool (or course) is six (6) feet to seven (7) feet measured from one (1) meter to five (5) meters at the starting end of the course and six (6) feet to seven (7) feet measured from one (1) meter to five (5) meters at the turn end of the course. The competition course has been certified in accordance with 104.2.2C (4). The copy of such certification is on file with USA Swimming.

Facility Rules:

- *NO smoking is allowed inside the facility
- *NO coolers allowed inside the facility
- *NO glass containers allowed inside the facility
- *NO food or beverages allowed on deck, in the locker rooms or in spectator areas.
- *NO folding chairs or seatbacks allowed in the facility. Bleacher seating will be available.
- *Spectators limited to designated areas
- *Reserving seats between sessions is prohibited
- *Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
- *Medical supervision will be provided by the lifeguards at the GCAC and an AED is on site.

Rules: Meet to be conducted in accordance with the current USA Swimming and SC Swimming Rules and Regulations and information herein. **Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms. Recording devices are also not permitted behind the starting blocks. Deck changing is prohibited by USA Swimming and South Carolina Swimming. A first offense will result in the disqualification of the offending swimmer from the next scheduled event. The second offense for the same swimmer will result in the disqualification from the remainder of the meet.**

MAAPP 2.0: All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.

SWIMWEAR: No Technical Suit may be worn by any 12 & Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet (USA Swimming rule 102.8.1F).

Athlete

Age is to be determined by the first day of the meet.

Eligibility:

All swimmers and teams must be currently registered members of USA-Swimming.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Image Release:

By attending or participating in this competition, you agree to be filmed and photographed by the host club approved photographer(s) and videographer(s) and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or SCLSC website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the start of the meet.

Entry limit: Friday: 2 individual events, Saturday: 11&ups may swim 3 events and 10&under may swim 4 including time trials. Sunday: all swimmers may swim 4 events including time trials.

\$10.00 per swimmer surcharge if entries are not submitted electronically.

Meet Format:

- **All Friday and Sunday events are timed finals.** All events 11 & above on **Saturday** will be prelims/finals.
- The 50 Free will be swam as a shoot -out. Everyone will compete in the first event Friday, Top 8 will swim after the Open 400 IM, Top 4 will swim at the beginning of finals on Saturday Night.
- The top 20 for each age group of 11-12, and 13-14, and top 30 for 15 & Over will return for finals.
- The 400 IM, 500 Free, and 1650 Free will be deck seeded, require positive check-in (30 minutes prior to the start of the session), and will be swum fast to slow alternating heats of women and men.
- Swimmers that check-in and do not appear for the events (All events 400 yards and longer) will be disqualified from their next scheduled event. All other events will be pre-seeded. Pre-seeded events will have no penalty for scratching.
- Distance events may be seeded together and scored separately (12& Under 200 and longer) per rule 102.1.5.
- Any swimmer not planning to swim at night in the finals must scratch so those swimmers who would like to swim again may do so. Swimmers that fail to show for their event at finals will be unable to swim in their first event the next day.
- **Swimmers in the 500 Free and 1650 Free must provide their own timers (and counter if they wish one).**
- A swimmer that misses their assigned heat will not be entered into another heat of that event unless circumstances are beyond the swimmer's control as determined by the meet referee and the swimmer may be allowed to swim.
- No refunds will be given.
- Meet management reserves the right to limit number of heats of 400 IM, 500 Free and 1650 Free as required for meet timeline management.
- Meet management reserves the right to insert breaks in the meet where necessary to allow athletes proper rest.
- Meet management reserves the right to run competition in up to two courses of up to 10 lanes

- Meet management reserves the right to split or combine sessions as required for timeline management.
- Entries will be limited to the first 800 swimmers that have submitted all required documentations and fees by the meet deadline. If a team's entries exceed the limits, all entries for that team will be accepted.

Time Trials:

Time Trials will be conducted at the end of the session and at the discretion of Meet Referee.

Time Trial fees must be paid upon entry at the Clerk of Course.

A time trial is counted as an individual event. Each swimmer swimming in a time trial will be required to provide their own timer.

Time of the Meet:

- Friday: Warm-up 4:30 pm, Meet 6:00 pm
- Saturday Prelims: Warm-up 7:30 am, Meet 9:00 am
- Saturday Timed Finals: Warm-ups Not Before 12:30, Meet: Not Before 1:30
- Saturday Finals: Warm-ups 5:00 pm, Meet 6:00 pm
- Sunday: Warm-up 7:30 am, Meet 9:00 am
- Sunday PM: Warm up 12:00pm, Meet 1:00pm
- Meet management reserves the right to adjust warm-up, meet start times and create additional sessions based upon the number of entries and Covid-19 protocols. Teams will be notified of any changes via e-mail.

Entries:

Clubs should submit a single check payable to Team Greenville for the full amount due. All fees must be paid prior to any swimmer entering the pool. Entry fees for events not swum will not be refunded nor will a credit be given.

Please use swimmer's full name, age, and sanctioned short course yard times or a no time. Entries on Disk using SD3 format are strongly encouraged. Clubs or individuals not submitting entries electronically will be subject to a \$10.00 per swimmer entry surcharge. Go to www.hy-tekltd.com to download Team Manager II Lite if your club does not possess team management software. You must submit paper back-up and your signed team summary sheet for verification.

Entry Deadline: All entries must be received by 11:59 pm, Tuesday, November 25, 2025

SC Swimming does not accept deck registrations.

All swimmers entered must be registered at time of entry deadline.

Coaches Eligibility:

- All coaches must be a current member in good standing with USA Swimming and present their credentials (via Deck Pass) to receive their coaching packet. Coaches must check in at Clerk of Course and provide current coaching credentials to be permitted on deck.
- **Coaches Meeting:** If possible, Coaches and Officials meetings will be held virtually prior to the start of the meet.
- **One coach from each team may** pick up the team's packet at Clerk of Course.

Other Information:

Officials: Certified officials willing to work are always welcome and encouraged. Please contact the Meet Referee and Meet Director, and report to the Officials meeting one hour before the meet begins. The Meet Referee is Dorian Lazea d_lazea@yahoo.com

*Note: Coaches and Officials meetings may be held virtually prior to the start of the meet.

From Interstate 85 take exit 44 (White Horse Road, U.S.25 By-Pass). Go North on 25 for approximately five miles. Turn right on S.C. Route 253. Greenville County Aquatic Complex is about one-half mile on left.

Parking: Parking on the ball fields or across the street at the church is prohibited. Cars parked in unauthorized areas will be towed at the owner's expense. Buses and RV's may not park in the lot immediately adjacent to the pool. RV overnight parking is prohibited.
