Participant Waiver, Release & Covenant Not to Sue

THIS IS A LEGALLY BINDING AGREEMENT. READ THIS ENTIRE DOCUMENT CAREFULLY.

Acknowledgment of Risk

I hereby acknowledge and agree that participation in TG programs and activities including the use of pools and other facilities leased or accessed by TG for practices, meets, or other team related activities (hereinafter "TG Activities") come with inherent risks. I have full knowledge and understanding of the inherent risks associated with such use and participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with such use and participation and that the preceding list in no way limits the operation of this Agreement.

Coronavirus / COVID-19 Warning & Disclaimer

The novel coronavirus ("COVID-19") has been declared a worldwide pandemic by the World Health Organization. COVID-19 is an extremely contagious virus and is believed to spread easily through person-to-person contact. COVID-19 infections have been confirmed throughout the United States and in South Carolina, including Greenville County. Federal and state authorities recommend social distancing as a means to prevent the spread of the virus.

I understand that TG has implemented preventative measures designed to reduce the spread of COVID-19, but that despite such measures, TG cannot guarantee that my child(ren) or I will not become infected with COVID-19. Further, I understand that participating in TG Activities could increase the risk that my child(ren) or I will contract COVID-19.

By signing this Agreement, I acknowledge the contagious nature and related risks associated with COVID-19 and voluntarily assume sole responsibility for the risk that my child(ren) and I may be exposed or infected by COVID-19 by participating in TG Activities and that exposure to COVID-19 can lead to severe illness, personal injury, permanent disability and death. I also acknowledge that TG in no way warrants that COVID-19 infection will not occur through participation in TG Activities.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration for being permitted to participate in TG programs and Activities, I, the undersigned, on behalf of myself, my heirs, representatives, executors, administrators, and assigns, as well as my child(ren), and/or any child(ren) for whom I have legal custody, HEREBY DO RELEASE Team Greenville Swim Club ("TG") its related entities, and the officers, directors, employees, volunteers, agents, representatives and insurers of them, (collectively referred to as "Releasees") from any causes of

action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, my heirs, representatives, executors, administrators, assigns and/or child(ren) may have, now or in the future, against Releasees on account of personal injury, property damage, infection, death or accident of any kind, arising out of or in any way related participation in TG Activities, however and wherever the injury or damage occurs, including, but not limited to the negligence of Releasees.

I also agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related participation in TG Activities by me or my children.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation in TG Activities and that I am voluntarily assuming said risks on my behalf and on behalf of my child(ren). I understand that I, not TG or any Releasees, will be solely responsible for any loss or damage, including personal injury, property damage, or death, that I, or my child(ren) sustain while participating in TG Activities and that by signing this agreement I HEREBY RELEASE TG and all other Releasees from all liability for such loss, damage, personal injury or death. I certify that I and my child(ren) are in good health and have no conditions or impairments which would preclude the safe participation in TG Activities.

I certify that I am of lawful age (18 years or older) and otherwise legally competent to sign this agreement on my behalf and on behalf of my child(ren). I further understand that the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it, of my own free will.
