

Coast Aquatics Swim Team Fees Registration

Effective August 8, 2025

<u>Please read through all the following information. These forms contain information for billing, dues, meet fees, and other requirements for Coast Aquatics.</u>

TRYOUTS: We'd love to meet your swimmer! The first step is to schedule a quick evaluation so we can see their skills and place them in the group that's the best fit. To schedule: Email us at coastaquaticscontact@gmail.com with your preferred location and date, and we'll confirm your swimmer's evaluation. **Evaluation Schedule:**

- Destin: Tuesday & Thursday at 4:00 PM
- Fort Walton Beach: Monday & Wednesday at 4:00 PM
- Niceville (Woodlands Pool): Monday & Wednesday at 5:00 PM

Please note: An evaluation does not guarantee immediate placement on the team. If a group is currently full, we'll add your swimmer to our waitlist and contact you as soon as space becomes available.

Coast Aquatics Registration: A non-refundable registration fee is due at the time of enrollment, once your registration has been received we will create an account and send out information on how to set up Auto Billing. Dues and fees will be billed to your account and must be paid within the first month of participation. Every new swimmer must pay a one-time registration fee of \$25 per swimmer.

US Swimming Registration: All Coast Aquatics swimmers are required to register with USA Swimming for insurance coverage and to participate in meets. Once your Coast account is set up, you'll receive a link with instructions to complete your USA Swimming registration. New swimmers must pay the USA Swimming fee before competing with Coast Aquatics. The fee for USA Swimming for the 2025-2026 season is \$82.

Training Fees: Coast Aquatics is a year round swim club. Training fees must be paid monthly and families are required to sign up for the automatic payment program on the team's website. Payment may be made via credit card (fees apply) or linked to your bank account (no fees apply). Training fees apply to the **first three swimmers** in a family. Additional swimmers must still pay registration and meet fees. Swim meet fees, swim cap orders, and travel fees will be automatically charged to your account following the registration deadline for the meet. Multiple swimmer discounts will be credited following each meet.

- → There is no allowance or refund for absences, weather cancellations, or missed days. All makeup practices are at the discretion of the coaches.
- → I understand that Coast Aquatics Inc. reserves the right to refuse a child or to cancel any child's enrollment whose conduct is unacceptable. In such a case, unused fees will not be refunded.

Payment: Must be paid by credit card or bank draft. Payment is charged to your account on the first of the month. If you wish to cancel or suspend your membership you <u>must</u> notify the team admin (coastaquaticscontact@gmail.com) 15 days in advance of the month in which you which to cancel or suspend; otherwise your account will be charged and will not be eligible for a refund unless the suspension is a result of a medical injury. Account suspensions can only be in month increments and the swimmer may not attend practice or meets in the time period in which the swimmer's account is suspended.

Coast Aquatics Membership Agreement & Policies

Team Account

All members receive a Coast Aquatics account through Team Unify (SportsEngine). Once set up, you'll receive a username and password. Your account allows you to view invoices, check the meet schedule, sign up for meets and volunteer duties, and track volunteer hours. Monthly billing statements include registration fees, training fees, meet entry fees, and fundraising charges.

Meet Fees

Meet fees are billed to your account and appear on your monthly invoice. They are non-refundable once a swimmer is entered, even if the swimmer does not attend. For meets outside Okaloosa County, a \$25 per-family travel fee applies.

Fundraising

Our annual 'Black and Blue' inter-squad meet helps cover program costs not covered by monthly dues. Each family must raise at least \$100 for this event through sponsorships, fundraising, or an account charge. Families not attending will have the fee automatically charged. All members are expected to attend, support, and volunteer at home events.

Financial Policy

Membership fees continue until you notify the team admin in writing (email preferred) by the 15th of the month to deactivate your account. If notification is received after the 15th, the next month's fees will apply.

Volunteer Commitment

Parents must assist at home meets and are encouraged to help with fundraising. Attendance at the August preseason meeting is required, and families must work a minimum of 2 volunteer hours per season (subject to change). Jobs may include officiating, timing, running, recording, or providing food/monetary donations.

Photo Release

By signing below, you authorize Coast Aquatics to use recognizable images of your child in team-related media (banquets, newsletters, social media, etc.) in accordance with USA Swimming photography guidelines:

- Action shots must be appropriate and sports-focused.
- No photos showing torn/displaced swimsuits.

IN CONSIDERATION OF, AND AS A CONDITION TO MY ENTERING, BEING PRESENT OR PARTICIPATING IN ANY PROGRAM OR EVENT AT THE FACILITY, I HEREBY KNOWINGLY AND INTENTIONALLY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, the Releasees from any and all claims, causes of action, suits, controversies or liabilities of any kind whatsoever against any of the Releasees which in any way directly or indirectly arise from or are connected with my entry, presence or participation at the Facility, or to the risks associated with a swimming pool, including, without limitation, any claim or cause of action involving death, mutilation, bodily injury, emotional distress, or loss or damage to property whether caused by the active, passive or grossly negligent act or omission of Releasees, myself or any other person or entity, and further, from any and all liability to me, my personal representatives, assigns, and heirs for any and all loss or damage, and any claims or demands therefore on account of injury to me or resulting in my death, whether caused by the negligence of the Releasees or otherwise, while I am present at the Facility or while participating in any activity at the Facility.

I HEREBY AGREE TO INDEMNIFY, DEFEND AND HOLD HARMLESS the Releasees from any and all loss, liability, damage, or costs, including attorney's fees and costs, as a result of any claims, demands, actions, causes of action, damages, or judgments, that Releasees may incur arising out of, claimed on account of, or in any manner predicated upon my use of the Facility and/or while participating in any activity while at the Facility including any and all loss or damage to property, personal or otherwise, personal injury or death of any person, which occurs as a result of me, my guest(s)'s or my family member(s)'s use of the Facility or while participating in any activity at the Facility, even where the loss, damage, personal injury or death is caused or contributed to by the Releasees, whether caused by their negligence or otherwise.

I FURTHER HEREBY HOLD EACH OF THE RELEASED PARTIES HARMLESS from and against all of the above described claims, and hereby indemnify each of the Releasees with respect to any claim, cause of action, suit, controversy or liability of any kind whatsoever arising from my own acts or omissions in connection with my entry, presence or participation at the Facility, or to the risks associated with a swimming pool, whether my acts or omissions are actively, passively, or grossly negligent or intentional. I hereby covenant and agree to indemnify, protect, defend, hold and save harmless the Releasees, from any and all claims, actions, lawsuits and demands of any kind or nature arising out of this Agreement. For and in consideration of the opportunity to participate in swimming and related activities at the Facility, I, my heirs, successors and assigns, forever release, hold harmless and indemnify the Releasees from any and all liability whatsoever for any personal property damage or for any personal injury that may result from said participation.

I agree, for myself, my heirs, successors and assigns, that the above representations are contractually binding and are not mere recitals, and that should I, my Personal Representative, heirs, successors or assigns, assert any claim in contravention of this Agreement, the asserting party shall be liable for the expenses (including reasonable attorney fees and costs) incurred by the other party or parties. This Agreement may not be modified orally, and waiver of any provision shall not be construed as a modification of any provision herein or as consent to any subsequent waiver or modification. I am at least 18 years of age and suffer from no physical, mental, legal or other disabilities that prevent me from fully understanding the terms of signing this Agreement.

Swimmer Code of Conduct

The purpose of a code of conduct for athletes is to establish a consistent expectation for athletes' behavior.

By signing this code of conduct, I agree to the following statements:
☐ I will respect and show courtesy to my teammates and coaches at all times.
☐ I will demonstrate good sportsmanship at all practices and meets.
☐ I will set a good example of behavior and work ethic for my younger teammates.
☐ I will be respectful of my teammates' feelings and personal space. I will refrain from sexist, racist, homophobic, or otherwise inappropriate behavior.
☐ I will attend all team meetings and training sessions, unless I am excused by my coach.
☐ I will show respect for all facilities and other property (including locker rooms) used during practices, competitions, and team activities.
☐ I will refrain from foul language, violence, and behaviors deemed dishonest, offensive, or illegal.
☐ If I disagree with an official's call, I will talk with my coach and not approach the official directly.
☐ I will obey all of USA Swimming's rules and codes of conduct.

Parent Code of Conduct

The purpose of a code of conduct for parents is to establish consistent expectations for behavior by parents.

As a parent/guardian, I understand the important growth and developmental support that my child's participation fosters. I also understand that it is essential to provide the coaching staff with respect and the authority to coach the team.

I agree with the following statements:

Names will be added ASAP but there may be up to a few days before you are on the list. Please check with the administration prior to driving to base.

Once added to the list, you will need to go through the main gate off highway 98 (the back gate isn't reliable to have the list) with your normal ID. Tell the guard you are with the Coast Aquatics swimming team and show your ID. There may be some time for the guards to check the list. Once they match you up, you are good to go.
