Senior Proposal – Olympic Trial Funding Request

1. \$1,500 per swimmer
2. \$1,200 per coach
3. Each club would qualify an additional coach for funding for every 3 athletes that qualify
4. Estimated Budget - \$30,000 - \$35,000
5. Swimmers must do the following to qualify for SN Olympic Trial Funding
 - a. Represent a SN club (Dual representation will count)
 - b. Not receive any additional funding from another LSC or University.
