## Information for Children under Age Thirteen

We recognize that children under age thirteen (13) may want to register for accounts through and use the Swim Team Websites. Before we allow a child under age thirteen (13) to register for an account through a Swim Team Website or to otherwise provide us Personal Information through use of a Swim Team Website, we first obtain consent from the child's parent or guardian for the child to use the applicable Swim Team Website and provide us Personal Information through the use of the Swim Team Website. When a child under age thirteen (13) tries to register for an account on a Swim Team Website or otherwise provide us Personal Information through a Swim Team Website, we collect the child's e-mail address (or that of a parent or guardian) solely for the purpose of contacting the parent or guardian to request consent. We send the child and/or parent or guardian an email directed to the parent or guardian and provide the parent or quardian forty-eight (48) hours to respond with his or her consent to allow the child to register for an account on the Swim Team Website or otherwise provide us Personal Information through use of the Swim Team Website. If the parent or guardian refuses to allow the child to register for an account on the Swim Team Website or otherwise provide us Personal Information through the Swim Team Website, or if the parent or guardian does not provide consent within forty-eight (48) hours of when we requested consent, we delete the child's email address (as well as the parent or guardian email address) from our database and do not allow the child to register for an account or otherwise provide us Personal Information through use of the Swim Team Website.

Before allowing a child under age thirteen (13) to use any feature of a Swim Team Website that might result in public disclosure of the child's Personal Information, comments, or content to the public, we require a high level of verification to confirm that the parent or guardian has given permission for the child to participate in such features and activities. For example, we may require the parent or guardian to return by postal mail, fax, or email a signed consent form.

When we know we are going to collect Personal Information from a child under age thirteen (13) in order to allow the child to use a certain feature of the Swim Team Website, we take the following steps to protect the child's privacy:

- We notify the child's parent or guardian about our information practices with regarding to children, including the types of Personal Information we may collect from children, how we collect that information, the uses to which we may put that information, and whether and with whom we may share that information;
- In accordance with applicable law, we obtain consent from the child's parent or guardian for the
  collection and use of Personal Information from the child, and/or for sending information about our
  products and services to the child directly (see discussion of our procedure for obtaining consent
  directly above);
- We limit our collection of Personal Information from the child to no more than is reasonably necessary
  to allow the child to use the particular feature(s) of the Swim Team Website that the child wants to
  use;
- We provide the child's parent or guardian the option to consent to our collection and use of the child's Personal Information, without consenting to our disclosure of that information to third parties; and
- Providing the child's parent or guardian access, or the ability to request access, to the Personal
  Information we have collected from the child and the child's account, as well as the ability to
  request that the child's Personal Information be changed or deleted. The child's parent or
  guardian may also provide us notice that the parent or guardian refuses to allow any further
  collection or use of the child's Personal Information at any time, and that the child's account be
  deleted.
