I was planning on a quick oral update on Sectionals, I did talk to Chris about this as well so he may be able to fill in:

- 1) Finalizing the Sectionals M.A. as we speak.
- 2) Two meets, 700 swimmer cap WITH out of Section athletes allowed now (MAX 200 per site).
- 3) Looking to also have two Spring Sectionals sites since we crossed the 900 swimmer barrier (in USA Swimming policies), one site always SCY, second site option for LCM on non-Trials years, Trials years will be required to be LCM.
- 4) Bid packets for 2022- 2023 are out, CCA is planning on re-bidding for the 2023 LCM Meet again, it will be held the THIRD full weekend of July this year. Decision was to always try and keep it there so we have that two weekend barrier between Sectionals and other national meets here on out. If USA Swim National calendar changes bid winner will have option to change their date (they can keep if locked in) from initial discussions. Bid packet was shared, due end of April, decision on May 12th meetings.
