Some changes to the Minor Athlete Abuse Protection Policy (MAAPP) will be rolled out soon by USA Swimming once the final draft is approved by the National Center for Safe Sport.

There is no written version of the draft to be shared (it's a draft, after all). As you probably know, MAAPP was first rolled out to all of USA Swimming with only six weeks notice in 2019, taking effect in the middle of the summer long course swim season. This next roll-out is scheduled to hit Sept. 1 and designed to fall during the registration period for short course season.

#### I have summarized the main points for you here:

The update is very similar to the current MAAPP, broken out in six policy areas:

- One-on-one interactions
- Meetings and individual training sessions
- Electronic communications
- In-program transportation and lodging
- Locker rooms and changing areas
- Massages, rubdowns and athletic training modalities

#### Noteworthy updates coming in MAAPP 2.0:

- The term Applicable Adult will now be called Adult Participant in MAAPP 2.0, per the Center. This includes any adult (18-over athletes included) who is a USA Swimming member, or participating non-member who has regular contact with minor athletes (timers/marshals/meet volunteers).
- A Definitions Section will spell out what terms mean. There will be about a dozen terms defined, including what determines In-Program interactions such as practices, meals, team functions and other activities, like meetings
- Exceptions will be clarified:
  - Close-in-age exceptions will be updated. As an example, if an Adult Participant has no control over a minor (18-year-old swimming with 16-year-old) the exception applies. Dual relationship exception permits parents to be officials and college coaches who are USA Swimming members to have more recruiting leeway with minor prospects An adult participant can be granted a personal care assistant exception E.G.: An adult accompanies deaf athlete as an interpreter on international trip
- Consent update: MAAPP must be agreed upon annually. Parents must sign off for massages for each treatment occurrence
- Individual training sessions Private lessons must be open and observable
- Electronic communication Messages must be copied to another Adult Participant to raise accountability. The communication window is extended to start at 5 a.m.and end at 9 p.m.
- Transportation and lodging will be separated to replace the current local travel and team travel policies.
- Locker rooms and changing areas Clubs must now provide private or semi-private changing areas for minors (stalls with signage, pop-up tents provided to all clubs with SSRP clubs getting an extra one.
  - E.G: A 28-year-old swimming at Trials but dressing with a 17-year-old competitor cannot fall under close-in-age exception, per the National Center (Omaha falls under MAAPP 1.0 but changing tents will still be provided) Definition of undress will be modified to align with what

swimmers normally wear

Showers - Adult Participants should not be showering with minors unless close-in-age exception applies

• Massages - Parents will be required to observe except where credential access prohibits the parental presence. Then another Adult Participant must observe.

The Center is requiring MAAPP 2.0 implementation for all NGB's on Jan. 1, 2022. USA Swimming moved up our implementation to Sept. 1 so it falls during short course registration to streamline the consent process during short course registration.

USA Swimming will have a communication roll-out that involves PSA's, web and newsletter updates. USA Swimming will provide sample consent forms for massages, dual-relationship exceptions, etc. Webinars and FAQ will be posted. The Center will also post general webinars by audiences (coaches, parents) that are not sport-specific starting in May. USA Swimming is working to provide MAAPP and other training materials in Spanish.

Safe Sport reported today that SNS is 52% SSRP, but no official letter indicating achieving second level achievement. SNS has achieved first level (25%) with \$1500 to LSC (to be used for programs benefiting the athletes. We have until June 15th to reach the second tier for an additional \$2000.00.

All registered clubs will be receiving a pop up changing tent through the support of "Keeping Athletes First".


#### Sierra Nevada Olympic Trial Funding 2021

#### Athlete Reimbursement

- All athletes that meet criteria are eligible for a maximum \$1500 in reimbursement from Sierra Nevada Swimming.
- Teams must submit for reimbursement one week after the completion of Olympic Trials or before.
- SN may ask for detailed expenditures as overpayment to an athlete can jeopardize their NCAA and amateur eligibility.

#### **Eligibility Criteria**

<u>i.</u>	Only swimmers that qualify and are going to represent a Sierra Nevada team
	(Primary team- not secondary) at Olympic Trials are eligible for SN
	reimbursement.



- Swimmers who have represented SNS for at least 18 continuous months will be eligible for reimbursement.
- iii. College athletes that swam with a SNS club team before college and will be representing a Sierra Nevada team at Olympic trials are eligible for reimbursement based on their club membership prior to college. Swimmers may not receive any additional funding or support from another entity including USA Swimming, or a University.

### Team/Staff Funding

• Teams will be eligible for a maximum of \$1000 per wave. Teams will be eligible for funding only if they have a swimmer(s) that qualify and represent that Sierra Nevada team (Primary team- not secondary) at Olympic Trials.
