	Rule 4: Only the first heat of an event at dual meets will be scored.
	Rule 5a: Visiting teams must submit entries for dual meets at least 24 hours before the start of the meet (unless otherwise agreed to). After the second late submission, each additional late submission will result in a \$100 fine.
	Rule 5c: Swimmers may swim up an age group to fill relays in dual meets, but may not do so at Championships.
	Rule 7: Ribbons must be awarded to all scoring swims (at a minimum)
	Rule 8c: The Head Coach for the home team is responsible for getting results to the Administrative Secretary within 48 hours of the conclusion of the meet. Failure to do so may result in a fine of \$25 per week
	Rule 19: Swimmers practicing, competing, or participating in activities prior to proper registration will result in a \$50 fine per swimmer.
	Rule 20: SAAA Waiver forms or equivalent printed spreadsheet containing emergency contact information AND medical conditions must be on deck at ALL SAAA practices, meets, Invitationals, and Championships
	Rule 22: Swimmers must be listed on the official final team roster of the Admin Secretary and must have competed in an individual event in at least three SAAA-sanctioned meets to be eligible for Championships.
	USA Swim Rule 304.3.11: Recruiting swimmers from other teams is prohibited. This includes swimmer-swimmer and/or parent-parent encouragement to change teams.
	Teams are required to provide officials for Championships and Invitationals based on their number of entered swimmers.
	Rule 32: COACHES CODE OF CONDUCT: SAAA Coaches agree to support and promote the SAAA purpose, objectives, and swim rules. They further agree to behave in a RESPECTFUL, RESPONSIBLE, SAFE, AND PROFESSIONAL manner at all practices, home and away meets, invitationals, and championship preliminary and final meets. Behavior may include but not be limited to: follow the SAAA swim rules and their intent; represent their SAAA team and the SAAA organization with integrity; use appropriate language and actions with swimmers, coaches, officials, and spectators; no possession or use of alcohol or illegal substances; no possession or use of weapons real or implied; no conduct or behavior that could endanger swimmers, coaches, officials, or spectators; follow the facility rules as posted, announced, or implied at all swimming venues. Coaches in violation of Rule 33 are subject to dismissal from the SAAA organization by a majority vote of the SAAA executive board
