Title: Swim School Instructor or Volunteer

Job Type: Part-Time, varies by site, on average 3-6 hours/week

Start Date: Upon review and submission of required job materials, candidates will be notified of hiring and can begin once approved by HR.

Position Overview

- Instructors are responsible for providing instruction on water safety classes and proper swim techniques.
- Volunteers are responsible for assisting instructors and aids, and learning teaching skills and techniques from the instructors and aids
- Pay rate for instructors: \$15/hour if lifeguard certified, \$12/hr if not lifeguard certified.
- Volunteers will receive a certificate of volunteer hours at the end of each session.

- Performs deck teacher duties as needed
- Other duties as assigned

- Must possess a valid CPR or Lifeguard Certification with CPR, First Aid, and AED training at all times
- Work Permit (if under 17 years of age)
- Volunteers ages 17 and under do not need to submit clearances or a work permit
