ANNUAL REGISTRATION FEE

This fee is non-refundable. Registration is a commitment to membership through July 31, 2024. **\$150**

*New registrations joining mid-month (between September 1 and July 31) shall have the first month's dues prorated.

FUNDRAISING

Each Wave **family** is required to raise a minimum of **\$100** at the main annual fundraiser which is held in September or October. Non participants and mid season registrations shall be assessed a **\$10** monthly fundraising fee.

MEET FEES

Meet fees shall be collected on-demand when the meet entries are submitted to the host team. Local* meets include a Wave supplement of **\$3** per event to defray coaches' travel expenses. *All meets are local unless otherwise stated.

USA SWIMMING MEMBERSHIP

All members are required to have USA Swimming membership. Subject to the following conditions, swimmers affiliated to Wave may choose between Premium and Flex membership.

Premium Membership: Required for swimmers 13 years and above. Participation in 3 or more sanctioned USA Swimming meets/ year. Participation in a meet at or above Championship level.

Flex Membership: Available for swimmers 12 years old or younger. Participation in 2 sanctioned USA Swimming meets. Flex membership is appropriate for Development practice groups.

Upgrades: Members may upgrade at any time through their USA Swimming account. USA Swimming will charge the difference between the membership types, plus credit card fees. Wave shall process USA Swimming membership upgrades where necessary for the participation in a swim meet. The cost of the upgrade plus a \$5 processing fee shall be charged to the member's account.

Renewals: USA Swimming membership for 2024 may be renewed anytime between September 1 and December 31. Wave shall process renewals for all active members without a renewal on December 1. On or shortly after December 1, accounts shall be charged the full cost of the renewal plus a \$5 processing fee.

OFFICIALS CREDIT

USA Swimming officials, including apprentices, may claim **\$25** per qualifying session officiated.*

*Must be in good standing and affiliated to Wave. Qualifying sessions are for meets Wave attends as a team. Credit may only be applied to swimmer meet fees for the qualifying meet. Claim is limited to two sessions per month and must be made within two weeks of the meet end.

VOLUNTEER OBLIGATIONS

Families are required to volunteer 10 hours per swim year. Hours should be recorded on the team website for: Meets, team events (including Swim-A Thon), ad hoc projects, SafeSport training.

SAFE SPORT

One member per family is required to take SafeSport orientation training. This training is available on-line through USA-Swimming (approximately one hour), or any in-person event that is organized in the local area.

PAYMENT OBLIGATIONS

- Monthly payments may be paid by credit or Automated Clearing House (ACH debit)
- Monthly payments of swimmers' dues are collected automatically in advance on the first (1st) of each month.
- **Accounts must maintain a valid credit card on file for on-demand payments.**
- Personal checks and/or mailed payments are not accepted.

ON DEMAND PAYMENTS

- Merchandise sales shall be charged at the time of order.
- Uncollected balances shall be collected when we are notified of a declined payment.
- Other purchases including, contributions to team events and USA Swimming membership upgrades/renewals.
- Meet Fees shall be charged at the time entries are submitted to the host team.

FEES & PENALTIES

- Declined Payment **\$10**.
- Late Payment **\$25**: Assessed when full payment is not received by the 5th of the month.

CANCELLATION

Registration is a commitment to membership through the completion of the swim year on July 31. Members will be released from this commitment with payment of the withdrawal fee of **\$150** per swimmer.

- A notice period is not required.
- Retroactive withdrawal dates are not accepted.
- The date of withdrawal must be notified to the team administration using the on-line withdrawal forms.
- The withdrawal fee and all account balances shall become due at the time of the drop notice including, but not limited to meet fees, monthly dues, fundraising obligations, late payment penalties, fees for swim lessons and clinics, and merchandise sales.

REFUNDS

Registration fees are non refundable. Retroactive withdrawal dates are not accepted. Dues shall not be prorated for partial participation.

INJURY

A swimmer with a medical condition or injury that prevents participation in swim practices for more than two weeks may request a **proration of monthly dues**. A doctor's note is required.

HOLDS

Remaining on the team is highly recommended because the individualized groups are carefully designed to ensure progression and maximize the swimmer's potential. Additionally, many groups have waitlists in the Fall and a **"hold" will secure a swimmer's place on the team**. When swimmers have other activities they may be placed on a temporary hold:

- Maximum of **two months** in a swim year (may be consecutive).
- Monthly dues will be charged at a **50% discount**.
- Swimmers may participate in 50% of scheduled practices and meets that Wave is attending as a team.
- The hold request must be made to the team administration using the on-line hold forms.
- Retroactive holds are not accepted.

Examples: High school swim, middle school athletics, summer swim league, school clubs, and school tutoring.
