- USA Swimming is one of 47 National Governing Bodies (NGBs) members of the USOC (United States Olympic Committee). Florida Gold Coast (FGC) Swimming is one of 59 LSC (Local Swim Committee) members of USA Swimming. Florida Gold Coast Swimming values its partnership with USA Swimming and is an active participant in numerous national programs including:
- Annual Convention: The annual USA Swimming Convention is held annually in September. Attendance is based on position (General Chair, Admin Vice-Chair, Senior Chair, AG Chair, Coach Chair, and Athlete Reps) All participating BOD members are eligible to attend. If the number interested exceeds the budget, convention delegates will be selected by the GC based on attendance, length of service, and contributions to the LSC.
- LEAP (LSC Evaluation & Achievement Program): The USA Swimming LSC Development Committee administers USA Swimming's LEAP program, a process by which LSCs are evaluated and recognized each quad. LEAP consists of three levels with Level 1 being required once every quad.

Currently, she has received numerous international certifications in the field of neuroscience and brain-based performance coaching. She played competitive tennis and basketball at Montclair State University. She was an alternate to the Women's Olympic Basketball team and maintains an undefeated college tennis record. She has coached at the collegiate and high school level for 15 years.







#### **Certification by Position**




### Sessions Worked in 2017 by Position
