Handout of New USA Swimming 2017 Legislation- regarding addition items to be put in meet information and condition of sanction. (will be required when applying for Sanctions beginning on February 1, 2017)

NEW USA Swimming 2017 Legislation-effective as of January 1, 2017 In accordance with the new 2017 USA Swimming legislation, the following items MUST be included in all of your meet information letters:

- 1) CONDITION OF SANCTION: The competition course has been certified in accordance with 104.2.2(4). The copy of such certification is on file with USA Swimming. Any swimmer entered in the meet, unaccompanied by a USA-S member coach, must be certified by a USA-S member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with the requirement. \*\* (Suggested placement is after SANCTIONED BY-section)
- 2)IMAGE AUTHORIZATION: All participants agree to be filmed and photographed by the official photographer(s) and networks(s) of USA Swimming under the conditions authorized by USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation

in USA Swimming competitions to promote such competitions.

\*\*(Suggested placement is after CAMERA FREE ZONE: section)

- 3) RULES: Current USA Swimming Rules and Florida Gold Coast rules will govern this meet. In granting this approval it is understood and agreed that USA Swimming, Florida Gold Coast, and (your club name) shall be free and held harmless from any liabilities or claims form damages arising by reason of injuries to anyone during the conduct of the event. Safety rules as outlined by USA Swimming and as recommended by the referee, will be in effect, except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated area is not appropriate and is prohibited, Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and /or spectators are present. Exceptions may be granted with prior written approval by the vice President of Program Operations. \*\*(Suggested placement is after the IMAGE AUTHOIZATION: section)
- 4) DECK CHANGE: Changing, in part or whole, into or out of a swimsuit (excluding a drag suit) is an area other than a permanent or temporary locker room, bathroom, changing room or other space designated for changing purposes while at a practice, competition or other pool-related activity. \*\*(Suggested placement is after the DISABILITY ATHLETES: section).
- \*\*Special note-Plantation Swim Club did have permission and a letter from USA Swimming to operate a drone at Winter Champs. See exceptions.

Current Status: as of January 20, 2017-113 officials with current certifications who have registered as no-athlete members for 2016 and two lifetime members. There were 28 officials who have not registered for 2017. Of the 115 officials with 2017 registration:

USA Swimming Officials are required, from time to time, to renew their certifications. 2016 was a recertification year for FGC Officials. Of the 167 certified officials in 2016, 24 did not recertify and w finished the year with 143 certified officials.

Motion: Apprentice officials must register with USA Swimming as Apprentice Officials and complete all current membership requirements within 60 days of initiation of training. The 60 day period shall begin on the date he/she performs his/her on-deck training. It shall be the responsibility of the LSC Officials Chair to monitor all apprentice officials for completion of the membership requirements. If an apprentice official does not complete all current non-athlete membership requirements prior to the 61<sup>st</sup> day after he/she has first performed on-deck training, then he/she shall be prohibited form being on the pool deck until they have completed those requirements. Motion: To require for initial certification as an Administrative Official: A formal clinic, taking the Administrative Official test with a minimum passing score of 80%; and a minimum of two apprentice sessions on deck with a mentor who has been certified as an Administrative Official or Administrative Referee for one year.
