Christi-only able to host an intra-squad meet; Chris-SOFLO/Miami swimming/Copper City/Plantation-good experience for development meet; Liz-4 other teams included themselves-need to try to empower hosts to host something; Alf-300 swimmers under timeline each time, split warmup to 45 minutes to teams-made it work in 6 lanes-had 12 teams in attendance. Had parents on deck in a separate area.

2. BB Champs Review-(Gordon and Chris)—Gordon-organization very challenging with dividing up teams/warmup times/tent assignment and working with

coaches with swimmers issues with swimmers entries. Parents had a viewing area and live streamed through Facebook as they were not allowed on deck; Chris-hats off to meet committee to make sure environment safe for athletes and created an environment of a Championship meet. Good security. Athletes swam fast and many liked just the swimmers on the deck. Steven-constantly talking to the officials about slowing the meet down and sticking to the timelines.

3. FGC Wide Coach Communication-(Jennifer)- try to communicate FGC wide to make sure all on the same page with communication. We have had so much thrown at us. The BB meet situation was not a fault of anyone-just had a lot of swimmers and not a lot of opportunities to make a time due to COVID.

4. 14 and Under Champs-(Bruno)-Currently have 441 athletes in the meet. Gave a breakdown of all the sessions with times and how many athletes in each session.

5. Sr. Champs Update-Chris-concern about numbers-close to capacity. Limits on the meet-coaches need to do your due diligence and get your meet entries complete. Currently in OME-330 athletes-138 women and 192 men total.

There is a lot going on at USA Swimming as they continue to jumpstart competition, so in addition to the items I'll cover here, please visit the USAS website to stay abreast of all that is happening.

- The ZDC has started to better define what each Zone Director is and should be doing. This will help as we experience turnover, so the new person coming in is not completely lost for a period of time. Each LSC as a part of LEAP had to develop something similar but the question is - do you use those descriptions. How often when you have leadership turnover is the new person lost for a while. Succession planning works for all of us.

- Three Governance Committee working groups have been formed, Board of Directors, Committees and House of Delegates. They will be looking at each of their assigned areas and we can expect any Board proposals at Convention to come out of these groups.

- You have already received notice on the Special meeting of the HOD 30 June, so please make sure that is on your calendars.

- Both National LC & SC virtual meets from 1-28 March, should be announced today.
- Expect four regional level competitions, LC, from late April-early May.

- Expect an East meet at Greensboro and West meet at Irvine 3-7 August requiring winter Junior cuts.

- These initiatives are all part of an ongoing effort to spur competition across the US and I'm sure regain some of our members who have not returned to swimming.

-There are grants available to each LSC to run a Select camp over the next six months, so let's make use of what is available. I've attached a select camp administrative folder off of the USA Swimming website as a reference, but the grant should be through Sports Development, so contact Jaime Lewis.

- Continue to respect the COVID protocols in place for your LSCs and individual facilities. I realize they are not standard. Some college conferences have their own protocols in place and will probably be the last to relax those protocols, so we'll just endure until this whole nightmare is past.

- Just a reminder of the upcoming virtual Zone Workshop late April - early May. While the actual dates are 30 April - 2 May, there will be some virtual meetings associated with the workshop held during the week prior, including an Athletes meeting, so please plan on attending and since it's virtual, most of your folks who are interested can attend. Friday, 30 April, will be a discussion on Governance along with a keynote speaker, Saturday will be DEI, Safe Sport and coaches education. Sunday will be for each Zone to have discussions with their LSC General Chairs and we'll probably have a short session with all four Zones participating.

And in closing, Herb sent emails out to everyone recently asking you to submit votes on whether to accept the SZ Policy & Procedures Manual which was combined with our by-laws under direction of USA Swimming legal.

# **Open Water Report/Status**

As we continue to operate under the effects of Covid19 restrictions and concerns, the following is an update on the status of OW in the FGC

- ALL STARS: This annual event is hosted by Florida Swimming and provides an opportunity for those selected FGC team members (as well as other interested swimmers) to participate as part of an Open Water Festival. This year, the original venue limited the anticipated site to OW Nationals only, necessitating a change. Florida Swimming was unable to secure a venue that could accommodate the amount of time necessary to allow FGC participation, which resulted in the cancellation of OW All Stars.
- **ZONES:** OW Zones are scheduled for June 5 in Chattanooga TN. The meet host is working to update information as he remains within compliance for Covid etc. Considerations:
  - Team travel: after speaking with zone coaches through-out; at this time, no zone is planning to travel as a team—to remove liability/responsibility from the LSC, parents will be responsible for their swimmers to include all travel, lodging, meals, etc
  - Reduced teams are being considered by each (with 10 per age group-4 groups) placing a limit on team size may be an idea.
  - Selection: with the added necessity for parents to make arrangements, and the knowledge that such travel may be out of reach for some, the LSCs are addressing methods of early team selection and scholarship

After extensive conversation with Don Henshaw, Cashel Mack, Jesse Vassalo, and the feedback from swimmers and coaches, I would like to offer the following for consideration:

- The FGC should sponsor an OW Zone Qualifier and LSC Championship event by lending financial support and assistance to the event host.
- OW needs greater exposure /more competitions in our LSC—quite a few teams found OW to be one of the only sources of water they had for practice during the lockdowns and their swimmers are ready to embrace OW competition
- While the sanctioning process has been simplified and we are adding officials, the biggest prohibition to hosting an OW event is the cost to rent the timing/chip system (necessary for both added safety and accuracy). NC/GA and several other LSCs own systems and have them available for rental by meet hosts.
- We currently do not add any LSC OW events to our schedule in the annual planning other than those hosted outside of the LSC.

# 2021 Stop Gap Solution

Looking to come up with a viable method of identifying OW Zone qualifiers and adding to our competition opportunities, Jesse Vassallo has very kindly allowed us to join his planned OW event at Pompano Pier (adding events, changing the dates etc.). Please find attached a working

copy of the meet information. The event would be held on April 24<sup>th</sup>, allow for Zone selection to be made in a timely manner to benefit parental planning, and would further meet the needs and interests of our swimmers/LSC.

Further considerations:

- Reduction of team size
- Scholarship/reimbursement

Accounting for Swimmers: Swimmers will be assigned numbers and "race tickets" when registering. The numbers will be marked on their shoulders and arms. Prior to each start, the number of swimmers starting will be counted and their "race tickets" collected. As swimmers enter the start area, their chip will be read electronically.


If the numbers of swimmers' chips is different from registration, a roll call will be made to determine the missing swimmer or the swimmer who did not hand in their "race ticket."

Once the swimmers start, they will be counted around each mark. The mark boats will also attempt to check off the number of the swimmer as they round the mark. Each mark boat will radio into the meet director or meet referee when all swimmers have rounded their mark. If any swimmers are picked up during the swim, their number will be called into land and the other mark boats.

The swimmers' numbers will be recorded at the finish as the swimmers come out of the water and each swimmer will be video recorded as they cross the finish line. The total number of swimmers will also be counted at the finish.

In addition, the races will be electronically timed. All racers will be given a timing chip, which will be programmed for their name, race number, and race. The company running the races will also record the finishers as they complete the race, so there will be a visual record of swimmers coming out of the water.

Abandoning Race:	race to be abandoned due to unsafe course or other conditions. Meet Referee, Independent Safety Monitor, PB Ocean Rescue Team Leader or the Meet Director.
	If the race is to be abandoned Race Control will relay via radio to all vessels to signal abandonment. Simultaneously, the Search & Rescue will signal abandonment.
Admission:	The abandonment signals will be: 5 short blasts of the whistle followed by one long blast. Swimmer actions are to: Discontinue swimming. #### MEDICAL AUTHORIZATION TO 'RETURN TO PLAY' WHEN ATHLETE HAS BEEN INFECTED WITH COVID-19

In accordance with CDC, the American Association of Pediatrics, and NCAA recommendations, any athlete who tests positive for COVID-19, whether symptomatic or asymptomatic, shall not return to Team activities until a documented medical exam is performed clearing the individual prior to that individual returning to meets or practices. The documented medical exam must specifically include an assessment of the cardiac/heart risk of high intensity exercise due to the potential of myocarditis occurring in COVID-19 patients.

This written medical authorization from a physician (M.D. or D.O.) or another qualified licensed medical provider, who works in consultation with, collaboration with, or under the supervision of an M.D. or D.O. or who is working pursuant to the referral by an M.D. or D.O. is required by our team to grant written clearance for the athlete to return to participation.

This form shall serve as verification that the physician or licensed medical professional has examined the student, has <u>performed a specific cardiac/heart</u> <u>risk evaluation</u>, or has referred the athlete for more definitive evaluation by a specialist. The physician or licensed medical professional must complete this form and submit to Team Administration/COVID Officer prior to the athlete's resumption of participation in practice and/or meets. **To reiterate, this sportsperson is not permitted to reenter practice or competition until cleared by a physician or licensed medical provider.**

Camera Zone: Per Florida Swimming Rule 223.12, Meet Management shall designate and inform the public of "Camera Zones" at each swim meet where both still photography and video photography of a race or a competitor in a race may be taken. Acceptable "Camera Zones" may include, but are not limited to the side courses of a pool, team gathering areas, concession area, turn-end of competition course when not in use as a "start-end." Etc. Meet Management shall also designate "Non-Camera Zones." Under NO circumstances will Camera Zones include the area immediately behind the starting blocks at each end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups, locker rooms, rest rooms, or any other dressing area. Coaches will maintain control over the entire warm-up period. Pace lanes, one-way start lanes, etc. will be decided upon by the teams assigned to the lanes. Autonomy is granted to the coaching staffs to use their assigned lanes as decided for all team members.

#### TEAM SEATING:

The lower pool deck of the aquatic facility will be used for all team seating. Florida Swimming and Florida Gold Coast coaches will work together to split the deck into appropriate sections for athlete seating. Teams will need to provide tents/shade for their teams members should it be wanted. The host facility, Indian River will provide tents when possible; however, the number of tents is VERY LIMITED.

#### **COMPETITION POOL AREA:**

The south side of the competition pool will be for coaches and officials only. Athletes MAY NOT be seated in the bleachers in this area. Athletes may ONLY come speak to coaches prior to or after a race in this portion of the deck area. At no time should there be a gathering of athletes on the south side of the competition pool.

# **COVID-19 FACILITY GUIDELINES**

# **Upon arrival at Indian River State College campus:**

- 1. If any athlete or staff member is symptomatic, he/she <u>SHOULD NOT</u> be permitted to travel.
- 2. Teams will enter the facility using the south gates of the complex.
- 3. Spectators will enter the facility for "viewing only" using the north gates of the complex.

# Upon entry into the Aquatic Complex

- 1. All teams may select their area on the lower pool deck for swimmers to remain when not competing. While in this area all athletes must wear masks and remain social distanced from other teams.
- 2. Locker rooms will be monitored by staff and/or volunteers to assure no congregation occurs. The locker room facility should be used for basic restroom needs, not showering. If teams need to change due to travel, the locker room will be available. Masks are required in the locker room at all times and all are required to practice social distancing.

# **During Warm-Up**

- 1. Only members of your respective teams should be in your assigned warm-up lanes.
- 2. Controlled warm-up will be at the discretion of the All-Star Coaching Staffs as outlined above in the meet information letter.

# **During Competition**

- 1. Fly-Over starts will be used during the competition to assist with social distancing.
- 2. A staging area will be set-up to assist with the flow and social distancing. Masks must we worn in the staging area until it is the swimmer's time to get on the starting block.
- 3. The current heat will be on the block, the heat next up will be on the top of the staircase while awaiting their turn and the final heat will be at the bottom of the staircase. Heat will advance forward as the meet progresses heat by heat.
- 4. Once the previous heat has exited the block area, the next heat will advance forward.

# Spectators:

Spectators will be allowed on the pool deck in designated areas for viewing races. Chairs and tents will not be allowed in the viewing areas and spectators are asked to practice social distancing. Any spectator on the deck during the competition must wear a mask. The entry gate at the north end of the pool will be open for spectator entry into the facility. Restrooms in the Science Center (N Building) will be available for use throughout the competition.

The pool deck has a limited number of bleachers in the spectator area under awnings. These benches may be used for spectator seating and are on a first come, first served basis. Management requests those seated in the area practice social distancing when on the bleachers. If an individual remains within the bleacher area, a mask covering both the nose and mouth is required at all times.
