Thank you to existing board members. All worked together during pandemic. Recognize some achievements with FGC: 15 athletes achieved Academic All-American, had 5 clubs recognized through Club Excellence (top ranking for athletes by times) in top 200. 4 of those got silver and 1 bronze: In order of ranking in SWMS: Saint Andrews, Eagle, Pine Crest, SOFL, and FLOOD. Had 3 FGC swimmers named to National Jr. team, all were at Olympic Trials past summer: Erika Pelaez with EA, Julia Podikoscielny-Pine Crest, Josh Zuchowski-FLOOD. Two swimmers did early acceptance to colleges: Julia at University of Florida and Josh at Stanford.

#### B. Admin Vice Chair: Alf Aguirre

A lot of the legislation is coming out of age group committee. Tech planning-working on building schedule for year. Thank the board and all FGC coaches for allowing to serve for the past 20 years. Will be taking a few years off from the board but will still be involved.

#### C. Senior Vice Chair: Chris Anderson

Work with technical planning and creating different changes to Senior meets. Works closely with FL swimming to create good meet information and promoting great competition to grow Senior swimming not only locally but within the state of Florida.

#### D. Age Group Vice Chair: Liz Kershaw

Presented attached report for changes to Championship meets in the next quad.

#### E. Coaches: Gordon Andrews

Ear between the Board of Directors and the coaches which has been a fun task. It is great to see the experience of those on the board and the different layers of involvement. Great to see the swimmers outside in the fresh air. Very balanced about getting them back in the water and reminding them of the greatness and fun of our great sport.

#### G. Secretary: Lori Bosco

Responsible for meeting minutes and helping with the awards-which for this year will be handed out at Winter Champs. Hope to be back with the Swimposium next year.

#### H. Officials: Steven Goldman

Thank you to the Officials committee for all their hard work this year. Uniform changed to navy blue bottoms. Thank you to Kathy Fish for getting weekly notice out for upcoming swim meets and making sure all officials are in compliance with MMAAP 2.0. Coverage of FHSAA state series continue to task our officials. LSC Championships continue to be officiated with nice numbers. This year had-31 clinics on all levels. Currently have 163 Stroke and Turn Officials, 79 Starters, 42 Referees, 9 Admin Ref, 49 AO's, 11 Open Water Referee and 14 Open Water Judges.

#### I. Finance: Kathleen Prindle

Spearheaded the biggest financial function for our LSC to create an emergency grant to help during COVID. We paved the way for other LSC's. We gave \$85,000.00 worth of funding to help teams. Overall, \$9 million dollars were giving to clubs around the USA through private donations and a partnership with USA swimming. Ensuring now that all clubs who received the money are meeting all requirements.

Keeping Athletes first initiative in which USA swimming is spending their money on. Sit \$5 million dollars allocated 2 years ago to help support our athletes, toward safe sport and getting that done. \$2 million dollars set aside to revamp coach education, upgrading technology platforms, and staff development.

#### J. D.E.I Chair: Rosemary Knoll

Resigned from the board. Jennifer Gibson: Thank you Rosemary for your service to the board. Already reached out to Leland Brown (DEI with USA swimming). In the next few months will be working on the framework of the "4 e's": Engage, Education, Empowerment, Elevation. Focus on-how to elevate across the sport and what we can use in the community for outreach marketing tools.

#### K. Operational Risk/Safe Sport: Mike Averett

Safe sport club recognition program allows a USA swimming member club to demonstrate an unwavering commitment to begin an abuse free and positive environment of all members through the minor athlete abuse program. Currently this program is voluntary at no cost and can be completed on the on-line club training portal on USA swimming. It is renewed every 2 years. October is bullying prevention month.

Thank you to the clubs who have done it and took the interest. October is bullying prevention month. Start a plan if you don't have one. The MMAP 2.0 update and all information is available on FGC site.

#### L. Meets: Allan Golding

Charged with both sanctioning and uploading times to SWIMS. Accept requests to observe and approved meets. For the calendar year 2021-date-sanctioned 92 meets in total-consisting of developmental meets, dual meets, open water, sizzlers and championship meets including one meet approved and 18 observed. All Districts and Regionals meets are being observed (FHSAA).

See attached report. 76,3699 times from SWIMS. 60 times were not loaded into swims because times were rejected as the athlete did not complete required trainings as those were 18 or older. Use the team portal to check the status of swimmers. If there are 18 and older athletes-make sure they get their APT courses or refresher or courses.

For 2022, had 60 meets bid. Thank you to Bruno Darzi and Christi Wathen to help review meets for sanction.

#### N. Athletes: Chloe Hernandez and Kyle Kasztner\*\*

AJ Martinez-talked to Ryan Gibbons who is the Southern Zone athlete rep about how to get LSC involved and becoming more involved this year.

Jennifer Gibson: It is all about swimmers being able to learn to take the lead, the opportunity to be heard and to learn. Also, making sure information being disbursed is at all levels especially among peer athletes and helping them being self- aware of their commitment level and learning how to work within the system to make it better for all of them. Looking forward to our athletes to have this experience and for them to be seen on the deck as an opportunity to include the other athletes.

# Age Group Report for HOD 10/2021

#### **BB Champs Format changes and clarifications**

#### Relays

No relays will be offered

#### Formatting

- Bonus events
  - Swimmers entered with 1 BB time may enter 2 bonus events using the B time standard
  - Swimmers entered with 2 BB times may enter 1 bonus event using the B time standard
  - Swimmers entered with 3 or more BB times will not be allowed to enter bonus events.
- Timed final events
  - 13-14 200's of stroke stay timed final events in the morning
- Maximum number of events per individual swimmer
  - Spring and summer 7
- Open age group Time Trial only events TT count toward the swimmer's daily limit but not the meet limit.
  - o 100 IM for 13-14.
  - o 50s of stroke for 13-14 can be done in time trials only.
  - 200's of stroke for 11-12

#### Modifications to finals

- 10 and under will be timed finals only in the prelims session.
- 13-14 400 IM AND 400/500 free are timed final events for both seasons on Friday
- 11-12 400/500 free is a timed final event on Friday both seasons

#### Age Group (JO) Champs

Time standards - use Summer 2021 for all of 2022. Then updated the time standards every 2 years. The next update to JO time standards will be after LC 2022 going into SC 2023.

#### Relays

- Add relay only swimmers to the meet
- 13-14 relays offered at JO's 200 free and medley, 400 free and medley
- 11-12 relays offered at JO's 200 free and medley, 400 free and medley
- 10 and under relays offered 200 free and medley
- B relays will be allowed and scored if:

- o Finish in the top 10 in the spring
- Finish in the top 8 in the summer
- Spring (March) Relays in finals with the exception of Sunday. Sunday will be at the end of prelims
- Summer (July) All relays in prelims due to weather potential.

#### Formatting

- Maximum number of events per individual swimmer
  - Spring (March) 7
  - o Summer (July) 6
- Offer a B final for 11-12 and 13-14 events that are 200 and shorter. The B final will not be scored.
- 10 and unders will race in as P/F and an A final only will compete at night.
- 13-14 400 IM AND 400/500 free are P/F events for both seasons. A final only will compete at night.
- The following events are timed final: 11-14 1650/1500, 10U and the 11-12 400/500 free.
- Timed final events
  - o Spring (March) Fastest one heat swim at night in finals
  - Summer (July) Swim in prelims due to potential weather.
- Open age group Time Trial only events TT count toward the swimmer's daily limit but not the meet limit.
  - o 100 IM for 13-14.
  - o 13-14 age group 4 x 200 free relay will be offered one day only
  - o 50s of stroke for 13-14
  - o 200's of stroke for 11-12

#### **USA Swimming Safe Sport Club Recognition Program**

<u>Description</u>: USA Swimming member clubs consistently embrace Safe Sport abuse prevention measures and educational resources. The Safe Sport Club Recognition Program ("SSRP") allows a USA Swimming member club to demonstrate its unwavering commitment to creating an abuse-free, safe, healthy and positive environment for all its members through the implementation of the Minor Athlete Abuse Prevention Policy, Anti-Bullying measures, Safe Sport Best Practices and Athlete Protection Training.

Using a web-based tool, member clubs can achieve SSRP status by detailing club procedures, uploading policies and verifying education and training efforts. SSRP club designation is valid for a two-year period and is eligible to re-apply for recognition once the validation period has ended. SSRP clubs will earn a badge to display on the club website and will be designated as a Safe Sport Club Recognized program on the USA Swimming Find A Team online search tool.

#### Facts:

- Voluntary, no-cost program available to all USA Swimming member clubs.
- Completed online via the Club Portal at <u>www.usaswimming.org/ssrp</u>.
- Renewed every two years.
- Earns Safe Sport Club Recognition designation.
- To implement Safe Sport, a team must focus on its policies, procedures, and education engagement to engage in best practices which safeguard against abuse. Contains both required and elective criteria in 30 areas including:
  - o Business/Organizational Success
  - o Parent/Volunteer Empowerment
  - o Coach Education and Development
  - o Athlete Education and Development
- Demonstrates a club's commitment to providing an abuse-free environment for all participants including coaches, athletes, parents, and volunteers.

#### **Frequently Asked Questions**

Q: What is the process for receiving Safe Sport Club Recognition?

A: The club admin will log into the club portal and complete the point requirement criteria for Safe Sport Club Recognition. This includes all the required measures as well as a selection of elective measures. NOTE: If you need assistance in accessing your club portal please reference the guide at <a href="www.usaswimming.org/ssrp">www.usaswimming.org/ssrp</a> or email USA Swimming Safe Sport at <a href="ssrp@usaswimming.org">ssrp@usaswimming.org</a>. After the club admin submits the form online, it will be reviewed by Safe Sport staff. This can take up to three weeks. Staff will either approve the recognition or send it back with notes for improvement. Once the recognition is approved, the club and LSC will receive notification and a logo to display on their website. Within 24 hours of approval, the Find A Team tool will begin showing the club status as a Safe Sport Club Recognized Program.

Q: Is there a performance component to the Safe Sport Club Recognition Program?

A: No. Times and IMX scores are not a factor for the Safe Sport Club Recognition Program. Clubs serving all levels of athletes are eligible to pursue this recognition.

Q: How is the training component measured?

A: This is an automatic process based on how many individuals completed the "Safe Sport for Athletes" (Ages 12 and over) and "Parent's Guide to Misconduct in Sport" courses on LEARN. Clubs can earn more points for having a larger proportion of their club complete these courses. The proportion is based on the number of registered households within a club, and at least 10% participation is required to receive points.

Q: Can we do trainings in groups?

A: Yes! In fact, this will make completing the online education component easier to fulfil. You can complete the athlete or parent training as a big group, in person or via Zoom, following MAAPP guidelines. In order to receive credit, you must take attendance by including the date, names of those in attendance, and the team name. Then, send it to USA Swimming at <a href="mailto:ssrp@usaswimming.org">ssrp@usaswimming.org</a> and we will manually update the points for the online education measure if you have reached a minimum of 10% participation. In addition, USA Swimming offers monthly trainings via Zoom. For all training options please go <a href="mailto:here">here</a>.

NOTE: Points are manually adjusted on the backend only, you will not see the number of participants adjusted in the club portal.

Q: Do I have to do it all at once?

A: No, it is possible to start Safe Sport Club Recognition process and come back to it at any time via the club portal.

Q: Does becoming a Safe Sport Recognized Club mean that we will never have instances of misconduct?

**A:** Unfortunately, no. However, having Safe Sport Club Recognition prepares you to mitigate risk and respond to any inappropriate behavior or misconduct. By creating a structure through policies, guidelines, and procedures—and training the coaches, athletes, and parent/volunteers on Safe Sport—you've created a shared commitment to create a safe, healthy, and positive environment free from abuse for all participants.

Q: Does becoming a Safe Sport Recognized club mean that I don't need to talk about Safe Sport or do other Safe Sport education anymore?

A: No! Becoming SSRP means the club has taken proactive steps to create a culture of Safe Sport within the club. You should regularly continue to talk about Safe Sport, engage athletes in discussion, review Minor Athlete Abuse Prevention and Anti-Bullying policies and refer to best practices when issues arise.




- Q: What happens if misconduct occurs at a Safe Sport Club Recognized team?
- **A:** Clubs will rely on their team policies to manage minor misconduct and team policy violations. If a more serious report of misconduct occurs, clubs need to report to the appropriate jurisdictions.
- Q: I noticed athlete and parent education numbers have changed in the application, why is that happening?
- A: Parents take the "Parent's Guide to Misconduct in Sport" and athletes (ages 12+) take the "Safe Sport for Athletes" course to meet the online education requirement. These courses will expire after 18 months from their learn dashboard. When the course expires for individuals it will also disappear from the team's online education numbers. Parents and athletes will need to take these courses again when you are planning to renew your Safe Sport Club Recognition status.
- Q: It's time for my club to renew their Safe Sport Club Recognition, why is my application blank?
- **A:** 60 days prior to renewal all previous documents uploaded, and information previously submitted will be wiped clean from the system.
- Q: Can anyone be a club Safe Sport Coordinator for our team?
- A: We strongly recommend your club Safe Sport Coordinator be somebody other than a coach. It is best served by someone from your team who has professional experience in the topic of Safe Sport like a law enforcement officer, social worker, or therapist. We understand not every team has this option though. It is important to note, people, especially kids, often feel more comfortable bringing concerns to the team if the person filling that role is not the coach.
- Q: What if a college program which has no minors and no parent involvement would like to achieve Safe Sport Club Recognition? How would the athlete and parent education requirements be met?
- A: Clubs who do not have minors associated with their team and thus no parent involvement would have their athlete adult members take the "Safe Sport for Adult Athletes" course to meet the education requirement for athletes. Same percentages apply. The parent education in this instance would be waived with 1 point and the team would need to make up that point in another area.
- Q: The points on my application changed (up or down) why did that happen?
- **A:** There are a few reasons this can happen:
  - Athletes or parents have taken the online education adding to your points.
  - An athlete switched teams and their online education now counts toward another team.
  - The measure you marked as complete and documents uploaded did not meet the specific requirements and was unchecked by the Safe Sport reviewer.
- Q: We have athletes and parents who are already non-athlete members of USA Swimming and have taken the Athlete Protection Training. Do they have to still take the Safe Sport for Athletes or Parent's Guide to Misconduct in Sport course to get points for our team?
- A: Yes. Athlete Protection Training is required for all adult members. The training requirement for teams to achieve Safe Sport Club Recognition is specifically designed for athletes/parents and shows the team's commitment to go above and beyond what is required for membership.
- Q: Our team does not have its own website. We have either a social media page or a designated page as part of our larger organization. Would this be acceptable for recognition?
- **A:** Yes. As long as the club page is public and can display the same information, which is required for the website quidelines, this would be acceptable.



- Q: Can the parent consent forms for MAAPP cover a season, especially local transportation?
- A: No, these permission forms are for specific instances of exceptions and cannot be a blanket permission.
- Q: Are there exceptions to the USA Swimming Corporate Bylaw requirement that all members of the Board of Directors of a member club must become individual USA Swimming Members? Doesn't this requirement of membership only apply to an Executive Member of the BOD?
- A: No, the bylaw change requires that the entire Board of a member club become non-athlete members of USA Swimming. Should a club apply the rule differently based on state or local laws, the club should be able to explain their decision. See Article
- Q: How can I find out how many parents and athletes have taken the training though LEARN? Can I get a roster of who has taken the courses?
- A: In your club portal you can see how many people have taken the trainings and how many points your team has, but you do not get a list of the specific individuals that have completed the training. Those who do complete the training through LEARN do see a completion certificate that they could take pictures of or print off and send to you.

Q: Club Portal Login Issues: Sometimes I get a blank screen sometimes I will get to the actual portal page but the box for the password is missing. Sometimes everything works.

A: This occasionally happens when one part of the site thinks you are still logged in and another part does not. Please try clearing your internet browser cookies and temporary internet files (cache). You will need to select "all time" or "all history" when clearing the cookies to make sure they all get cleared.

Then close all browser windows.

Then log back in and see if the problem is resolved.

You could also try another browser if that is easier.

- Q: How do I display the Safe Sport Club Recognition badge that I received after my team was approved on my Team Unify webpage?

#### **2021 SSRP Trainings**

Safe Sport is committed to creating a healthy environment that is free from abuse for all members. As we continue with virtual learning opportunities throughout 2021, we will be increasing security measures to keep parents, athletes and coaches safe during trainings. **All trainings will require individuals to register ahead of time**.

In addition, we have enhanced our Safe Sport Trainings' security measures and will have the following in place:

- Meetings will be locked
- Athlete attendees will only have access to chat with hosts
- Multiple USA Swimming Safe Sport staff will be on all trainings and will monitor participant video share
- Frequent check-ins with attendees
- Screen share and annotation capabilities will be disabled
- Meetings will require registration and athlete training registrations will be cross-checked with USA Swimming member records
- USA Swimming has enabled the At-Risk Meeting Notifier tool from Zoom. This tool
  searches the public internet for Zoom meeting information and checks the meeting's
  security settings. Zoom notifies USA Swimming if a meeting appears to be at high risk
  for being disrupted. This tool is enabled for all USA Swimming hosted Zoom meetings.

#### Membership Extension from 9/1/21 to 1/1/22

On July 15, 2021, you received a communication announcing all employees and individuals serving on the board of directors of USA Swimming Zones, Local Swimming Committees (LSCs) and member clubs must be non-athlete members of USA Swimming. Since then, we have received numerous inquiries about how this requirement applies to institutionally-owned clubs. USA Swimming has been working with the U.S. Center for SafeSport in an attempt to b able to provide guidance to institutionally-owned clubs. To date, we continue this effort but do not have full guidance to provide.

As a result, USA Swimming is <u>extending the implementation date of this requirement to January 1, 2022</u>. We anticipate being able to provide full guidance to clubs, LSCs and members in advance of this new deadline. Please look forward to receiving further communications from USA Swimming on this matter.

Please note, all individuals who have direct and frequent contact with, or who have authority over, athletes are required to be non-athlete members of USA Swimming. For any questions c concerns, please contact safesport@usaswimming.org.
