**Recap From Zone Directors Council Meeting**

This is a short recap from our Zone Directors Council meeting today. The items are in order discussed, not the importance.

- The September Western Zone Open Water meet hasn't been cancelled, but has had it's funding pulled by USAS, so we're expecting it to be cancelled soon.

- If any coaches are approaching the expiration of their certificates, they need to finish all their online requirements, then contact their LSC person who can conduct small groups of them through ZOOM at their pool for the in-water portions. Joel Shinofield of USAS has more info (jshinofield@usaswimming.org).

- Bob Vincent spoke about some upcoming board votes. Within a day or so, the Board will vote on August sanctions. They are leaning towards allowing LSCs to shoulder more responsibilities, but everyone HAS to comply with local, state and federal guidelines. The other item was any meet that has enough officials and a valid timing system will have their times count.

- Any athlete on a National committee that is approaching their two year limit on competition may see some relief since USAS has queried USOPC.

- LSCs have the responsibility to say NO to any sanction where a host is not complying with local, state and federal guidelines. Also, if a host is complying and a meet is scheduled, probably not the smartest thing to brag on social media about it. There is at least one LSC who had a governor call and shut them down.

- Patrick Murphy of USAS gave an excellent talk on virtual meets and how they will work. Approximate 140 hours of computing effort has gone into the program and it should be released around the 27th of the month.

- Any virtual meet will not count against the FLEX swimmers' limits. In the future, they hope to have the program mature enough so you'll be able to virtually form a team and swim against another virtual team. But right now, just established clubs.

- From me – the Convention page is up on the USA Swimming website and has the legislative package. I recommend everyone reading through the different proposals.

- Abby Howard had been working on voting during Convention but she's going on maternity leave so Mike Unger is taking over. We still don't have specifics and we're clicking down to Convention.

- For the Southern Zone, we may have our virtual meeting during Convention week, but more likely a week before or after. More to come as soon as we know something. Anyone wishing to host one of our Zone Championship meets should be working on their package now and sending it in to Herb NLT 15 August. Currently there are three positions up for election – Zone Director, Non Coach, Zone Secretary/Treasurer and the Zone Age Group Chair. The Zone athletes have their two positions – Senior & Junior – to fill from the Zone Athletes Committee.

As all of you are aware, these have been extraordinary times requiring the best from all of us. We are seeing a few setbacks, but we'll handle them just like we've handled everything to date. USA Swimming has been hard hit with Gina's death and the retirement of a number of staff members, but the ones remaining are doing excellent jobs. We all need to have patience while we get through this.

The last item I want to bring up are KUDUs to our Zone athletes for their excellent Zone workshop on Saturday. They put in a ton of work to make it happen. And while Annie Norris and Ryan Gibbons were leading, there were many other LSC athlete reps who stepped forward and provided much needed support. Some of you attended the workshop but I wish you all could have.

2. Introduce myself to the athlete committee and join their next meeting. Let them know that DEI is here for them and also get their feedback on what they would like to see as well in terms of representation for DEI and discuss how they would like to move forward with the Athletes for Change movement and racial injustice (sent email 7/24, been emailing Chloe Hernandez)

3. Create DEI page for FGC website

4. Create a DEI quarterly email/e-newsletter introducing myself and DEI to the LSC coaches. This will include DEI importance and videos/resources that coaches can share with their swimmers and families. (e-newsletter will be sent on Monday 8/3 to all LSC)

5. Create SWIMPOSIUM DEI clinic (if SWIMPOSIUM is virtual, contribute speaker and have a swimmer who previously attended the DEI Camp and Submit speak on their experience to coaches and athletes to encourage more athletes to apply for the camp (since only one swimmer went last year from our LSC))

6. Educate the clubs about the importance of encouraging their swimmers to check the box for the upcoming 2021 registration. This can lead to a diversity increase as well. (Will include this in the e-newsletter)

7.) Ensure all Gender Diversity guidelines for clubs, coaches, and officials have been individually sent to EACH CLUB, and also posted on website if you want (will email on 8/3 with newsletter)

1. Three meets have been sanctioned to date for the months of July and August.

#### 2. Sanctioning Process

The sanctioning process remains largely the same as before, however the USA Swimming Crawl/Walk/Race return to competition plan adds the following restrictions and requirements:

A) All clubs and athletes must be registered in Florida Gold Coast Swimming.

B) The meet must be pre-seeded and deck entries are prohibited.

C) Two additional risk disclaimers must be included in the meet announcement.

D) The meet announcement must be submitted to the Sanctions Coordinator along with a supplemental document that includes:

- i. A statement of local protocols and requirements.
- ii. Plan for spectator ingress and egress.
- iii. Planned number of individuals in the pool, on deck etc.
- iv. Safe Sport considerations to ensure parents have access to and/or opportunity to observe their child.
- v. An attestation that the meet will comply with state / county / local / facility guidelines.

- Using USA Swimming's Meet Simulator tool, coaches, athletes, and parents will be able to simulate a meet between any USA Swimming clubs across the country. As long as the meet has been loaded into the USA Swimming SWIMS database, it will show up in the Simulator. • The simulator will include all Sanctioned and
- Non-sanctioned meets
- The first step is to select a date range from which meets will populate.

- Sanctioned Meet Protocol does not change
- Times should be sent to your LSC Times Officer in an uploadable file format (.sd3 (Hytek, SwimTopia Meet Maestro), .cl2 (Team-Unify, Swimmingly, HyTek), .lef (Omega), .xml).
- Times count towards all USA Swimming meet entry and recognition program purposes.
- Time Standards and PowerPoints will be assigned to these times.
- Times will show up in all USA Swimming times searches.

- A Sanctioned Virtual meet counts towards a Flex member's two meet limit.
- All Clubs must be USA Swimming clubs
- All Athletes must be USA Swimming members and must be APT compliant. LSC's will be responsible for Meet Recon, following normal Sanctioned Meet Protocol.
- Sanctioned meets can be combined into a singular meet file using other software like Team-Unify Touch Pad, HyTek, Swimmingly, SwimTopia Meet Maestro, Swim Connection etc.

- Times should be sent to virtualmeets@usaswimming.org in one of the following uploadable file format (.sd3 (Hytek, SwimTopia Meet Maestro), .cl2 (Team-Unify, Swimmingly, Hytek), .lef (Omega), .xml).
- Times DO NOT count towards all USA Swimming meet entry and recognition program purposes.
- Time Standards and PowerPoints will not be assigned to these times.

- Times will show up in separate Non-Sanctioned meet search (both an individual search and a top times leaderboard search)
- A Non-Sanctioned Virtual meet DOES NOT count towards a Flex member's two meet limit.
- All Clubs must be USA Swimming clubs
- All Athletes must be USA Swimming members and must be APT compliant. Any non-compliant athletes will not be loaded into the the SWIMS database.
- Then select the LSC(s) from which you want to compare clubs.
- Next, select the specific clubs you want to compare and which meets you want their times pulled from. The Simulator will populate all meets from which the selected clubs have participated.
- After selecting age groups and events, the simulator will simulate a meet between the selection of teams.
- If the user selects multiple meets and multiple teams, the simulator will take the best time from each athletes across the meets selected.
- Meets are scored for the top 8 in each age group and event using the following points system: (1st: 9 points, 2nd: 7 points, 3rd: 6 points, 4th: 5 points, 5th: 4 points, 6th: 3 points, 7th: 2 points, 8th: 1 point). Relay events will receive double points.
- The end user will have the ability to print the results to a pdf file.
