Meeting was called to order at 7:00 p.m. by Jim Holcomb.

The Athlete Representatives gave their Minutes of their 4th meeting. (See attached.) They gave suggested changes to the Bylaws concerning them. (See attached.) (The suggested change is athlete representatives to the Board may be 15 years old, and freshman in high school rather than 16 years old and sophomores in high school, for a term of one year.) The Bylaws changes will be reviewed to be discussed at the next Board meeting. Clarification was made about age for Border Swimming scholarships.

Cindy Crane gave the :financial report.

Our LEAP Level 1 checklist is due by May I, 2019. We need to check our Bylaws revision.

Andrea Schiechl told us the City of El Paso is amenable to having pool records posted at the Westside Natatorium. Question was raised if it is SC, LC, High School, City public and private league records? We will look at Swimpride.com and other sites about signs for this.

Our LSC governance meeting for Stage 2 workshop will be on Saturday, June I, 2019.

Cindy reported that all coaches of Border Swimming must have water skills check l is t in place. This must be administered by a life guard instructor. Andrea will check if the Ci ty's lifeguards can do this outside the City's lic ense/agreement with the Red Cross.

Manny Gardea , Jim Van Atta, and Gus Viveros gave the report about Zones Team criteria and requested budget for the meet in Cary, NC. They suggest 48 athletes to attend (if quali fied) , and Border Swimming to provide an annual budget of \$17,500. Jim Holcomb raised the iss ue if we want to allocate 35% of our annual budget to a single event/meet. Gus says this is worthwhile event that benefits swimmers and coaches. Jim Van Atta stated an athlete must strive hard to achieve AA times to make the Zones team. Juan Corral stated he thinks an athlete should have at least 3 AA times to be on the Zones team. Todd Roberts asked if the other 65% of our budget will be used for our swimmers. Michele Key stated she thinks going to Zones meets helps our swimmers improve. Discussion was had that \$17,500 is \$365 per swimmer. Motion was approved for Border Swimming to spend \$365 per swimmer this year on the Zones teams. Manny Gardea has the document that shows the team criteria: if an ath lete won an event at SC Border Champs or hit AA time, they are qualified for the Zones Team. Athletes have until Memorial Day to apply to be on the Zones Team.

Michele Key gave the SafeSport report that all teams with Border Swimming must have policies in place for Trave I, addressing Bullying , and Discipl.ine. USA Swimming has templates as examples .

Andrea said the City will be enforcing the \$3 sp ctator fee. Adrian Slater made a motion to suspend the \$3 fee until the Interlocal Agreement between EPISD and the City of El Paso is in place. Adrian listed the City 's charges to Border: \$3 specta tor fee every day of every meet, \$1 per hour per lane increase for lane renta l, full price charge for Pool rental during SC season at the Westside Natatorium. Yet, the City will not allow inside concession sales, it reduced the lanes available during LC season, has arranged lanes away from Border teams this summer when the City has Fitter Faster event on June 1-2 and durin g summer league championship meets. Border Swimming helped get the Natatorium accomplished at all. Border Swimming provides the life guard candidates, and the officials and referees at the City meets. He feels that the City is chipping away at the good spirit between Border Swimming and the City. We should speak to our City representatives and Mayor Mar go about this spectator fee. John Bernhard, Jim Holcomb, and Ruben Pallares are the designated to speak to the City about this. Jim Holcomb is concerned the City will price us out of the ma rket; he will write a letter to protest the \$3 spectator fee.

Cindy reminded us that all members of the Board of Directors must take the I-hour leadership course from USA Swimming. She will send the email for that.

Meeting adjourned at 8:38 p.m. Next meeting is May 8, 2019.
