# **Margaret Dugan – Technical Planning:**

**SC Championship Meets:** The 12&U and 13&O KYLSC Championship Meet announcements were emailed to all board members. The meet information was edited with following taken under consideration: creating uniform language between the two meets and removing redundant information.

**12&U:** 11 lanes will be used for prelims, with top 16 swimmers returning for finals.

**13&O:** Avery will send Margaret updated facility information and map.

Fine for missing a final on Sunday in SC and LC champ meets: For Sunday finals, clubs will be fined \$25 for 12&U and \$50 for 13&O for any athlete/s that misses any individual and/or relay events.

12&U Age Group - 500 Free

Commitment deadline - Wednesday after the SC championship to commit.

If any spots are open, the process will continue through 8<sup>th</sup> place as long as the time does not fall below a AAA time.

#### State B Meet:

Lake Cumberland Swim Team coach, Tassos Madonis, requested approval to host a 10&U "B" championship meet March, 19. LCST will be responsible for all awards and expenses. Scott Gainey expressed his interest in Regional B meets. Mike explained the history of the B meets moving from ribbons to high point trophies and expressed his hesitation for the LSC to commit resources again. As a coach, he is also worried that the top B swimmers will settle for that place instead of trying to move toward the state meet and beyond. Scott wants to reach out to host clubs in his region that have meets schedule before the champ meet. He would like to see meets progress from a lower level to higher level. He will report back to the board.
