## Coaches Report: Amy Albiero

- S Zones: Lindsey Pfoff (CKTS head coach) will be the 2015 S Zone head coach. Amy will also reach out to Gord Veldman (LAK) as an assistant.
- MidState AllStars: The team didn't do as well as in the past missing some key athletes as well as
  illness at the meet. There was no Friday night team dinner but had a meeting with games. The change
  saved money and will plan to do the same for 2016.
- Coach Selection for Zones and AllStar Teams: Amy recommended a change/addition in coach assignment for the select teams. She suggested an application process in lieu or in addition to the current procedure in the handbook (Age-Group Coach of the Year, AllStars & Senior Coach of the Year and Zones). The board agreed that if either coach of the year declines the head coach position, the coach body at the HOD fall meeting will have applicants to select from. An application and procedure for request and submission will be created and presented to the board.
