Board of Directors Meeting Minutes September 9, 2012 Blairwood Tennis Swim and Fitness Club Louisville, Kentucky

The meeting called to order 3:04 pm

Approve Minutes: Minutes read/motion to approve/minutes approved with the following change: Under New Business, bullet number four – change "As general chairman, Ben Davis will appoint an individual to complete Julie's term." to "No action taken at that time," and add Bill Precious to those attending.

Executive Secretary Report: no report

Long Course Championship Meet Info Changes:

The Championship Rules in Kentucky Swimming state that the host team needs to provide 50% of the timers. This is not listed in the meet information as I guess it's been assumed all teams know this. It needs to be added to the timer section for all 3 meets.

There should also be mention that the meet committee will be established at the start of the meet. The meet committee is comprised of the meet director, meet referee, coach, and athlete. I am checking on this, but I assume the meet referee will choose the coach and athlete. If someone knows that for sure, please include that in the minutes. I also notice that there is an item titled 'meet merge' under the championship subheading. If we are not wanting to merge the meet any longer for scoring, then we will have separate sanction numbers and the 'qualifying period' listed below would no longer be of concern.

13 & Over

Qualifying period needs to be changed so that it is the same as the 12 & Under meet. Currently the 12 & U meet qualifying period begins on the first day of the prior year's Sectional meet up until the final deadline for entries (the Monday prior to the meet). I believe this deadline works fine for both. In discussing this with USA swimming, there are multiple issues that can come up with different dates and I was told that the dates should be the same.

The way of entering times for the 'bonus' (1500/800) event needs to be specified. The easiest is to enter with an NT as that marks it for time verification, however, our meet information states no 'NT' entries. If we are not going to use NT for these, then it will be specified to enter at the non-conforming SCY time. This ensures the swimmer is seeded at the end.

All relays need to be moved to the final session.

<u>Long Course Championship Survey Questions</u> based on comments/complaints/suggestions given to me at the meet or via email. Please include any other questions that the board feels would be helpful to the technical planning committee.

- 1. Do you prefer two championships?
 - a. If so, do you prefer both inside? Both outside?
- 2. Should the age of the athletes be limited? If so, how would you like to see this adjusted:
 - a. Should there be restrictions on college-age athletes
 - b. Should there be different age group categories
 - c. Should there be a criteria for college athletes (i.e. they must have competed in at least 2 meets held within the LSC over a 6 month period or must have competed with their registered team the year before)
 - d. Should there be no limitation on preliminary heats but restrictions on final heats

SCY Time Standards

Based on information I received from Bucky and some of the coaches, my recommendation is as follows:

- 1. Determine the time standard based on 5 heats for all events.
- 2. If this time is not faster than last year, the time standard will be reduced by 1% which is .6 sec. per 100. We will look at doing this each year over the next 4 years.
- 3. Relay time standards are currently set by the KYLSC Championship rules book. Obviously, there are no 200 medley relay time standards based on this method of standard setting. There was discussion to allow each team to enter 2 relays with no time standards. Please let me know what the board determines to do and what relays those rules will apply.

- Board Member Duties: A chart of responsibilities and duties was distributed, discussed and signed by present board members.
- Convention: Ben discussed USAS National Convention issues conflict of interest regarding coaches' roles as officials at meets.
- Championship Meets: Nate Knopf, Program Development, will produce an outline of procedure for running the championship meets.
- Observed Meet Approval: The board discussed the type of meets that would be approved. Maureen will research the national standard.
- Board of Review: Charging a fee for filing with the Board of Review was discussed. Maureen will research and report back.
