Agenda: Kevin Ryan motioned to add a State B Championship item to the agenda/Kris Humphries seconded/approved Kevin Ryan motioned/Colin Faris seconded/approved agenda with addition of the approved item.

Championship Meet Bid Process: Program Development and Technical Planning will meet, review current procedure and report back to the board.

Items of discussion:

- · A poll to coaches as to what their preferences are was suggested.
- Board of directors having total control versus the house approving the boards host club/venue selection was.
- The process is good as is but need to add a back-up plan for exigent circumstances that disrupt the championship meet cycle.

2022 Long Course Schedule: The were limited meet bids submitted. Several clubs are planning on hosting meets but have not set dates. Any late sanction requests will be accepted with no penalty.

Open Water: Kevin Ryan is discussing meet venue in Lexington. He is developing a committee. Items to discuss will be date and event format. Joseph also has an optional venue at Lake Cumberland. Paducah Swim Team may sanction an open water event in 2022.

Committee Reports:

- · Athletes: Katie Bridwell is planning a meeting during Christmas break
- Officials: Becky Gilpatrick reported that 98 officials recertified and 14 new certifications with a projection of 200 plus by the end of the certification process.
- · Program Development: Putting championship meet packets together

State B Championship: Several coaches have reached out to Kevin asking for some type of State B meet with possibly a prelim/finals format. They want something to highlight those athletes a little more. It could be added as part of the championship meet bid with maybe even adding it on the same day as the state championship. Amy responded that there has been a history of B meets. It was also a time when the 12&U and 13&O were on the same day which made for an open weekend. The board voted that rather than the LSC be responsible for that meet, it was left up to any club that wanted to host that type of meet could. Scheduling is difficult. Amy is considering having a B meet between sessions with Cardinal's 13&O Championship to offset facility rental fee. It is open for other teams to be creative and have an opportunity to make some money.

Brian Johnson thought that a late summer short course meet when non-year-round swimmers could compete would be a great recruitment tool.
