KYLSC Board of Directors Meeting February 28, 2024 Conference Call

PURPOSE - MISSION

The objectives and primary purpose of Kentucky Swimming shall be the education, instruction, and training of individuals to develop and improve their capabilities in the sport of swimming.

VISION

To provide a safe and healthy environment, encompassing all backgrounds and abilities that create a tradition of excellence in the sport of swimming.

Joesph Phillips, General Chair, called the meeting to order at 7:38 (EST)

Jason Brown motioned/Kevin Ryan seconded agenda approved as presented.

Jason Brown motioned/Kris Humphries seconded, January 17, 2024, board meeting minutes approved as presented.

Finance Report: JJ Rodgers presented the profit and loss to date. There is a concern that 2023-2024 registrations will be about 15% under what was budgeted. Splash and surcharge fees will exceed what was budgeted.

Long Course Schedule: There are nine swim meets on the schedule. The schedule has been posted on the website along with the SZ OW championship meet and the KYLSC OW championship.

Short Course Championship: Nick Graves asked if the heaters at Blairwood pool have been fixed. Jason Brown assured the board that the heaters were fixed, and the pool temperature was 80 degrees.

S Zone Open Water Championship: The meet information is out. Kevin is hoping that with the meet being in Kentucky, the roster will fill.

S Zone Athlete Summit & Olympic Watch Party: Ruth Ann Bode recommended, Hannah Andrews supported, that the Executive Athlete Committee representatives be invited to the watch party. If there are any open spots, the club representatives will be invited. The board of directors agreed.

S Zone Age Group Championship: Decisions to be made for the age group championship. The athlete fee is estimated to be \$2,000.

- Team vs. parent travel
- Team selection: Earlier deadline using short course times vs. middle of June.
- Minimum number to apply what is that number?

Thought – If we can't take our best team, is it worth the investment?

What are other LSCs doing?

If the board is considering not going, the coaches should be surveyed.

Alternate ideas: Plan an event for the same weekend with other LSCs.

Use the Zone funds to take 13-14-year-olds to the SZ Senior meet.

Officials Certification - R9: Jason Brown received guidance from the National Committee.

Major changes:

- Moving from a one-year to a three-year recertification process.
 - Renew USAS membership annually
 - APT Training annually
 - Background screening every two years
- Stroke and Turn, AO, Chief Judge must work eight sessions in at least two swim meets within the three-year recertification period.
- Meet Referees must work 16 sessions in at least two swim meets within the three-year period with at least eight of the sessions worked being at the referee position.
- All clinics will move to a national online virtual training. LSC clinics will not qualify for certification with the exception of CJ.

- Eliminated the Administrative Referee position.
- Referee certification requires an AO certification first. Certified referees will be grandfathered in.
- USAS observed swim meets will not count towards session requirements.
- Open Water certification is not affected by the new USAS policies.

Club Athlete Representatives: 18 letters were sent to parents with an athlete representative description and communication consent form. Nine club representatives returned the consent forms. Mega Zerhusen noted that the letter was sent during high school semi-state and recommended sending a reminder.

KYLSC Sponsor: Kevin Ryan suggested that Kentucky Swimming renegotiate the sponsorship contract with Swimville. Currently, the LSC receives \$6,000 from Swimville USA. Kevin felt that what Swimville contributes is disproportionate to what they charge for state meet shirts. With Kentucky Swimming having difficulty funding special teams, and Swimville making money off the athletes at the state meets, they should be supporting the athletes more than they do.

A committee will review the current contract, make suggestions and look at alternate sponsors.

Coaches Representative: Kevin Ryan plans to reopen discussion with the LSC coaches in regard to the short course championship meet schedule to accommodate the high school schedule.

Diversity, Equity, and Inclusion: Helen Glish report attached.

Records: Kris Humphries reported for 2023, there were 16 new boys and 15 new girls records. For 2024, four new boys records have already been broken.

Old Business: Joseph Phillips reached out to Sarah Bridenbaugh, the KHSAA Swimming and Diving Commissioner, and offered the commissioner a non-voting at-large KYLSC Board of Directors position. She has not responded.

Next Meeting: March 23 at the UofL Ralph Wright Natatorium between sessions.

Introduction & Orientation to Para Swimming (Virtual Session)

This workshop presentation is designed to provide an introduction and orientation to the para-swimming arena in the USA. It's designed for swimmers with a disability, coaches, parents and anyone interested in the para-swimming community and how to support swimmers with a disability.

In this session, participants can expect to:

- Discover the roles of the USOPC and U.S. Paralympics Swimming
- Identify the swimming sport classifications, rules, and exceptions
- Understand how to prepare for a positive classification experience
- Examine the levels of the Para Swimmer Development Model (PSDM) to supplement the USA Swimming American Development Model (ADM)
- Compare the potential competition progression associated with the PSDM
- Discover basic sport class training considerations for para-swimmers
- Watch basic biomechanical modifications/adaptations video clips for athletes with physical, visual and/or intellectual disabilities
- Identify basic support for a para-swimmer in training and competition
- Discuss options for coaches and swimmers with a disability to become a part of the para-swimming community
