Kentucky State Reporting Requirements Presentation

Jim Capillo – Kentucky Swimming certified official, consultant on criminal/security issues and first person assigned solely to the division of the prosecutor of juvenile court.

Jim presented information regarding state reporting requirements for abuse against a minor

- What to report
- To Whom to report
- When to report
- Why you report
- If you have suspicion, you are required to report

Safe Sport - Kris Humphries

The Safe Sport initiative mission is, "How to keep kids safe". The new Minor Athlete Abuse Prevention Policy was not established by USA Swimming rather it was created by US Center of Safe Sport. It's a congressional act.

- USA Swimming has made mandatory reporting for sexual misconduct available in several ways: online and phone with reporting being anonymous.
- MAAPP applies to all non-athlete members and athletes 18 years or older
- An applicable adult must interact with swimmers in an observable and interruptible location
- An applicable adult is someone serving a role as an authorized adult who has power over the athlete
- Kris recommended that all clubs participate in and complete the USAS Safe Sport Recognition Program
- Kris recommends that all clubs have a Safe Sport Coordinator

Finance Chair - Bobby Livesay:

• September 1, 2018 – August 31, 2019 Financial Report was reviewed. There is enough in the reserve for a six-month operating period. Projected revenue was not reached due to a decline in membership and a decline in splash fees collected. It was explained that there has been an average of 2-3 per cent decline in membership every year for the past four years except this past year where there was a 6.8% decrease.

Mike Essig asked if the board of directors had investigated why there was a decrease in membership. It was explained that membership is being monitored by the board. Membership Reports by age group have been reviewed, and the 12 and under age group was identified as to where the decline is occurring. Steve Hagan, a father of a YMCA swimmer told the house of delegates that YMCA teams are exploding with swimmers in the 12 and under age group. It was pointed out that the cost to swim YMCA was much less than swimming USAS. Brent Runkle, president of the Louisville Swim Association added that its membership had declined 4%-5% this past year.

- 2019-2020 KYLSC Budget attached
 - Bobby explained that small reductions were allotted in income registrations and splash fees.
 - The contingency was reduced
 - Zone Budget: reduced by \$5,000
 - Moved/seconded/passed to accept the 2019-2020 budget as presented

Age Group Vice Chair – Jack Grigsby

• 2019 Southern Zones

39 KY Swimming Athletes Competed to finish 10th Place: Women: 10th Place & Men: 8th Place 40 Top-20 Swims

First Para Swimmer to Compete at the Age Group Zones championship – Brett Evans Brett received 2 First Place medals and 2 Second Place medals

• S Zone Age Group Championship Conference Call, July 9, 2019: A conference call with age group chairs throughout the Southern Zone was conducted. When asked how callers would feel about not including the 15-18s, more differences of opinion were expressed but a majority still favored their inclusion. The timing of the SZ AG Championships being close to existing LSC championships, Futures and the SZ Senior Championships were mentioned as influencing the ability of LSCs to attract athletes in this age category.

When asked how everyone would feel if the SZ AG Championship was reduced to 4 days from 5, everyone agreed that 4 days would be preferred. It would give an extra day to recover from lengthy meets the previous weekend as well as reduce LSC budgets all of the costs associated with an additional day of lodging and associated meal costs. Meet hosts would be able to reduce facility rental costs somewhat as well. It was suggested that the 13-18 Girls 800m Free and 13-18 Boys 1500m Free be spread over the other days of the meet following prelims in a manner to be determined.

 - 13 Average number of sessions worked per official
- 10,976 Estimated number of hours volunteered by officials at USAS/KYLSC meets

LSC Officials' Chair Workshop – June 2019

- I attended the LSC Officials' Chair Workshop in Charlotte, NC.
- Agenda items included MAAPP, changes to Athlete Protection Training, training and mentoring, communication, succession planning, advancement at the LSC and National levels, recruitment, retention, and strategic planning

USA Aquatic Sports Convention - September 2019

- Becky attended along with Ruth-Ann Bode and Maureen McDonald
- "Officially Awesome" session a celebration of officiating led by the National Committee.
 - Fun facts such as salaries of other professional officials
 MLB \$235,000/yr, NFL \$205,000/yr, NBA \$150,000/yr compared to our USAS volunteer officials who spent an estimated \$325/day and \$1.1 million/yr of their own funds to work at national level meets
 - Carol Zaleski, former president of USAS, shared some of her Olympic experiences that occurred during the 2008 games in Beijing where she became the first Olympic female deck referee
- Southern Zone committee meeting
 - o KYLSC recognized as having the highest percentage of officials to athletes (10%) in the SZ for 2018
 - o Safe Sport club recognition program
 - Reminder from USAS that applications needs to be completed by all LSC teams
 - Potentially mandatory in the next couple of year
 - 2021 meet dates set for SZ championships Age Group in Tupelo, MS July 27-31; Senior in College Station, TX July 27-31
- Bright Ideas Contest
 - o Finalists were from North Carolina, Oklahoma, Mississippi, and Niagara
 - NC Registration process tutorial developed to explain when, where, and how to handle registration and requirements for various groups and the meet reconciliation process
 - OK Safe sport wheel Athlete leadership within the OK LSC developed a spinning wheel concept they used at meets to allow younger athletes (and coaches) to ask questions and be education on Safe Sport
 - o MS Reuse and recycle donation boxes to collect gently use old medals and ribbons to be reused at meets
 - Niagara Athlete wellness initiative to raise mental health through educational activities, intervention and referrals to crisis hotlines and resources.
- USAS HOD proposed increase in dues –from \$70 to \$250 for existing clubs; \$70 to \$500 for new clubs
- Resulted in membership sending the proposal back for further work after considerable discussion
 Concussion Protocol Training
 - Now being required by USA Swimming for officials and coaches. Implementation is underway with officials incorporating this one-time training requirement as part of the 2020 recertification process.

New Referee Workshop – October 2019

- Occurs every other year
- Each LSC is provided the opportunity to send one official to the New Referee's Workshop
- The target audience is up and coming officials who are have less than 2 years' experience as a Deck Referee.
- Joseph Phillips is attending the workshop for KY Swimming

Goals for this upcoming year

- Re-establishment of an officials committee
- Increased communication, education and training for officials

Diversity, Equity and Inclusion - Ruth Ann Bode

- Ruth-Ann assisted with the planning and implementation of 2019 SZ D&I Select Camp. Attended camp D&I chair summit. Camp held June 13-16 in Columbia, SC at University of South Carolina. Largest attendance by athletes (40) for the SZ D&I Select camp. All but 1 LSC sent athletes/summit attendees. D&I Chair summit had at least 15 attendees (chairs and D&I representatives). Cort Hobelman was the KYLSC D&I SZ Select Camp attendee for this camp.
- Set up a Facebook page for Southern Zone Diversity & Inclusion friends. Post information pertinent to and of interest to Diversity & Inclusion for the SZ and KYLSC.
- Attended the USAS National Diversity & Inclusion Committee meeting February, Colorado Springs. Reported on the progress of the SZ D&I Select Camp, activities ongoing within the SZ.
- Attended the USAS Southern Zone Workshop as a participant, May, Denver. Learned about MAAPP roll-out and how it
 would affect our LSC. Participated in workshops for D&I initiatives (camps, swim meets, educational opportunities
 through job and college fairs,
- Posted/shared educational opportunities for coaches, athletes, parents, officials with Para-swimming clinics (August, September, October).
- Working on National Committee Knowledge bank task force assisting with collection of documents for the knowledge bank that will share via the USAS website under Resources.
- Attended USAS convention September 11-14, St. Louis, MO as one of 3 KYLSC delegates.
- Participated in the D&I Workshop "Educate, Initiate, Celebrate" at USAS convention in St. Louis.
- Attended the Swim-a-thon workshop at USAS Convention. Gathered information about how to host a Swim-a-thon in our LSC, for teams to do.
- Presentation to the 2019 KYLSC HOD about Diversity and Inclusion activities in USAS and their importance to the KYLSC.
- Arranged for Para-swimming speaker, Susan Mechler, to present to the 2019 HOD, information about Para-swimming –
 What it is, implementation of motivational time standards.
- Organizing an Athlete Leadership Summit for KYLSC focusing on developing upcoming athlete leaders within the LSC.
 Working with USAS Morgan Weinberg for information to share, possible facilitators. Anticipated date: 12/21/19

- Beginning process of organizing an LSC Select camp for 2020 we haven't done one in many years.
- Sent survey to all LSC clubs asking for input on D&I initiatives little to no response. Re-survey at 2019 HOD.

New Business

USA Swimming has a new template for required LSC bylaws. The bylaws are not ready to be approved yet.

Mike Essig motioned/seconded/approved

- 1. Motion to amend Section 604.13 of the Kentucky Swimming Amended and Restated By-laws to permit the amendment of by-laws by voting by mail.
- 2. Motion to amend Section 604.13 of the Kentucky Swimming Amended and Restated By-laws to permit voting on amendments to the by-laws by mail, including electronic mail, without a meeting. This amendment would remove amendments of the by-laws from the exclusions from actions that must be taken at a meeting and would permit voting on amendments to the by-laws by e-mail.
- 3. Motion to amend back (but with the addition of e-mail voting on other matters) Section 604.13 when the USA Template is finalized.

The amended text of Section 604.13 would read as follows: Any action which may be taken at any regular or special meeting of the House of Delegates, except elections, removals of Board Members, members of the Zone Board of Review, and elected committees chairs or coordinators, may be taken without a meeting. If an action is taken without a meeting, the Secretary, by first class mail, postage prepaid, or by electronic mail, shall distribute a written ballot to every member of the House of Delegates entitled to vote on the matter. The ballot shall set forth the proposed action, provide an opportunity to specify approval or disapproval, and provide a reasonable time (but in no event less than the period specified in Section 604.15.1) within which to

return the ballot to the Secretary. Action by written ballot shall be valid only when the number of votes cast in favor of the proposed action within the time period specified constitutes a majority of the votes entitled to be cast.
