She explained to the House of Delegates that since March 2020, the board of directors met 10 times and additional meetings conducted by Program Development, Technical Planning, Coaches and KY LEADS. The KYLSC Board of Directors is committed in bringing all USA Swimming information to its members, meeting with government officials to open facilities and fighting for the sport of swimming in Kentucky.

 - Mike Essig reported that during the shutdown, approximately 25 athletes participated in several KY LEADS (KY Leadership Education for Athlete Development through Swimming) meetings. Guest speakers included Abbie Fish and Nic Albiero. Two National team members, Mallory Comerford and Zach Harting will be giving a Zoom presentation after the HOD meeting for any athlete interested.
 - Program Development & Operations Vice-Chair: Brian Johnson
 - Brian Johnson reformatting LC champ meet. Committee met evaluated possibility of doing that. Due to cancellation of 2020 long course championship meets, the committee tabled that but will revisit before long course season. COVID plan submitted to governor's office at the beginning of the pandemic and used successfully to get back into the water. For the coming year Brian would like to look at reviving what would look something like the old state "B" meet. With this hopefully being an Olympic year and the additional excitement that it should bring, it would be a great opportunity to schedule a meet like that. Running the meet right after the summer championship meets possibly keeping the summer swimmers engaged a little longer and increasing USAS members numbers.
 - Technical Planning: no report
 - · Coach Representative: Kevin Ryan
 - Kevin Ryan reported he was voted in as Coaches' Representative the night before. He will be reaching to the coaches in the next few weeks to introduce himself and get to know the KYLSC coach members. During the Coaches' meeting, 8 coaches from the 27 KY Swimming clubs were present.
 - Senior Coach of the Year Chip Augustus (CARD
 - Age Group Coach of the Year Mike Essig (TS)
 - Pedro Pereira, outgoing Coaches' Rep, held weekly Zoom meetings during the shutdown. Now that practice has continued, the meetings will become monthly discussing updated USAS/KYLSC policies and discussing coaches' concerns.

Amy wanted to thank Mike Essig and Pedro Pereira for continuing to keep the coaches and athletes engaged and encouraged.

- Safety Chair:

Kris Humphries reported that the focus for 2020-2021 is clubs become a SafeSport Recognized club. If coaches or club board members need help with credentialing, Kris will be glad to help. Please forward all SafeSport information to your swim families.

- Officials Chair:
 - Becky Gilpatrick reported KY Swimming officials are a completely dedicated group of volunteers. Town Hall Meeting earlier in the morning where 51 officials attended.

August 2019 through February 2020: 203 officials certified, officials worked 1,800 different sessions equating to 7,100 volunteer hours, 39 clinics – 13 recertification clinics and 26 clinics for new officials or for officials wanting to advance to higher positions. KY Swimming should keep almost all officials from last year.

Diversity, Equity & Inclusion:

Ruth Ann Bode reported working on committee meetings and will reformulate soon. Ruth Ann, along with Becky Gilpatrick, was able to participate and form the KY LEADS program for club athlete representatives. At the kick-off meeting, there was a DE&I presentation expressing the importance of diversity and engaging participation. There was the formation in Louisville of a new swim team with 20 members under of the auspices of Ali Center and Trident Swim Foundation, motto "Float with our butterfly – Sting with our free." Louisville, Kentucky is the site for the 2021 national DE&I Select Camp sometime in early June. Coaches please encourage your athletes to apply. Earlier this morning, Peggy Ewald, Team USAS - Olympic Para-Swimming Committee presentation, including the para swimmer at the club and LSC levels. Several officials have researched certification at the para swimming level. DE&I is looking to engage not only athletes but officials. Ruth Ann will work with coaches to recruit not only athletes in minority areas but recruitment with coaches as well.

- New Business
 - 2020-2021 Short Course Meet Schedule: 2020-2021 Meet schedule it on the web site. Schedule consists of meets approved during the meet bid process and new meets. Some of the originally scheduled meets may be cancelled due to pool availability.
 - Championship Meets: Amy Albiero reported the short course championship meets are scheduled for March 12-13 and March 19-21. For the current meet hosts, neither facility have access to the pools. The board has decided to wait closer to December to discuss moving on with a different plan and send out for a rebid. Coaches meeting are dates are concrete, and the answer is no. State meet may take place over several weekends in several different locations. Have state championships is a top priority.
 - Sanctioned Meet Requirements: USAS requires an additional host plan to be included with your sanction application and meet announcement. All documents and templates can be found on the web site.
 - Timing Systems: Bucky Stoess explained timing systems requirements. A primary system shall always be in place and shall consist of one of the following, listed in their preferred order of use: Automatic Timing touchpads, Semi-Automatic, with three (3) or two (2) buttons per lane, each operated by a separate timer, and Manual, with three (3) watches per lane, each operated by a separate timer. Secondary System If manually operated watches are not the primary system, a secondary system of precedence equal to or lower than the primary system must be used. These requirements have always been in place with the addition for a secondary system of overhead video with 100 images per second.

 Elections (Nominating Committee Slate of Candidates) Marvin Watson, Nominating Committee Chair, thanked the committee, Bucky Stoess – outgoing Rules Chair, Chris Fugmann (HA), Matt Vogelpohl (NLY), Joseph Phillips was on the committee but resigned when he was nominated for a position.

Amy asked if there were any nominations from the floor. Kevin Ryan moved/Ruth Ann Bode seconded/approved to accept the slate from the Nominating Committee by acclamation.
