

Kentucky Aquatics Derby Classic Meet Announcement
May 19-21, 2023
Held under USA Swimming Sanction #KYLC23-KYA01

LOCATION: Lancaster Aquatic Center, University of Kentucky; Lexington, Kentucky

FACILITY: A 75 X 176-foot pool, with two movable bulkheads creating one eight-lane 50-meter racing course with Competitor non-turbulent lane markers, is housed in this facility. Electronic timing by Colorado Timing System with two full color scoreboards will be used. There are 350 bleacher seats on deck for swimmers and 500 permanent seats in a raised balcony for spectators.

Pool depth: Patio end is 6" to 7", dive end is 7.5" to 16"

Due to State Fire Marshall's code only 500 spectators will be permitted in the balcony. Once the limit is reached, no additional spectators will be admitted until someone leaves. Re-entry, with a ticket stub, will be allowed subject to seating capacity.

The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

FACILITY NOTES:

1. All trash must be deposited in appropriate containers.
2. Children (swimmers and spectators) may not go into unauthorized areas, especially the Seaton Center attached to Lancaster Aquatic Center.
3. UK and USA Swimming prohibit smoking and alcohol.
4. Any signs or banners must be hung by masking tape or string only.
5. Radios, noisemakers, or anything that may cause distraction to swimmers, coaches or officials will not be allowed. Flash photography is prohibited during the start of heats.
6. Only competitors, coaches, officials and authorized meet workers will be allowed on deck.
7. Folding chairs on deck must be placed out of traffic paths and may be limited per team.
8. There is no reserved seating in the aquatic center balcony; clothing and other materials may not be used to "save" seats.
9. Any acts of vandalism against the University of Kentucky at the Lancaster Aquatic Center will require immediate attention by the meet director. UK Police Department will be called and a report filed. Culprits could be expelled from one or more sessions, as determined by the meet director, team coach and KYLSC.

RULES

Unsupervised Swimmers: USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. Swimmers participating under the provisions of 202.6 or USA Swimming's "open border" policy must be under the supervision of their coach or a USA Swimming member coach. Coaches who are entering swimmers but will not be at the meet should arrange ahead of time for another coach to supervise their athletes. Swimmers unaccompanied by their coaches or for whom arrangements have not been made must contact the Meet Director or Meet Referee who will assist the athlete in finding coach supervision.

The use of audio or video recording devices, including a cell phone, is not permitted in changing areas, restrooms or locker rooms. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations.

Deck Changing: Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Athlete Protection Policy: Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy (“MAAPP”), will govern this meet. Locker rooms will be available to swimmers only. Coaches, officials and meet workers will use the restrooms in the balcony area and downstairs hallway.

STARTING TIMES: Tentative warm-up and starting times for each session are noted at the end of this meet announcement. These times are subject to change depending on entries, and final warm-up and starting times will be announced on May 17.

ENTRY DEADLINE: The due date for entries is May 13, 2023, by 6:00 p.m. EST.

PSYCH SHEET: A psych sheet will be sent out via e-mail to each team’s entry contact by 8:00 p.m. EST on Sunday, May 14, 2023.

CORRECTING ENTRIES: Please use the psych sheet. Any corrections must be e-mailed to J.J. Rodgers (kyaentries@gmail.com) by Tuesday, May 16, 2023, by 5:00 p.m. EST.

ENTRY FEES: Individual events are \$8 (includes \$0.25 KYLSC splash fee); plus a \$2.50 per swimmer KYLSC surcharge; plus \$23.00 per swimmer facility surcharge. Checks should be made payable to Kentucky Aquatics and delivered to the Meet Referee or Meet Director prior to the start of the meet.

ENTRY LIMITS: Each swimmer may enter up to nine individual events. The exhibition event described below does not count toward the entry limits.

DECK ENTRIES: Deck entries will not be permitted.

ELIGIBILITY: Swimmers must be current athlete members of USA Swimming as provided in Article 302 or as provided under 202.6 or USA Swimming “open border” policy. Age is as of the first day of the meet. Coaches must be current coach members of USA Swimming and must wear credentials during the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.

ENTRIES: Submit Entries to kyaentries@gmail.com. Only electronic entries will be accepted (Hy-Tek or SDIF). Handwritten, telephoned, or faxed entries will not be accepted with the exception of the report sheet provided for utilization when entering swimmers with a disability. If the USA Swimming ID for any swimmer is omitted, that swimmer’s entries will not be accepted.

SWIMMERS WITH A DISABILITY: Entries for swimmers with a disability should be handled in the following manner: (1) enter the swimmer in the Hy-Tek database (or on the regular entry form); (2) list in the email accompanying the Hy-Tek entry file (or on a separate sheet of paper) the name of the swimmer, the stroke(s)/distance(s) s/he wishes to swim, the entry times, the day/session s/he wishes to swim the event(s), and the manner in which s/he prefers to be seeded (with a longer distance or with a different age group); and (3) provide any information about special accommodations needed by the swimmer. The final determination of seeding will be made by the Meet Referee after consultation with the swimmer and his/her coach. All requests for accommodations must be submitted to the Meet Referee in writing prior to the start of the meet, and must include the basis for the request and the specific accommodation requested.

CONDUCT: The meet will be conducted according to the rules set forth in the current USA Swimming Rules and Regulations. Events will be contested in a long course meters pool. **Events of 400 meters and longer will require positive check-in.** All other events will be preseeded. **All events will be swum fastest to slowest.** The 800 freestyle will be conducted in alternating heats of girls and boys. Heats of boys and girls may be combined at the discretion of the Meet Referee. The number of swimmers in the 800 freestyle may be limited, in the discretion of the Meet Referee, to ensure no disruptions to the timeline. KYA reserves the right to include one heat of its swimmers in the 400 and 800 freestyle events. These events may be limited to allow the

meet to operate within its reserved time. In the event a swimmer is not able to participate in these events due to limitations, the swimmer will be permitted to select another event.

CLERK OF COURSE: There will be no clerk of course at this meet.

TIMERS: Kentucky Aquatics will provide timers for all events EXCEPT FOR the 800 freestyle. Any swimmer competing in the 800 freestyle must provide his/her own timer and lap counter.

AWARDS: High point awards will be given to the swimmers achieving the top three overall scores in the following age groups: 8&U, 9-10, 11-12, 13-14, 15-18. A swimmer must compete in his/her own age group in order to score points in an event that is available for that age group. Points scored in an event by a 12&U swimmer competing in 12&O event will count toward high point awards only if that event is not available in the swimmer's age group.

SCORING: Scoring will be on a sixteen (16) place basis with individual events scored 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1.

EXHIBITION EVENT: Events 35 and 36 are exhibition events. These events will be a 50 meter freestyle skins race. The top 8 finishers in Events 27 and 28 who wish to compete in the exhibition will be required to check-in for the event by the conclusion of Event 32 (Men's 12&O 200 Breaststroke). The top six finishers in Events 35 and 36 will return to the blocks for another race; the top four finishers will then do the same; and the top two finishers will race to determine the winner of the events. After the first heat of Event 36 concludes, lane 8 will be open for warm-ups for the 800 meter freestylers; lanes 7-8 will be open after the second heat; and lanes 5-8 will be open during the final heats. There is NOT a scheduled break between Event 36 and Event 37.

PARKING: Parking on University Drive will not be permit controlled during the meet. PS #1 (at University Drive & Cooper, across from the pool), K, and C6 (stadium) lots will also not be permit controlled. **DO NOT PARK on Complex Drive**, as it will be permit controlled. PS #7 (at Complex & Sports Center Drive, near the tennis courts) will be available at no parking cost. Sports Center Drive E lots will not be permit controlled.

RESULTS: Will be posted on www.KYLSC.org and Meet Mobile.

SAFETY/WARM-UP: Coaches must maintain contact with their swimmers during warm-up. All entry into the pool for warm-ups will be feet first from the starting block end of the pool. There will be no diving during warm-up, except in designated sprint lanes. **All warm-up and start times below are tentative and subject to change based on the number of swimmers and facility restrictions.** Final warm-up and start times will be posted by Wednesday, May 17, when warm-up lane assignments are provided to the coaches. All 12&O sessions will have open warm-ups.

COACHES: There will be a coaches' meeting in the hospitality room 15 minutes prior to the start of Session 1. Any questions may also be directed to the Meet Referee prior to or at the meet.

OFFICIATING OPPORTUNITY: Kentucky Aquatics welcomes the assistance of visiting officials. Kentucky Swimming officials may sign up to officiate through the Kentucky Swimming website. Visiting officials from other LSCs who would like to officiate this meet should contact the Meet Referee in advance.

MEMBER REQUIREMENT: All meet directors, referees, starters and stroke and turn judges, serving in an official capacity must be members of USA Swimming or other FINA-member organization. Except for coaches accompanying athletes participating under the provisions of 202.6 or USA Swimming's "open border" policy, all persons acting in any coaching capacity must be members of USA Swimming.

EVENTS: The tentative order of events is provided below. Events may be consolidated and swum together at the discretion of the Meet Referee. This meet will be conducted in 12&U and 12&O sessions for the purpose of allowing 12 year olds to attempt to obtain qualifying times in events not typically available in 12&U sessions. As noted above, any points earned by 12 year olds competing in 12&O events that are also available in the 12&U session will not be counted in determining high point scores.

HOSPITALITY: Hospitality will be provided each day for coaches, officials and meet workers volunteering for back-to-back sessions.
