FACILITY: The Competitive Indoor Pool is 8 Lanes x 25 Yards. The seating for spectators is 400. The lobby of

the Natatorium will be setup for swimmers to utilize during meet. Colorado Timing System will be

utilized with an 8 Lane Scoreboard.

POOL MEASUREMENTS: The competition course *has not* been certified in accordance with 104.2.2C (4).

WATER DEPTH: The depth of the pool at the start end is 4 feet 6 inches. The depth at the turn end is

12 feet 6 inches.

MAAPP: All applicable adults participating in or associated with this meet, acknowledge that they are

subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in

the conduct of this competition.

Use of audio or visual recording, including a cell phone, is not allowed in changing areas, restrooms,

or locker rooms. Such devices being used in these areas are subject to confiscation.

DECK CHANGING: Except where venue facilities require otherwise, changing into or out of swimsuits other than in

locker rooms or other designated areas is not appropriate and is prohibited. Per USA Swimming Code of Conduct 304.3.7, persons violating this provision are subject to ejection of the facility.

BULLYING All participants and competitors shall follow the U.S. CENTER for SAFESPORT rules for bullying

found on the USA Swimming and Kentucky Swimming web sites. A violation will be grounds for

removal of member from the facility.

DRONE USE: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools,

athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by

the Program Operations Vice Chair. USA Swimming article 202.4.9 J

ENTRY DEADLINE: The due date for entries is October 7, 2022

ENTRY FEES: Individual events: \$6.50 per event

Relay events: \$12.00 per relay

KYLSC Surcharge: \$2.50 per swimmer

Facility Surcharge: \$20.00 per swimmer

Make checks payable to Central Kentucky Aquatics.

ENTRY LIMITATIONS: Swimmers may enter up to 5 individual events and 1 relay per day. Entries will be taken on

a 1st come, 1st served basis and will close at a max of 250 swimmers per session.

ENTRIES: Entries should be submitted in Short Course Yards . Only Hy-Tek electronic entries will be

accepted.

DECK ENTRIES: Deck entries for swimmers not already in the meet will not be allowed. Deck entries for swimmers

already entered in meet will be accepted if there is an open lane. Additional heats will not be added to the meet for deck entries. Deck entry fees are \$10, payable at the time of entry into

meet.

ELIGIBILITY: Swimmers must be current athlete members of USA Swimming as provided in Article 302

or as provided under 202.6 or USA Swimming "open border" policy. Age is as of the first day of the

meet.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

SWIMMERS WITH A DISABILITY: Entries for swimmers with a disability should be handled in the following manner: (1) enter

the swimmer in the Hy-Tek database (or on the regular entry form); (2) list in the email accompanying the Hy-Tek entry file (or on a separate sheet of paper) the name of the swimmer, the stroke(s)/distance(s) s/he wishes to swim, the entry times, the day/session s/he wishes to swim the event(s), and the manner in which s/he prefers to be seeded (with a longer distance or with a different age group); and (3) provide any information about special accommodations needed by the swimmer. The final determination of seeding will be made by the Meet Referee after

consultation with the swimmer and his/her coach.

CONDUCT: The meet will be conducted according to the rules set forth in the current USA Swimming Rules and

Regulations. All events will be timed finals.. Heats will be swum slowest to fastest.

AWARDS: Awards will be given for Age Group High Points 10&U, 11-12, 13-14, 15 & Over.

All OPEN events will be seeded accordingly, but scoring will be broken into 13-14 & 15 & Over age

groups.

ADMISSION COST: No Admission will be charged
