| Facility | The competitive indoor pool is 8 lanes by 25 yards: fully automatic timing system. Timing for 25's will utilize the timing system with swimmers starting off the side of the pool if certified; otherwise, they must start in the water at the shallow end. The depth of the pool at the start end is 12 feet. The depth at the turn end is 4 feet. GSCS ensures the required course dimensions. The seating for spectators is fire marshal limits of natatorium area with overflow in the gym area. Restrooms for spectators will be available in the Family Restrooms in the hallway prior to entering the pool deck. Other spectator restrooms are available upstairs. Locker rooms will be reserved for 17&U athletes only. Only athletes entered in the meet, working coaches, officials, and meet workers are allowed behind the blocks and in the designated areas for swimmers. | | | | | |
