**LOCATION** Falling Spring Rec. Center; 275 Beasley Drive; Versailles, KY 40383

Take Exit 68 off of the Bluegrass Parkway • proceed 0.5 miles northbound on KY 33 to the stoplight intersection with KY 2113 (Falling Springs Blvd.) • turn left (westbound) onto KY 2113 • proceed 2.5 miles to

the parking lot entrance on your left • pool is around to the right as you enter the facility.

**FACILITY** 8 lane, 25 yard indoor pool with Kiefer lanelines; fully automatic timing.

**POOL MEASUREMENTS:** The competition course has been certified in accordance with 104.2.2C (4). The copy of such certification is on file with USA Swimming.

WATER DEPTH: The depth of the pool at the start end is 12 feet. The depth at the turn end is 4 feet.

FORMAT Timed finals age group meet open to USA Swimming registered athletes and teams: 10 &Under, 11-12, 13-

14, and Open age divisions. Please utilize short course yard times when making entries.

COVID-19:

We have taken enhanced health and safety measures for the swimmers, coaches, volunteers, spectators and other meet workers. You must follow all posted instructions while attending this event. An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable.

Neither USA Swimming, Inc. nor Kentucky Swimming, Inc., can prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. It is not possible to prevent against the presence of the disease. Thus, if you choose to participate in a USA Swimming sanctioned event, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

Permitting a swimmer to attend this meet constitutes a representation by that swimmer's parent or guardian that the swimmer has not been tested positive for COVID-19 in the two weeks preceding the meet, that the swimmer has not been in close proximity to any person who has tested positive for COVID-19 in the two weeks preceding the meet, and that the swimmer is not exhibiting any signs of illness.

SPECTATORS: Admission is free.

**PARKING**: The Falling Springs Center has a large parking lot available at no cost.

**RULES** The use of audio or video recording devices, including a cell phone, is not permitted in changing areas,

restrooms or locker rooms. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of

Program Operations.

**Deck Changing:** Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

MAAPP: Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP"), will govern this meet.

All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.

Locker rooms will be available to swimmers only. Coaches, officials and meet workers will use the restrooms in the lobby.

Deck Access: Only athletes entered in the meet, coaches, officials, and meet workers will be allowed on deck.

**ENTRY FEES:** \$6.00 per Individual Event entry

\$2.50 per swimmer Kentucky Swimming LSC surcharge + \$12.50 per swimmer facility surcharge = \$15.00 total

**ENTRY LIMITATIONS**: Swimmers may enter up to five individual events

**DECK ENTRIES**: Deck entries will not be permitted.

**ELIGIBILITY**: Swimmers must be current athlete members of USA Swimming as provided in Article 302 or as provided under 202.6 or USA Swimming "open border" policy. Age is as of the first day of the meet.

Coaches must be current coach members of USA Swimming and must wear credentials during the meet.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**CONDUCT:** The meet will be conducted according to the rules set forth in the current USA Swimming Rules and Regulations. Events will be contested in a short course yards pool. All events will be pre-seeded; no events will be deck seeded. Heats will be swum slowest to fastest.

**SAFETY/WARM-UP:** Coaches must maintain supervision of their swimmers during warm-up. All entry into the pool for warm-up is feet first from the end of the pool. Dive starts are only permitted under the supervision of the swimmer's coach.

SAFETY PERSONNEL: Lifeguards will be on duty during the conduct of the meet. An AED is available at the facility.

OFFICIALS: All meet directors, referees, starters and stroke and turn judges serving in an official capacity must be members of USA Swimming or other FINA-member organization. Except for coaches accompanying athletes participating under the provisions of 202.6 or USA Swimming's "open border" policy, all persons acting in any coaching capacity must be

members of USA Swimming.

WARM-UPS: To start at 7:45 A.M. and be assigned based upon "social distancing" measures. Warm-up assignments will be emailed by

Noon on Friday, Jan. 6, 2023 and posted to <a href="https://ht

AWARDS ribbons will be awarded for first – eighth place in individual events.

Coaches are requested to take their team's ribbons with them at the conclusion of the meet.

**HOSPITALITY** There will be a hospitality room open to coaches and officials throughout the meet.
