**FACILITY:** The competitive swimming pool measures 6 lanes by 25 yards. The pool depth at the start end of the pool is 6'0" and the depth at the turn end of the pool is 3'6". The facility has Colorado Timing System and a 6-lane scoreboard. The competition course has not been certified in accordance with 104.2.2C (4).

Use of audio or visual recording devices, including cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.

#### **SAFETY DIRECTOR:**

Anyone that is a USA Swimming certified official is welcome and encouraged to work this meet. Please contact the meet director, Leigh Johnson, in advance of the meet if at all possible to let her know of your availability.

**OFFICIALS MEETING:** There will be an official's meeting 45 minutes prior to the start of each swimming session.



**COACHES MEETING:** A coaches meeting will be held 15 minutes prior to the start of each session.

**ELIGIBILITY:** All current USA Swimming registered athletes. The age of the swimmer on December 17, 2022 will determine the age group for this meet. This meet will be run according to current USA Swimming rules and regulations. No entrant will be permitted to compete unless the entrant is a member as provided in Article 302 except as provided under article 202.6 or USA Swimming's "open boarder" policy included in its registration manual.

**ON-SITE REGISTRATION:** Swimmers not previously entered in the meet must provide proof of current USA Swimming registration. Deck entries will be accepted prior to the start of session as long as lanes are available in the event attempting to be added. No new heats will be added to the meet. Entry fees must accompany deck entry.

**DECK ENTRIES:** Subject to space availability, and at the discretion of the Meet Director, deck entries will be accepted on the day of the meet at the cost of **\$10.00/event.** Deck entries will be accepted prior to the start of each session.

**ENTRIES:** All entries must be submitted as SCY times. Only electronic entries will be accepted (Hy-Tek or SDIF). Handwritten, telephoned, or faxed entries will not be accepted.

**ENTRY FEES:** \$5 for each timed finals event

\$7 for each prelim/final event

\$14 for each relay

\$25 per swimmer surcharge

ENTRY DEADLINE: December 10, 2022

**ENTRY LIMITS:** Each swimmer in the 11-12, 13-14 and Open age groups will be limited to 3 individual events and 1 relay per day. Swimmers in the 10 & Under age group will be limited to 4 individual events and 1 relay per day. If a swimmer is entered in more than the maximum number of individual



events for that day and does not scratch down by the start of event #1, the entry will be made by order of events. There will be no refunds for swimmers entered in more events than permitted.

**SWIMMERS WITHOUT A COACH:** Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**AWARDS:** Ribbons will be awarded 1<sup>st</sup> through 12<sup>th</sup> place for individual and relay events. High Point Awards will be awarded in the represented age groups (Girls and Boys).

WARM-UP: USA Swimming and KY Swimming safety procedures will be enforced throughout the meet. Warm-ups are subject to the following procedures:

The referee may remove anyone from the warm-up for failure to comply with the warm-up rules.

Swimmers without a coach must report to the Meet Director before entering the pool for warm-up in order to obtain a lane assignment.

**Note:** Swimmers violating safety procedures will be removed from the warm-up for the remainder of the warm-up session. Subsequent violations may cause the swimmer to be disqualified from the remainder of the meet.

**CHECK-IN:** The 400 IM and 500 free will be pre-seeded prior to the meet. ONLY the TOP 12 will be swimming in finals. Athletes must check-in by NOON on the day of the event.

SCRATCHES FROM FINALS: USA Swimming Championship rules will apply. Swimmers qualifying for finals, or final, based on the results from preliminaries, must notify the referee or designee with 30 minutes after the announcement of the qualifiers for that race that they do not intend to compete. Failure to declare, and not swim in the Sunday finals events, shall result in a \$25 fine.

**CLERK OF COURSE:** Clerk of course will be provided for all 10 & Under sessions.

**TIME TRIALS:** NO time trials will be permitted.

**ADMISSION:** There will be no gate fee this year.

**RESULTS:** Results will be posted on KYLSC website and emailed to each team.

**RULES:** This meet will be conducted in accordance with the current USA Swimming Rules and Regulations, except where rules therein are optional and exceptions are stated. Current USA Swimming Rules pertaining to the Minor Athlete Abuse Prevention Policy (MAAPP) will govern this meet.

All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.

The use of audio and visual recording devices, including cell phones, is not permitted in changing areas, restrooms, or locker rooms. Such devices being used in these restricted areas will be subject to confiscation.

Changing into or out of swimsuits other than in locker rooms is not appropriate and is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair (USA Swimming Article 202.4.9J).

**DECK ACCESS:** By USA Swimming ruling, deck access is limited to swimmers, coaches, officials and meet workers. Officials and coaches must wear their USA Swimming ID cards to be allowed on deck.

**HOSPITALITY:** There will be food and drinks available at all sessions for officials and coaches. **TIMERS:** Volunteer Timers may be needed for this meet.

**SPECTATORS:** Seating may be limited. Please bring folding chairs as needed. No coolers are allowed in the facility. Concessions will be available.
