 - c. College and post grad swimmers not having participated as an age group swimmer for a KYLSC team will be eligible for reimbursement identified in John's Travel Reimbursement recommendations (number 3)
 - d. The swimmer will have no other source of reimbursement available.
 - e. The reimbursement application must be submitted 30 days after trials of the reimbursement is waived.
- 5. Age Group Vice-Chair: KYLSC's Altitude Camp application was denied. The time requested was not available due to scheduled pool maintenance. The zones coaches are Sarah Holman, Amber Lyvers and Nate Kopf. 14 swimmers have applied.
