V. SZAG CHAMPIONSHIP MEET – SUGGESTIONS FOR THE FUTURE

- A. Consider setting a date certain to expect the SZAG Championship Meet Info (ie. April 15th)
- B. We had one swimmer enter who had achieved a Junior National qualifying time before the entry deadline. The Meet Committee met and allowed the swimmer to participate in non-Junior National events and no relays (since the swimmer was already present at the meet and it was not caught ahead of time). Recommend that the Junior standards be added into the meet entry file as a maximum allowable time so that it would be flagged in the entry process moving forward.
- C. Change the Charlene Craddock Award from a swim cap to a t-shirt.
- D. Start the coaches Meeting to 10:15am on Tuesday and start warm-ups at 11am. Rationale: It gives more time for coaches to get required items submitted and be present for warm-ups.
- E. Consider moving the parade to a night earlier in the meet.

2021 Disability Swimming Report

Southern Zone

To say that 2021 has been a unique and challenging year for swimming would be a gross understatement. The 2020 Tokyo games were delayed 12 months and cancelation was a possibility. Pools were shut down and leadup competitions were not being scheduled. Swimmers with a disability face the additional requirement to redo their classification prior to the games in an international competition as well as making qualifying times. If the games did take place, many of our athletes were not going to be eligible to compete. Thanks to the efforts of US Paralympic swimming, and Shannon Gillespie, an international competition was scheduled in April in Lewisville, Texas, one of the few facilities that were open. All the US and Canadian swimmers who needed to were able to be classified and qualifying swim times were achieved. The meet was held under strict covid protocols, and all participants were tested and quarantined.

US Paralympic Trials were held in Minneapolis simultaneously as the Omaha wave 2 trials and for the first time were broadcast live. The following southern zone athletes participated in the meet:

The southern zone age group championships were held in Tupelo, Mississippi after being canceled last year. 5 swimmers with a disability competed; 3 from Georgia and 1 each from North Carolina and South Carolina. Each LSC is allowed to bring 6 swimmers and should strive to meet that goal in future competitions.

The National Disability Committee has posted a webinar titled "my swimmer with a disability is ready to compete, now what?". Included with the clinic are tools to help meet referees communicate with coaches and officials to better facilitate the inclusion of the athlete. These can be found on the USA Swimming website with the parallel time standards for LSC, sectional and zone meets as well as sample wording for meet information.

Rule section 105 of the USA Swimming rule book has been edited into a single page reproducible handout to use for officials in clinics and at meets. The NDC requests that any time rule 105 is used to set aside a technical rule a note is added in the meet results. They are working on a way to do that in swims in the future.

Open water age group zone meet is seeking to include 2 swimmers from each LSC with a disability in the P1, P2 or P3 ability grouping in next year's open water zone meet.

RE: SZAG Championships-Tupelo, MS, Report

The meet was held July 27-31 in Tupelo, MS at the Tupelo Aquatic Center. It was a very hot week in Tupelo, outside temperatures over 100 degrees and heat index of over 110 degrees; inside the temperature was 80-90 degrees. The air quality in the facility was very good.

The city of Tupelo was very inviting and provided an athlete social on the first night. They also provided outside tents with air misters.

There were 443 athletes in attendance, with 5 disability athletes (from 3 LSC's), 13 of the 15 LSC's participated in the Southern Zones Age Groups Championships. We had 38 officials from 12 LSC's. Melissa Hellervick-Bing, Dave Smith and Walter Smalley were our National Evaluators; and they provided 23 evaluations.

The operational issue for the meet, was that we had trouble starting the 50-meter events at the turn end, so we had to move the timers to the other end. This caused a 30-minute delay during prelims and about a 10-minute delay in finals, on the first day. We then just moved the timers for the rest of the meet.

The meet committee met to discuss the 1 athlete who had a junior national cut in 1 event. Since the athlete was at the meet, the committee decided to allow him to swim any events that he did not have the Junior time. They also decided that he could swim the one event as exhibition only or he could choose another event and that he could not swim in the relays. The one question for discussion is the intent of swimmers with Junior National times, to not allow them to enter the meet in that event or not allow them at all. It doesn't make sense to me if a swimmer has 1 or 2 Junior cuts and can't swim in a fun event like this, to be a part of the LSC Team.

Overall, it was a good meet and I think everyone enjoyed themselves. Thank you for allowing me to be the meet referee.

Wade Kojima Meet Referee Meet Report for Southern Zone Senior Champs in Justin, TX.:

Approximately 590 swimmers. After Tuesday evening relays there was a definite issue with air quality. A lot of coughing from swimmers immediately after their race. Facility was purging every 5-8 hours at that time. Starting Wednesday morning the facility purged every hour on the hour for the remainder of the meet. The air quality improved immediately and drastically. No other issues the rest of the meet. I commend the facility for a pro-active response to the IAQ issue. We were short staffed the entire meet on officials, but absolutely made it work. Time lines ran on-time (after the changes described below) and Time Trials Wednesday thru Saturday went very well. The relays Tuesday were a challenge for Admin, but they persevered and it was actually one of the most exciting evenings of the meet.

We did change the award ceremony order (with unanimous coach approval) from After Women then After Men to After Women & Men. We also changed the Relay Awards (except Tuesday and Saturday) to the next evening after the National Anthem and prior to the beginning of Finals. It helped with our time lines and I recommend that be put in place for future meets.

Thank you for the trust you put in me to run this meet. I had fun and learned a few new things. Also met some really great athletes, coaches and officials.

Proposal to Increase LSC Dues to the Southern Zone

Brought by the SZ Directors

To go into effect January 2023



SECTION 9 - Revenue

1. Annual Dues

A.The SZ collects annual dues from each LSC in the Zone. The annual dues are set by the House of Delegates and currently are \$50 per year and are due by January 31st of the current year. Beginning in January 2023, the dues will be \$.15 per registered member of the LSC, athlete and non-athlete, as determined by registration numbers from 31 August of the previous year.

SECTION 8 - Fiscal Goal and Operating Reserve Fund

The goal is to fund SZ Travel Requirements, support our Zone Athlete Representatives and the SZ Athlete's Committee, to support our Zone Safe Sport Conferences, to support our Zone DE&I Camps and to build up a reserve for contingencies.

RATIONALE.

The SZ dues have not been revised since 2002. We find ourselves with two main travel requirements, one to attend the USA Swimming Annual Business Meeting in the Fall and the Expanded Zone Workshop in the Spring.

RATIONALE.

The Annual Business Meeting will be a 3-day affair, probably in either Colorado Springs or Denver each year. The expectation will be for attendance of the Zone Directors, including the SZ Athlete Director. Committee meetings will be virtual for the most part.

The Expanded Zone Workshop will be a 4-5 day meeting, location changing each Spring but probably in the middle of the country with easy air access such as Chicago, Dallas or Atlanta. We can expect the SZ Leadership to attend along with the LSC GCs or reps, the LSC Athlete Reps and other members of the LSC Boards depending on what committees will have an in-person meeting, since that may change each year.

In the past, each LSC was asked to pay for Travel and Board of any Zone Leadership called for a meeting, when not covered by USA Swimming. We are anticipating that USA Swimming will no longer pay for that travel, so this proposal will shift payment from the LSCs to the Zone. As an example, the SZ Non Coach Director is in the Southeastern LSC, and that LSC has been covering travel & room costs to any meeting not covered by USA Swimming, including previous Conventions. If this proposal passes, those expenses will be paid by the Zone with the expense shared by all 15 LSCs in the form of their annual dues.

This increase will also allow us to increase the budget we currently allocate to the SZ Athlete Reps, allowing them to organize an in-person athlete meeting every other year.

This dues revision is in line with how the other three Zones operate, although our amount will still be below the other three Zones.
