Dave thanked Herb Schwab as the Zone Secretary/Treasurer. Dave also thanked Barbara Aguirre, Kenneth Chung, Wade Kojima for stepping up at the last minute to host the Zone Age Group Championships this past summer. Dave also thanked Tim Byerly for stepping in as the Meet Referee for the Zone Senior Championships.

Dave acknowledged the USA Swimming Zone Advisors, Terry Jones and Dana Skelton, for their help and support this past year.

Dave thanked Dan Henshaw for a great job as the Southern Zone Webmaster.

New Business

Block 1 Proposals to be voted on as a block (SZ 01, SZ 02, SZ 03, SZ 04, SZ 05):

SZ 01 - Requiring Notification of athletes selected to Meet Committee to the SZ Athlete Director.

SZ 02 - Adjustment of language for the composition of the SZSR Meet Technical Committee.

SZ 03 - Adds requirement for the Sectional Technical Committee to have at least 20% athletes.

SZ 04 - Removes cap on fiscal goal.

SZ 05 - Cleans up the language of how voting will be conducted during a virtual meeting, allowing more flexibility.

A Motion was made and seconded to approve Block 1 by unanimous consent. Motion carried.

Block 2 Proposals to be voted on as separately (SZ 06, SZ 07, SZ 08, SZ 09, SZ 10, SZ 11, SZ 12):

SZ 06 - Modification of language under expenses to bring it in line to what USA Swimming is using.

A Motion was made and seconded to approve SZ 06 by unanimous consent. Motion carried.

SZ 07 - SZSR Meet reduction from 4½ days to 4 days, allowing travel on Tuesday. *NOTE - A vote on the actual template will be conducted once the template is distributed and each LSC will have a chance to review it - anticipate an October email vote.*

A Motion was made and seconded to approve SZ 07 by unanimous consent. Motion carried.

SZ 08 - Southern Zone Age Group Meet reduction from 4 ½ days to 3 ½ days; elimination of the 15-18 age group and increase of athletes in the 11-14 age groups to maintain 48 swimmers per LSC. No change to the swimmers with disabilities. *NOTE - A vote on the actual template will be conducted once the template is distributed and each LSC will have a chance to review it - anticipate an October email vote.*

A Motion was made and seconded to approve SZ 08 by unanimous consent. Motion carried.

SZ 09 - Adjustment of Southern Zone Age Group Meet fees: \$10 per event, \$15 per relay plus allowing the prospective host to charge a facility charge, if included in the bid package.

A Motion was made and seconded to approve SZ 09 by unanimous consent. Motion carried.

SZ 10 - Adjustment of LSC dues to the Southern Zone, setting it at \$.10 (ten cents) per registered non-athlete member and premium athlete as of August 31st each year, effective immediately.

A Motion was made and seconded to approve SZ 10. Motion carried by electronic vote.

SZ 11 - Addition of Southern Zone surcharge of \$5.00 per swimmer attending the Southern Zone Senior, Southern Zone Age Group and Southern Zone Open Water Championship meets, effective immediately.

A Motion was made and seconded to approve SZ 11. Motion carried by electronic vote.

SZ 12 - (Contingent upon SZ 10 & SZ 11 passing) Addition of a statement saying all Zone Director expenses will be covered by SZ funds rather than individual LSC funds, effective immediately.

A Motion was made and seconded to approve SZ 12 by unanimous consent. Motion carried.

Hospitality Top notch catering. A lot of thoughts were given into the choice of menu and there were abundance of food and drinks for all coaches, officials and volunteers. Hospitality was one of the best among all the meets I worked.

Meet Director and Personnel All the staff under the leadership of the Meet Director Barbara Aguirre were very professional and helpful. They were very efficient and supportive of our officials. They get the job done well.

Locker Rooms, Athlete areas, Meeting Rooms, Traffic flow on deck I did not go into the locker room, so I do not have the details, but I was told by athletes the locker rooms are clean. The athletes' areas, meeting rooms are very spacious and clean. We were provided printer and copier to use. The traffic flow on deck was well maintained.

Other The air quality for the entire meet was acceptable. The airflow was good.

Officials: Assigned Team – What went well? The TLCJ Mike Trexler, Head starter Rebecca Thomas and Admin ref Oded Ravid all did a fantastic job. They were focused on tasks and adaptable when needed. We have constant flow of Stroke and Turn judges as we did not have many officials committed to the entire meet. Mike and the CJs did a great job in showing coherence of the team despite new people every day. Rebecca did a great job in adjusting the rotation after two deck referees felt sick and left early. Oded was very supportive of his admin team as two of them were being evaluated for N3i and N3f respectively.

What were weaknesses/concerns Nothing of importance

Future recommendations I would recommend Mike Trexler as a TLCJ for a higher-level meet like Futures.

Deck Officials – Standouts (provide names and reason) Nicki Rogers – only signed up for two sessions but ended up working all sessions as we needed help and she enjoyed working with the team. Anne Bennett – Anne is a N2 Deck Ref but our assigned team were set when she signed up. Anne did a great job in working stroke and turn for all sessions with a smile and was very helpful to newer officials.

Timeliness Good
Heat Sheets well prepared ahead of time
Swim Offs Well managed
Disqualifications (not DFSs) Well communicated by CJs and well vetted by DRs and well accurately recorded by Admin. The background noises made communicating over radios difficult at times but the team managed to get the job done effectively.



Meet Referee Report

Competition Session Lengths: right on timeline, less than 4 hours for prelims
Finals: right on timeline
Time Trials: Not Applicable (We did not have time trials at this meet)
Coach concerns/protests: Coaches concerns were first dealt with by Deck referee regarding infractions. Only one call came to me for appeal.
We called a coach meeting to discuss adjustment due to delay of warmup as a result of a short power outage on the last day before finals. Coaches' voices were heard, and we collectively came up with a plan to get back on our timeline. Coaches were happy with the process and outcome.
Announcer: James was excellent. He worked really well with age group swimmers. James was also a DJ and played music to help create a fun environment. I recommend using him again in the future.
Safety issues: There were two reports of incidents of athletes not feeling well after the completion of the final session on Friday. EMT was called and both athletes were discharged by EMT after being attended to. The Meet Director has filed the incident reports. The facility staff and lifeguards were very professional and handled the situation very well. Barbara Aguirre and her staff were very attentive and helpful for the coaches and athletes.

General Comments: The meet was originally scheduled to be hosted in Arlington, TX but needed to be moved due to change of personnel in Arlington ISD. Thanks to Dave Smith who solicited support from Barbara Aguirre of Tupelo, MS. We are very grateful for Barbara's willingness to host with a short notice and did a wonderful job for everyone attended. Mississippi Swimming under the leadership of Wade and City of Tupelo were great hosts.

Meet Preplanning

The leadership team held three zoom calls in preparation of the meet. The meet director Vic Riggs was very accommodating with our requests.

Facility

Air quality was remarkably excellent for a 5-day meet. There was no hint of chloramines and many coaches commented that have never been to a facility with such excellent air quality.

Two large rooms of the deck provided more than adequate space for both officials' meetings and hospitality. Restroom facility were available for officials and coaches off deck, just outside the pool and on the second floor.

Mountaineer Pride was evident throughout the event by the facility staff. Ed Denny Coordinator of Competitive Aquatics was available for all backstroke events to ensure the backstroke ledges were for properly installed before each race. He was also observed cleaning the deck plates for each lane during the meet to ensure positive connections. Deck plates are the in- deck areas where all the touchpads, plungers and lane speakers are connected. Miranda Buiter the Certified Pool Operator went the extra mile to ensure the pool water was perfectly balanced each day. Result was excellent air and water quality throughout the meet

Hospitality was excellent throughout the meet. Club Mountaineer parents provided breakfast and lunch. Dinner was catered nightly from restaurants who were meet sponsors. One night we were provided steak for dinner!

Meet Execution

Prelim sessions were 2.5-3 hours and each final session was completed in about 2-2.5 hours. The awards for the previous day were given out to the Top 3 at 845 AM prior to the start of Prelims. Saturday awards were given after Finals on Saturday and this proved to shorten the daily timeline.

A relay split timing pad fell off during a heat at the turn end. Vic Riggs, Meet Director and Ed Denny quickly resolved the issue with no effect on the swim.

A 100-meter free swim off was conducted for a 200 Free Event. Several coaches were not aware of USA Rule 102.5.2, which allows a dissimilar event or distance for the swim off as long as all parties agree.

Officials

There were 18 officials that worked the meet; however, six sessions were minimally staffed with either the meet referee or evaluator manning the deck. With the five Futures meet scheduled during same week, this impacted our recruiting efforts. Special thanks to all in the Central and Eastern Zones who helped recruit officials. This meet did not have the minimum officials available for each session until the Friday before the meet.

A total of nine N2 evaluations and three N3 evaluations were conducted during the meet. National Evaluator Teri White, SNS conducted a starter clinic on Thursday. Teri also provided a multitude of mentorship opportunities throughout the meet.

The theme for official's education during the meet was "What did I learn this session?" and "Be A Sponge". More than half the officials who signed up were neither N2 officials or had attended a sectional level meet. Marnie Kern, OKS and Co Team Lead Chief Judge jumped into action and provided over 30 hours of education via phone on the protocols and the evaluation process for those individuals. Over the course of the meet, she also conducted a Chief Judge clinic for five individuals covering nine different areas. This clinic was placed into OTS as a learning activity for these individuals. Her efforts sparked excitement and introduced these officials to different techniques in officiating. Her activities took the meet from good to great as far as an officiating perspective.

Administration- by Didi Byerly, Administrative Referee

1. Depending on the location of the meet, consider opening the meet to athletes outside of the Southern Zone in order to make the meet more robust.
2. Bonus Events – Keep an eye on the athlete count. As the deadline nears, consider increasing the number of bonus events/athlete if the meet looks like it will be small with short sessions. A few days before the meet entry deadline, we changed the bonus events to two bonus events per one qualifying event.
3. Entry Limit – Consider increasing the entry limit to 7. It currently is six, for a 5-day meet. This was a common request.
4. Change the positive check in for Tuesday night relays to 4 PM instead of 5 PM. There are many relays on Tuesday evening, and it was labor intensive to get the names of the relay swimmers input into Meet Manager.
5. Positive Check-in for 1500 – Change to 5:30 PM on Friday night, which is the same time as the scratch deadline for the events on Saturday.

6. For the 1500, clarify the meet information that the 1500 free will be contested immediately after that Saturday time trials (after prelims)
7. Relays – For all the relays except the 800 free relay and 200 mixed relays, change the wording on the seeding that the relays will swim fast to slow with the fastest two heats of women going first then the men.
8. For time trials, run the 800 M Fr time trial on Tuesday and the 1500 FR time trial on Saturday. Because of the limited number of time trials in the meet, remove the language of following the national protocol and change to scheduling the time trial events in the most expedient way. We only had a couple of heats of time trials each day.
9. Make sure the records are updated in the Meet Manager file before providing the back-up to Southern Zones.
10. For awards, the coaches decided to do the awards 15 minutes before the morning session on the following day, which kept the finals sessions at a reasonable length. On Saturday evening, the awards for Saturday's events and team awards were presented at the end of the session.
11. Please see revised meet information to see changes made prior to the meet (purple and red) and recommendations (green) made for future meets.

The 2022 Southern Zone Open Water Championships was held May 13-15 on Lake Winona in DeLeon Springs, FL. Thank you to Hydro4 and all of their volunteers for hosting a great event with 263 total athletes. The 11-12 2 K consisted of 56 athletes (30 F / 26 M). The 5 K had 207 athletes and was run as Open with two waves 1 Male consisting of 103 athletes and 1 Female consisting of 104 athletes. The results were split by age group for scoring and the age group breakdown is as follows 13-14 - 73 Athletes (36 F / 37 M), 15 -16 - 72 Athletes (35 F / 37 M), Open - 62 Athletes (33 F / 29 M). The 5 K was run combined to meet USA Swimming Standards to allow qualification for OW Junior Nationals. This was a change from the original format and a concession made to keep qualification possible after USA had originally suspended the path from zones to Juniors a week prior to the meet. There was some discussion that the waves were too big and that the combined format was a detriment to the 13-14 Races. This was also the return of the team pursuit to the event for the first time since 2018. The relays the past few events have been popular but by request of the coaches the team pursuits were returned to the meet format.

Last year we expanded the available roster by 2 in each age group to 48 total. This was great for 13-14 and 15-16 age groups. Numbers are still low in 11-12 and open.

The main struggle with participation for many LSC's since 2019 has been the FINA age up date. 1 LSC did not participate at all because of it. It also makes it very hard to fill the 11-12 age group. We should look at getting rid of the FINA age up date moving forward. If needed for the juniors selection we should use the Open 5 k with FINA age up date like the central zone does.

2022 Disability Swimming Report

Southern Zone

The National Championships for US Paralympic Swimming were held December 17-19, 2021, in Greensboro, North Carolina. This was the last meet held under full covid protocols and the first time it was held in North Carolina. The southern zone was well represented by both athletes and officials participating.

On January 1, 2022, the National Disability Committee and The National Diversity, Equity and Inclusion Committee were reformed as a single committee with disability swimming as a subgroup. This action reduced the size of both committees and resulted in less focus on disability swimming through committees. Prior to this consolidation, the committee submitted R-14 as a clarification to Article 105 of the USA Swimming Rulebook. I strongly recommend this proposal.

An incident with a hearing-impaired swimmer at the TYR Pro meet in San Antonio, Texas the end of March, led to the submission of multiple legislative proposals to the Rules and Regulations Committee for consideration. R-5, R-7 through R-13 all address changes to the starting protocol for hearing impaired swimmers. R-7 and R-9 are being withdrawn and replaced with R-8 and R-10. I recommend R-8, R-10 only. These were discussed extensively at the April meeting and the education, evaluation and professional documents have been updated to better address this issue.

The Southern Zone Age Group Championships were held July 26 – 30, 2022 in Tupelo, Mississippi. 11 athletes with a disability and 1 hearing impaired athlete were entered from 5 of the 14 LSCs who participated. The 4 female and 7 male athletes with a disability earned a total of 128 points and had 125 splashes. 4 of the athletes requested accommodations and an auxiliary strobe light was provided at the block for the hearing-impaired swimmer. It is important to note that the swimmer requested that hand signals NOT be given by the starter when offered.

The Fred Lamback Para Swimming Open will be returning to the southern zone October 14 – 16, 2022. Previously held in Augusta, GA, the meet has been moved to Lawrenceville, GA, a suburb on the east side of Atlanta. This is the only event where classification is offered in the southern zone. Information about the meet can be found on the US Paralympic website under events and competitions or the Georgia LSC website.
