Call to order by Melissa Hellervik-Bing, Zone Director, on Sunday, September 17, 2023, at 5:30 p.m. Eastern Time.

Roll Call - Herb Schwab 14 LSCs in attendance with 96 Participants. WT LSC was absent.

Moment of Silence for all Zone Members who have passed away during this past year.

Agenda distributed and approved

The Agenda, Minutes, and all of the Attachments were posted on the Southern Zone website, and notifications were emailed to all of the LSCs. Each LSC was also asked to forward the electronic files to their

delegates. The agenda was approved.

Approval of 2022 Meeting Minutes Motion was made and seconded to approve the minutes of the 2022

Convention meeting, with the correction of the spelling of Allan Golding's

name. Motion carried.

Melissa Hellervik-Bing, Non-Coach Zone Director Melissa acknowledged and thanked Bruno Darzi, Dave Smith,

Jim Kelly, Herb Schwab, Ruth-Ann Bode, Megan Braman, and Nicole

Caruso for all of their help and assistance this past year.

Melissa reported on the proposed Junior Official position. After

discussion with others, including the Zone Director Council members, the proposed Junior Official position and a new membership category will be

brought to the USA Swimming Board of Directors.

Bruno Darzi, Coach Zone DirectorBruno thanked the members of the Zone for their support in helping him

to acclimate into his new position as the Coach Zone Director. Bruno will be working on developing the Job Descriptions for the Zone Directors, to

be included in the Zone Administrative Policies.

Herb Schwab, Secretary/Treasurer Herb reported that the Zone has a balance of \$26,495.09. No formal

budget was presented for this year. Several plans for financing projects later this year will be discussed later during this meeting. A formal budget

will be presented at the next Annual Meeting.

Jonathan Watson, Zone Age Group Chair Jonathan is ill and unable to attend this meeting. His report will be

submitted, once Jonathan is healthy

Matt Webber, Zone Senior Chair Matt's report is posted on the Southern Zone website. Matt asked for

volunteers to form a working group to discuss making the Zone meets more attractive to host. Matt also reported that discussions will be held

with the LSC Senior Vice-Chairs concerning the Zone Senior Meet and the Sectional meets.

Nick Graves, Zone Open Water Chair

Nick reported on the Open Water Championships held in Seven Hills, North Carolina. The participation level was higher than previous years.

Megan Braman/Nicole Caruso, Athletes

Megan and Nicole will continue their terms for the next year. The Zone Athlete Representatives Committee has voted to stagger the terms for Athlete Representatives. The Southern Zone Athlete Representatives will continue for a one-year until 2024. Thereafter, the term of office will be for two-year terms.

This change in election of the Zone Athlete Representatives will require an amendment to the Zone Administrative Policies. Megan and Nicole will work on the updated wording of this amendment and present it to the Zone for an email vote later this year.

Megan and Nicole are maintaining contact with the LSC Athlete Representatives on a regular basis via social media and virtual meetings.

Terry Jones/Dana Skelton, Zone Advisors

Terry reported on the outstanding performances of the Southern Zone athletes at the recent Junior World Championships. The Southern Zone had 31% of the athletes on the USA Swimming squad.

Terry and Dana offered suggestions on housekeeping changes for the Zone Administrative Policies.

Terry also reported that discussions will be held later this year for realignment of the Sectionals Meets.

Terry has been conducting calls with the LSC Senior Vice-Chairs. Dana has been conducting similar calls with the LSC Age Group Vice-Chairs.

Explanation of Voting Procedures

Nicole and Megan discussed the process that we will be using for voting during this meeting. Google Forms will be used, with Nicole and Megan conducting the voting process.

New Business

2024 Southern Zone Athlete Summit & Olympic Trials Watch Party Melissa described the Athlete Summit and the desires of the Athletes to conduct this Summit. Nicole presented the Mission Statement: To instill qualities of leadership and cooperation as well as cultivate a foundation of knowledge about USA swimming governance, legislation, and operation to bring back to their LSCs.

Two possible sites have been identified for the Summit: Louisville, KY, and Cary, NC.

Ruth-Ann Bode presented information for the Louisville site. This location has been used for previous Regional Camps and Clinics, and has experience in conducting this type of program. The Summit would be held at the University of Louisville.

Amy Faulk presented information for the Cary site. This location would be using either the North Carolina State pool or the Triangle Aquatics Center pool.

A comparison of the costs of each site was presented to the Zone Delegates.

After considerable discussion about the costs, logistics, and content of the Summit, a Motion was made and seconded to approve the Summit with a Zone budget cap of \$12,000. The Motion passed.

A Motion was made and seconded to vote on either Louisville or Cary for the location of the Summit. Louisville was selected as the site of the 2024 Athlete Summit.

Updates to the Southern Zone Administrative Policies

Diversity, Equity, and Inclusion Coordinator Ruth-Ann Bode presented amendments to the Administrative Policies to further define the roles and responsibilities of the Zone DEI Coordinator. A Motion was made and seconded to accept the changes. The Motion passed.

Officials Coordinator

Herb presented amendments to the Administrative Policies for the Zone Officials Coordinator and Zone Assistant Officials Coordinator. The amendments were made to make the selection and appointment of the Officials Coordinator more open and transparent, and to further define the qualifications for the Officials Coordinator. A Motion was made and seconded to accept the changes. The Motion passed.

Elections

Zone Director - Coach: Bruno Darzi (FG)

No other candidates were nominated.

A Motion was made and seconded to elect Bruno Darzi by acclamation. Motion carried.

Zone Senior Chair: Matt Webber (SE)

No other candidates were nominated.

A Motion was made and seconded to elect Matt Webber by acclamation. Motion carried.

Zone Open Water Chair: Nick Graves (GA)

Hector Acevedo (FG)

No other candidates were nominated.

Nick Graves was elected as the Zone Open Water Chair, by secret ballot.

2025 Southern Zone Age Group Championships Dates and Site Nominations/Presentations

The proposed dates for 2025 will be decided after the dates of the 2025 Futures Meets are determined.

Two bids for the 2025 Southern Zone Age Group Championships were received from:

Allan described the process for selecting the Assistant Officials Coordinator, that was just approved with the amendments to the Zone Administrative Policies. Allan is soliciting nominations from the Zone Officials. The nominees must be an N3 Deck Referee, and must have some experience from a previous Zone Championships. Nominations may be submitted to Allan, Melissa, or Bruno.

Comments

We had 30 officials, including Mellissa and myself. Fifteen were from North Carolina (four from Cary), fourteen from other zones, and once from NJ, but I want to claim Jim for North Carolina. We had five evaluations, N3I DR, N2 DR, N3 S/T, N2 CJ, N2 S/T.

The Facility recently installed a new Quantum Swiss Timing and struggled with setup and speaker issues. The result was a few equipment delays and the need to offer re-swims on a couple of heats. Rayleen was invaluable in guiding us in the inclusion of SWAD into finals. A more detailed conversation before the meet regarding the incorporation of SWAD would have been great.

I would recommend that a formal Zoom call with the Facility, assigned team, and relevant members of the SZ committee be included in the pre-meet planning process.

Modifications to the sanction:

On Day One, we add a 30-minute warmup break between the distance events (800 and 1500) and the relays. Most swimmers on the first day were relay only, so we proposed the break to provide access to the pool for swimmers' warmup/relay starts. It might make most sense to break them into two sessions, a Distance and a relay session.

The awards break as planned was not sufficient. If the plan is to award all top eight awards during these breaks, I would recommend the following:

- Relay awards for Days 1, 2, and 3 are awarded before finals the following night. Warmup start times should be adjusted to accommodate these changes. Day 4 relays will be awarded after finals.
- Individual award breaks are added after the change of each stroke. IE for Thursday evening, break after 11/12 and 13/14 Back; 13/14 and 11/12 Freestyle; 13/14 and 11/12 200IM; 13/14 and 11/12 50 Fly; The last break could be longer to allow warmup for relays.

On Day One, we add a 30-minute warmup break between the distance events (800 and 1500) and the relays. Most swimmers on the first day were relay only, so we proposed the break to provide access to the pool for swimmers' warmup/relay starts. It might make the most sense to break them into two separate sessions, Distance and Relays.

Clarification of the allowable entries in the 400 free/IM, specifically if SWAD is included in the 3-athlete limit or over and above the entry limit.

Adjusting entry deadline to be more than 24 hours than the meet start time. Ask for preliminary entries for SWAD before the entry deadline would ensure the Facility can meet all requests.

Comments from James Sheann

Jeffrey, my only thought is to look at the scheduling of the awards as they took a very long time. I can't say whether the individual awards should be top 8 or top 3 as recognizing these athletes is very important, but I suspect the coaches and chaperones would have liked to get the team back to the hotels earlier than they were able. Maybe finals should start earlier.

Rayleen was invaluable working with the swimmers with a disability. Made life much easier for the admins when it came to seeding and any accommodation needed.

Facility: Equipment 8 lanes 50 Meter pool with blocks w/wedges at both ends of the pool. Colorado backstroke wedges. Colorado System 7 Timing System, with a Omega Starter.

Hospitality — Shockwave provide local restaurants and catering were provided with Southern Cuisine, breakfast, lunch and heavy snacks for finals for hospitality.

Meet Director and Personnel Walker Todd, meet director, security and marshals by outside company who had safe sport training and provided their own background checks. The City of Tupelo and Aquatic Center provides timers and personnel to assist meet officials.

Locker Rooms, Athlete areas, Meeting Rooms, Traffic flow on deck. The Aquatic Center Men and women's locker rooms were for 17 and under; Public bathrooms with small changing area in the lobby of the aquatic center for 18 and older. The Aquatic Center has family bathrooms for coaches, officials and Tupelo staff. They had tents with misting units, provided by Tupelo Convention Bureau.

Other The Tupelo Convention Bureau provide the Athletes lunch on the first day and a Coaches Social later in the week. Mississippi Swimming provided a dinner for Assigned Officials, and evaluators.

Officials: Assigned Team – What went well? <u>Because we lost our meet referee late, we were not able to field assigned teams early, except for Starter/Deck Referee</u>

What were weaknesses/concerns – For senior zones, it's having the meet in an LSC that does not have enough Officials. Our biggest weakness is that we have had a Zone/Sectional meet for the last 8 years and we also hold our LSC Championships in the same venue, so officials don't want to come every year._____

Future recommendations

University of Tennessee, Knoxville

Our site may be difficult because we are hosting Olympic Trials for Diving in 2024 and it overlaps with Swimming Trials, so it's likely we will have a lot going on during the time you are looking at. For reference though, we do "in general" (lots of stipulations, ect.) have the ability to put kids up in the dorms over the summer. Cost is usually around or under \$50 per person per room night. They stay in a nice dorm close to the pool and eat in a dining hall next door. Food is typically around \$15 for dinner, \$13 for lunch, and \$12 for breakfast. There would need to be adult chaperones as well. Pool space is somewhat depending on what you're looking at, but if available it would likely cost about \$180 an hour for the 50 M pool.

If the SZ DEI Coordinator is unavailable to perform duties, the SZ Assistant DEI Coordinator will act in their place (coordinating meetings, disseminating information to the National DEI staff and to the LSC DEI Chairs, to the SZ Coach and Non-Coach Directors) until the current SZ DEI Coordinator is able to return to duties, or, until a new Zone DEI Coordinator is appointed by USA Swimming National DEI staff.
- c. Be a currently registered member of USA Swimming in good standing.
- d. Term of service is two years. May serve up to (3) two-year terms of service (not more than six years.
