Progress on Written Consent for June HoD [Aimee O.]:

81% of the written consent forms have been returned. Aimee is testing meeting platforms. The June HoD is scheduled for June 7^{th} at 1PM.

Club Assistance Program Update [Chris]:

Committed \$60,000 to coaches. Provided \$45,000 so far. Committed \$2,000 for innovation. Very well received.

2020 All-State Update [Aimee O.]:

Gifts and plaques sorted and in the process of distributing awards to clubs throughout the state. The web ceremony was well done.

2021 Registration Report [Karen]:

Registration for 2021 opens June 1 for the following membership categories: premium, outreach and flex athletes as well as official, other and coach. September 1 is still the start date for single meet, seasonal, apprentice official and club registration. There is a \$2 fee increase.

2020-2021 Budget Postponement [Vaughan]:

The committee has looked a several revenue scenarios. Until there is more clarity, propose postponing the 2020-2021 until the October HOD. Meet schedules and registration numbers should be available by then. USA swimming is currently routing 3 different budgets due to this uncertainty. Motion to postpone the 2020-2021 budget until the October HOD. Motion Passed

Open Water and Long Course Championship Meets [Roy]:

Motion to cancel Open Water and Long Course Championship Meets. Asked to postpone Open Water until the Fall. Official announcement in for this calendar year. We have direction from USAS for virtual or inter-squad meets.

Technical Planning Legislative Item [Cathey]:

Proposal provided to address time trials, smaller meets, and virtual meets. 21 days to allow processing instead of the normal 60 days. This would be an interim change to the P&P.

Motion to pass proposal with a change in the deadline to 12/31/2020. Motion Passed

Technical Planning Chair Vacancy

Cathey is stepping out of the Technical Planning position effective June 1, 2020. Brian Heaton will step into this position.

Any Legislation for June HoD

Legislation will be considered during the June HoD.
