Approval of Minutes [Aimee Onoszko]:

The 10/4/2020 HOD meeting minutes were approved by acclamation.

<u>Statement of Activity (Balance Sheet YTD) [Joyce Dodd]:</u> – Hardcopies were provided. Revenues were lower than last year as expected due to COVID. Expenditures were much lower than last year. We are \$33k favorable for the first seven months of this year. We expect expenditures to increase as COVID subsides.

<u>Budget Overview 2021-2022 [Jake Ritz]:</u> — Last year we finished in the red by \$17K, but we have assets of \$775K. We are positive \$115K in net revenue year-to-dated, but we expect expenses over the next five months to eat into most of that. We expect to finish \$15K-\$30K in the black this year depending on expenses. The budget for the next fiscal year is negative \$67K. We think this is appropriate because now may be the time to reinvest and grow registration and meet revenue. There is an extra \$25K for Zones in Texas next year, \$20K for professional marketing, \$10K for club development, \$10K for office expense, and \$4K for official's expense. Motion to approve the proposed budget. Motion passes unanimously.



The annual review which is done by the audit firm was also provided. An annual review is required by USAS for LSC's with assets over \$200K. Motion to approve the audit review. Motion passes unanimously.

<u>Elections [Lynn Williams]:</u> — Elections were conducted by the Nominations chair with an announcement of the position, a call for nominations from the floor, candidates brought forth by the nominating committee, an opportunity for candidates to speak, a vote by the HOD by paper ballot, and an announcement of the selected candidates. <u>SC Logo [Aimee Onoszko]:</u> – In the fall USAS contacted the general chairs and offered to have their design team look at our logo, free-of-charge, in an effort to have LSC's be more branded under USAS. USAS has provided an updated logo option. The logo was presented during the meeting. The proposed logo was brought before the HOD for a vote. The design was well received. Motion to accept the new logo design. The new logo design passes.

Reports of Officers:

<u>Eduardo dos Santos</u> – The main focus for the Age Group Committee this summer is the zones. Initial selections have been made. Chris Wolford will be the head coach.

<u>Aimee McMillan</u> – Officials committee spent the first part of the year recruiting new officials (53 new officials). The focus for the second part of the year will be advancing our officials.

<u>Heather Alexander</u> – Thank you the teams for your diligence in completing Athlete Protection. A new travel policy was approved during the Board of Director's meeting. Twelve of the 28 teams have completed the Safe Sport recognitions program. USAS has established a monetary Incentive for LSC's.



Four categories starting with 25% of member clubs. We have met this level, so the LSC will automatically receive \$1500. The next goal is 50% by June 15th. We are 2 clubs shy of this level which would result in an additional \$2K. 75% by July 1 would result in an additional \$2500. 100% by September 1 would result in an additional \$3K. The total possible incentive is \$9K. This money will be spent on the athletes.

<u>Stanley McIntosh</u> – DEI is starting an initiative to have at least one DEI member per team to be part of the DEI Athlete committee to increase communications. They are looking at offering swim lessons to increase diversity and increase team size. They discussed adding more about DEI to the P&P and gathering demographics information during registration. They also discussed the meet fee reimbursement process and talked about having a DEI long course as a fund raiser.

<u>Caroline Parker</u> – In their meeting, the athletes discussed COVID policies. They discussed possible changes to the championship meets. Jill Smiley will be new Junior Representative. Darden Tate and Alex Ritz will be the At-Large Representatives.

<u>Big Show</u> – The Seniors committee has done a lot toward reimbursement of national meets. The select camp process will resume this year. The open water championship will resume 2022. We are looking forward to our first long course championship meet.

<u>Brian Heaton</u> – Technical Planning is continuing to update the COVID policy.

<u>Jay Boudreau</u> – Media request form is available on the website to get information reviewed and out on the LSC's social media platforms.

<u>Karen Alexander</u> – Coaches need to send their completed CPR certificate of completion to Karen. Aimee Onoszko – Thanks to Dan Mascolo for his work on the All-State banquet and weekend.

Sport Development Director Report [Chip Holland]: – 3 things going on right now; 1 is performance based, the other 2 are development based. The Carolina Crown meet has full participation (260 swimmers). South Carolina will have 120 swimmers and 5 coaches. USAS awarded the LSC a \$1200 grant for an Athlete leadership summit. The focus will be LSC Committee leadership Community leadership. USAS is offering a grant for select camps. This series of camps will be geared to mid-level swimmers. Summerville Y is back. There were 15 new short course state records involving 25 athletes.
