Function of committee: The purpose of the South Carolina Swimming Officials Committee is to develop and conduct mentoring programs to recruit, educate, train and certify USA Swimming officials to provide high quality and consistent officiating for our athletes. Our goal is to set standards that will accomplish the following:

- Ensure clear and consistent knowledge of the rules
- Provide sufficient time in training to assure familiarity with all levels of competition
- Ensure professionalism in all aspects of the word "team" both on and off the deck

Summary of Committee Objectives and Action Items:

We have implemented a cleaner, more automated process for tracking apprentice officials as they progress through certification. Once apprentices meet the required criteria, the system now automatically moves them to the list of approved officials. Additionally, a list of current apprentices is now published on the SC Swimming website for easy access by Meet Referees. This list clearly indicates whether each apprentice is deck legal, as well as the position they are apprenticing in. A separate page on the website now displays all certified officials along with their certified positions. These tools are designed to help Meet Referees more easily assign deck roles. An email with links and instructions was sent to all referees to highlight these new resources.

We have continued to refine and improve the certification process for new apprentice officials. A follow-up email template has been created for use after completion of the online certification course, outlining the expectations for on-deck sessions. Officials are reminded that apprentices have 60 days from registration to complete their training unless they have completed all applicable USA Swimming athlete protection requirements. Clear instructions have also been provided to Meet Referees for completing the apprentice evaluation form, with updated examples and guidance on what to look for during the fourth session.

The Officials Committee has also developed updated referee guidance on how to handle situations where a swimmer misses the start of a heat but enters the water late. This includes clarification on the appropriate use of Rule 101.1.5B, how to properly document the disqualification using the updated USA Swimming DQ slip (rev. 1/24), and tips for clear and professional communication with swimmers and coaches. This guidance is being incorporated into referee clinics and distributed as part of a quick-reference resource.

North Carolina Swimming has invited South Carolina officials to attend their Swimposium Officials Training Sessions on April 12th at the MCAC in Charlotte. While this conflicts with our own HOD, BOD, and All-State Banquet taking place the same weekend, the opportunity will still be shared with all SC officials. We hope that some will be able to take advantage of these additional educational offerings, especially those not attending HOD-related events. This type of regional collaboration helps strengthen both LSCs and provides valuable development opportunities for our officials.

We are proposing a terminology correction in the SC LSC Championship Meet entry procedures. The current policy incorrectly uses the term "nonconforming time entries" when referring to entries that cannot be verified. The corrected language should read:

"In all SCLSC Championship Meets, unproven time entries shall be sent to the club by electronic mail (e-mail). The club shall have the opportunity to correct the entry if done so within 24 hours from the email time stamp."

This update brings our language in line with USA Swimming standards and improves clarity in the entry process.

Finally, we will recognize the 2024 SC Swimming Officials of the Year at the All-State Banquet on April 12th in Rock Hill. This recognition highlights the outstanding commitment and contributions of two individuals who have gone above and beyond in their service to our LSC over the past year.
