The meeting was called to order by Aimee Onoszko at 10:02 am and began with the reading of the SCS Vision, Mission, Core Values and Duty to Serve.

**Reading, Correction and Adoption of October HOD minutes** – no corrections – minutes stand as approved

• Financial Committee Chair – Mike O'Shaughnessy – Gave review of the LSC financial position – 2023-2024 Budget will be -\$44,850. Zone meet is in Arlington, TX (LC 2024) – will take on an additional \$24K in expense in the 2023-2024 budget year; the LSC has funded an account to be utilized by the Zones team, and that will bear the burden of some additional expenses. Finance committee will continue to investigate ideas on how to create new revenue streams (utilizing existing resources with the accounts) to fund future needs if operating income is not able to keep up with operating expenses.

<u>Bid Calendar 2023-2024</u> – Meet bid winners – Short Course Palmetto Championships – Coastal Aquatic Club and Upper Palmetto YMCA; Long course 2024 state bid will be sent to the Senior Committee; the bid calendar was approved unanimously (with no meet host for Long Course Senior State) – will be posted on the website tomorrow

<u>Senior Chair</u> – Jon Mengering – Priority one for the committee will be the Palmetto Championship and determining the best direction to take that meet; Chip Holland and Big Show have been working on the zones open water team; invitations will go out to athletes on Monday, April 24<sup>th</sup>; Time standards have been evaluated and some changes will be made to short course; long course standards will be evaluated at the end of long course season; reminder to all there is a 60 day window to get reimbursements turned in, want to get checks to families as quickly as possible

<u>Finance Committee</u> – Joyce Dodd - the LSC has a review every 3 years and an audit on the 4<sup>th</sup> year; this was a review year and South Carolina Swimming got a clean review

<u>Executive Committee</u> - Aimee Onoszko - Member survey will go out later this month to get feedback on short course, long course, All State, etc.

**Sports Development Director Report** - Chip Holland – Total athletes are at 3700 (compared to 3390 at the end of 2022); 18 new short course LSC records; 20 new long course LSC records; 96 new first time senior sectional qualifiers; 35 futures qualifiers; 29 juniors national qualifiers; 11 athletes attended national meets – 2 champions (Lila Bognar, Maria Francescotti); 2 new national team members – Lila – Junior National Team member; Maria Francescotti – world class 12<sup>th</sup> ranking for para athletes; 20 scholastic all Americans; 43 new college commitments this year

<u>Social Media</u> – Instagram up 8.2% in followers; reached over 12,000 individual accounts; Facebook reaching over 1800 people (parents, coaches, etc.); up 20% in messages being opened (constant contact);

<u>Carolina Crown</u> – partnered with DEI clinic and Swimposium; Todd DeSorbo was a guest speaker; had a full house of coaches and athletes; Team Black Diamond won the crown; very successful weekend; South Carolina will host next year at the end of April— will also include a DEI camp (may be a separate location from the meet, but same general area); more details to follow

<u>Zones Team</u> – 11-12, 13-14 only meet this year; (Para swimmers can attend, ages 11-18) new selection process for team this year; details and applications are available on the LSC website; meet will take place at the end of July in North Carolina

DEI Swim clinic in June- will be held in Columbia, SC – more details to follow

**Purpose of proposal**: Update registration deadline parameters with SWIMS 3.0

#### Proposed new language: B. Registration Deadline

The LSC Office shall receive all materials, including payment, required to obtain and/or maintain current memberships for any club, athlete, or non-athlete wishing to participate in a meet, by 5 p.m. Thursday, or 5 p.m. the day before the start of the meet, whichever is earlier.

- 1. USA Swimming memberships obtained after the deadline must show proof of membership "in good standing" to the Meet Director or Meet Referee (or their designee) to participate in a meet providing that all other parameters in the meet announcement have been followed.
- 2. Members not in good standing that have been flagged through the pre-meet status report and wish to participate in the meet shall show a USA Swimming membership card "in good standing" or verification from the LSC Registrar to the Meet Director or Meet Referee (or their designee).
- 3. No paper certifications or pictures of certifications and/or membership will be accepted on deck.
