-Dave Horton suggested that SCSC will be bidding on hosting Senior Sectionals in March, 2022.

-Order of Events

- Switch 200 I.M. & 200 Back on Day 4.
- The Board of Directors would like for the Senior Committee to revisit the event order every year or two years.

-Open Water

- Feedback was positive for the Death Valley Open Water Swim.
- Feedback from the city and Pickens County was positive for future involvement.
- If attendance exceeds 500-600, CAT will look at hosting zone/sectional/USA Swimming competitions.
- -Open Water Select Camps
 - Fast approaching deadline of July 1st.
 - Camp will be September 10-12 at Lake Echo in Pinehurst, NC with North Carolina Swimming.
 - Invites have gone out. Coaches have been notified to encourage participation.
- -Open Water Zones/Nationals
 - Can we look at having a staff & designate money for coaches?

-Reimbursement

- National meets will be announced at USAS Convention in September.
- Issue was tabled until a later date after USAS Convention. Committee will reconvene to get information on the docket for H.O.D. in October.
- We have substantial income left after Olympic Trials.
- Costs were north of \$3000 for Annika in Omaha.
- Requests of \$2500 were approved for Annika, Parker & Erek at last meeting.
- Committee will request an increase in the budget for reimbursement every four years to account for Olympic Trials costs.
- Is \$2500 enough for these athletes? Can we re-initiate the process to increase the amount available for athletes?
- Futures will be added to the list of competitions eligible for reimbursement.

-Senior Select Camp

- It's planned every two years to go to Colorado Springs
- Mike & Chip will request for training to the aquatics director.
- The goal is to bring in to Colorado a coach from outside for instruction.
- Mike suggested Mike Parratto. Dan mentioned Alexis Keto. Chip recommended Chris Webb.
