**Summary of Committee Objectives and Action Items**: Discussion of the Summer State LC Championships

**Unfinished business**: Vacancies remain on the committee because of departures of coaches. Emails have been sent for invites to fill these.

**Motions**: Because of the facility, having blocks at only one end. It was recommended to remove the 200 relays from the meet. 800 Free Relay on Thursday BEFORE distance events. The Distance events on Sunday of the meet, all move to the morning (after other prelim events finish). Move the 50 free to Saturday; 100 back moves to Friday. Create a more balanced and fluid event order. OOE for Friday is 200 Free/100 Breast/200 Fly/100 Back/400 IM. OOE for Saturday is 100 Fly/200 Breast/50 Free/400 Free.

**New Business**: Evaluating the 25 meet (spring) to move to align with President's Day holiday. Though not all the state has that as a holiday. Majority opinion was to keep on Thurs-Sun and not shift to a Monday finish.
